1.1 IMPORTANT DAYS

Date	Day	Theme / Remark
November 19	World Toilet Day	 World Toilet Day is celebrated on November 19 every year to raise awareness about people living without access to safely managed sanitation and initiate action to tackle the global sanitation crisis. The United Nations aims to explore how poor sanitation systems spread human waste into rivers, lakes and soil, polluting underground water resources. The UN General Assembly declared World Toilet Day an official UN day in 2013 after Singapore had tabled the resolution. It is the same day the World Toilet Organization came into existence in 2001. Under PM Modi's flagship program "Swachh Bharat Mission" the nation saw an acceleration in the efforts to achieve universal sanitation coverage and to put the focus on sanitation.
November 14-20	Child Safety Week 2022	 The Child Safety Week is organised by an NGO Arpan since 2019, Child Safety Week is a collaborative movement to encourage collective action towards addressing the issue of Child Sexual Abuse. Important dates in the Child Safety Week 14th November: Children's Day, India 18th November: World Day for Prevention, Healing and Justice to End Childhood Sexual Violence 19th November: World Day for the Prevention of Child Abuse 20th November: World Children's Day

On 26th November 1949, the Constituent Assembly of India adopted the Constitution of India, which came into effect from 26th January 1950.
November 25	International Day for the Elimination of Violence against Women	 The International Day for the Elimination of Violence against Women is observed on November 25, every year to pay tribute to the Mirabal sisters, the Dominican Republic activists who were murdered at the order of Rafael Trujilllo in 1960. In 1993, the United Nations General Assembly adopted Resolution for the Elimination of Violence Against Women to raise awareness about gender-based violence against women. In 1999 the General Assembly proclaimed 25 November as the International Day for the Elimination of Violence Against Women. Theme 2022 - 'UNITE! Activism to End Violence against Women and Girls.'
November 26	National Milk Day 2022	 National Milk Day is observed on November 26 to commemorate the birth anniversary of the "Father of the White Revolution in India", Dr Verghese Kurien, who was fondly known as the 'Milkman of India'. National Milk Day is annually organised by the Department of Animal Husbandry & Dairying, under the Ministry of Fisheries, Animal Husbandry & Dairying. Theme 2022: 'Dairy Net Zero'

1.2 DEFENCE, NATIONAL SECURITY AND TERRORISM

Sea Vigil - 22' drill tests security forces' preparedness in TN

- The exercise is being held from November 15 to November 18 in Chennai to check the preparedness of security forces and intelligence agencies against possible terrorist attacks along the entire coast of India.
- About **1,000 personnel** were drafted for the exercise from the Navy, the Coast Guard, the Central Industrial Security Force, the National Security Guard (NSG), the Fisheries Department, the Directorate ¬General of Lighthouses and Lightships, intelligence agencies, the Mercantile Marine Department, Immigration, Customs, the Coastal Security Group and the police.

Operation – Sea Sword 2

- INS Trikand participated in the 'Sea Sword 2', which is a Combined Maritime Forces (CMF) led Focused Operation held in the Northwest Arabian Sea to counter terrorism, prevent narcotics trade and stop smuggling entities from using the seas.
- The Indian Navy's long range maritime patrol aircraft also participated in the operation and provided air support.
- This effort is a part of the Indian Navy's commitment towards ensuring safety of the seas and collective security in the region, supported by Prime Minister's SAGAR vision.

About INS Trikand:

- INS Trikand (F51) is the third and the final ship of the 2nd batch of Talwar-class frigates of the Indian Navy.
- INS Trikand was built by the Yantar shipyard in Kaliningrad, Russia.
- The other two Talwar-class frigates, INS Teg and INS Tarkash were commissioned in 2021 at the Western Fleet.

Exercise Garuda Shakti (8th Edition) 2022

- The 8th edition of the India-Indonesia bilateral joint training exercise "Garuda Shakti" began at the Sangga Buana training centre in Karawang, West Java, Indonesia.
- Garuda Shakti 2022 is a part of military-tomilitary exchange programs.

Note

 The first edition of Exercise Garuda Shakti was conducted in 2012 in India.

Harimau Shakti-2022

- The India-Malaysia joint military exercise, 'Harimau Shakti-2022', commenced at Pulai, Kluang, Malaysia.
- The exercise is an annual training event between the Indian Army and the Malaysian Army that has been held since 2012.

 The joint military exercise involving troops of India and Malaysia aims to enhance inter
 operability in the planning and execution of various operations in the jungle terrain.

Samanvay 2022

- The Annual Joint Humanitarian Assistance and Disaster Relief (HADR) Exercise "Samanvay 2022" from 28th to 30th November 2022 at Air Force Station in Agra is being conducted by the Indian Air Force.
- The exercise aims to provide a unique platform for the exchange of domain knowledge, experience and best practices with the participating Association of Southeast Asian Nations (ASEAN) member countries.
- In India various national and regional stakeholders are involved in Disaster Management.
- The exercise will promote a synergistic approach by involving various institutions like the Armed Forces, National Disaster Management Authority (NDMA), National Disaster Response Force (NDRF), Defence Research and Development Organisation (DRDO), Border Roads Organisation (BRO), India Meteorological Department (IMD) and the Civil Administration.

About NDMA

- NDMA is the apex statutory body for disaster management.
- It was formally constituted on 27th September 2006, in accordance with the Disaster Management Act, 2005.
- Chairperson Prime Minister.

Ikshak launched at Chennai

- Indian Navy's third Survey Vehicle 'Ikshak' has been launched in Chennai at Larsen and Toubro (L&T)'s Kattupalli facility.
- Ikshak is the third of the four Survey Vessels (Large) (SVL) Project which was built by

Garden Reach Shipbuilders & Engineers Ltd (GRSE) and Larsen and Toubro (L&T) for the Indian Navv.

Note

 Contract for building four SVL ships was signed between the Ministry of Defence and Garden Reach Shipbuilders & Engineers (GRSE), Kolkata in October 2018 for a total cost of Rs 2435 Crores.

- The first ship 'Sandhayak' was launched on Dec 5, 2021 at GRSE, Kolkata.
- The second ship, 'Nirdeshak' was launched on 26 May 22 at Kattupalli, Chennai.
- The fourth vessel is under construction.

1.3 WORLD ORGANISATIONS – PACTS AND SUMMITS

COP- 27 at Sharm El Sheikh, Egypt

- The 27th United Nations Climate Change conference is being held from 6 November until 18 November 2022 in Sharm El Sheikh, Egypt.
- At COP 27 India along with some countries stated that Carbon border taxes, which could result in market distortion and aggravate the trust deficit among parties, must be avoided.
- European Union has proposed a policy called the Carbon Border Adjustment Mechanism to tax products such as cement and steel, which are extremely carbon intensive, with effect from 2026
- BASIC, a group comprising Brazil, India, South Africa and China, large economies that are significantly dependent on coal has for several years voiced common concerns and reiterated their right to use fossil fuels during 2 their transition to clean energy.
- BASIC countries call for a united solidarity response by developing countries to any unfair \(\pi\) shifting of responsibilities from developed to developing countries.

About Conference of the Parties (COP)

- The COP is the supreme decision-making body of the United Nations Framework Convention on Climate Change (UNFCCC)
- All States that are Parties to UNFCCC are represented at the COP.
- The first COP meeting was held in Berlin, Germany in March, 1995.

COP-27 sets up loss and damage fund

 The 27th United Nations Climate Change conference is held from in Sharm El Sheikh, Egypt.

- The COP27 made history by establishing a fund for losses and damages arising from climate change - a demand developing countries facing the devastating impacts of global warming have made for decades, and that has been consistently blocked by rich countries until now.
- COP27 President Sameh Shoukry announced that the loss and damage fund would serve the United Nations Framework Convention on Climate Change.

G20 Summit at Bali, Indonesia

- The 17th G20 Heads of State and Government Summit took place in Bali from 15-16 November 2022
- The Summit was the pinnacle of the G20 ARAprocess and intense work carried out within the Ministerial Meetings, Working Groups, and Engagement Groups throughout the year.
- Leaders of the G20 grouping in a joint declaration at the end of the G-20 summit in Bali said that the Ukraine war was causing economic difficulties and insecurity worldwide, and the threat of using nuclear weapons was "inadmissible".
- In the event, Indian PM Modi held meetings separately with the leaders of Australia, France, Germany, Italy, Singapore and the U.K.

India's Presidency of G 20 in 2023.

- India's G20 presiden cy will be "inclusive, ambitious, decisive, and action oriented.
- India stated that it would give priority to "women led development" on its G20 agenda, which would be driven by the theme of "One Earth, One Family, One Future" which was unveiled recently.

 India is expected to showcase its geographical and cultural diversity during the year, and will hold approximately 200 G20 meetings at different locations across the country.

About G20

- The G20 or Group of Twenty is an intergovernmental forum of major developed and developing economies comprising 19 countries and the European Union (EU).
- Formation 26 September 1999
- Chairman Joko Widodo, President of Indonesia
- First Meeting in Cologne, Germany
- G20 Countries Argentina, Australia, Brazil, Canada, China, France, Germany, Japan, India, Indonesia, Italy, Mexico, Russia, South Africa, Saudi Arabia, South Korea, Turkey, the United Kingdom, the United States, and the European Union.

India to hold 'offsite' on Andaman as it prepares for G20 presidency

- As India is about to take over the G20 presidency formally, the Union government plans to fly diplomats from all missions of G20 countries, invitees and United Nations agencies to a resort on the Andaman Island for a special briefing by the Ministry of External Affairs (MEA) and the G20 Secretariat.
- The "offsite" for 30 to 40 diplomats will take place at Taj Exotica hotel on Havelock Island from November 25 to 27.
- At the event the G20 'Sherpa' Amitabh Kant, 'Sous Sherpa' Abhay Thakur, and G20 National Coordinator and former Foreign Secretary Harsh Shringla will give the diplomats a preview of India's plans for the next year of its presidency.
- India has already announced that in a departure from the previous G20s, which stick to a single venue for most events, it hopes to hold the 200 or so G20 official meetings in about 50 locations, including all the States and Union Territories across India.
- Another key decision was to hold the G20 summit in September, rather than November, given the levels of pollution in Delhi due to crop burning at the later time.

19th Meeting of the CITES

- The 19th meeting of the Conference of the Parties (CoP19) to CITES (the Convention on International Trade in Endangered Species of Wild Fauna and Flora), also known as the 19th World Wildlife Conference took place from 14 to 25 November 2022 in Panama Convention Center, Panama City, Panama.
- Two Indian turtle species the red-crowned roofed turtles (Batagur kachuga) and Leith's soft-shell turtle (Nilssonia leithii) have been added to the Appendix I of the Convention on International Trade in Endangered Species (CITES).

Red-crowned roofed turtle:

- It is native to India, Nepal and Bangladesh and known to be widely found in the Ganga and Brahmaputra River basins, according to the Wildlife Institute of India (WII).
- At present in India, the National Chambal River Gharial Sanctuary is the only geographic area where the species is found in substantial numbers.

Leith's soft-shell turtle:

- The species inhabits rivers and reservoirs mainly in southern peninsular India, in states like Odisha, Madhya Pradesh, Karnataka, Andhra Pradesh, Kerala, Maharashtra and Tamil Nadu.
- 2. Its presence is substantial in the Cauvery, Tungabhadra, Ghataprabha, Bhavani. Godavari and Moyar drainages.

About CITES

- CITES, also known as Washington Convention, is a multilateral treaty to protect endangered plants and animals from the threats of international trade.
- India is a member country.
- Signed on 3 March 1973.
- Location Geneva, Switzerland.

22nd Edition IORA

- India participated in the 22nd Council of Ministers meeting of the Indian Ocean Rim Association (IORA-COM), which was held at Dhaka in Bangladesh.
- Bangladesh is the current IORA Chair.

- The Indian delegation was led by the Minister of State (MoS) for External Affairs Dr. Rajkumar Ranjan Singh.
- The meeting adopted the 'IORA's Outlook on the Indo-Pacific' (IOIP) which would guide enhancement of IORA's engagement in the Indo-Pacific region.
- The 22nd COM Meeting also adopted Dhaka Communique, as the outcome document and the COM also endorsed India's candidature for IORA Vice-Chair for the period 2023-25 by consensus.
- India will set up an e-Office at the IORA Secretariat and also announced provision of e-subscription by India to Mahatma Gandhi Library at IORA Secretariat.

About IORA

- IORA is an intergovernmental organization dedicated to fostering regional cooperation and sustainable development in the Indian Ocean region.
- Formation 1997
- Secretary General H.E. Salman Al Farisi
- Headquarters Ebene, Mauritius
- Members 23 Members and 10 Dialogue **Partners**

1.4 EMINENT PERSONS

Birsa Munda Birth Annivesary (Janjatiya Gaurav Divas)

 President Droupadi Murmu, appointed India's first tribal woman president, visited Ulihatu village in the Khunti district of Jharkhand - the birthplace of 'Bhagwan' Birsa Munda - and paid floral tributes.

Note

- The Munda tribe inhabits the Chota Nagpur **region** of the present-day Jharkhand.
- Birsa Munda was born in 1875, during the time when the British were attempting to establish control over and exploit forest lands, disrupting the tribal way of life.
- A feudal zamindari system was introduced, destroying the tribal "Khuntkatti" agrarian and land ownership system that was more community-based.
- The Raj brought in outsiders moneylenders and contractors, as well as feudal landlords to aid them.
- Munda received his early education under the guidance of his teacher Jaipal Nag. Influenced by him, Birsa converted to Christianity in order to join the German Mission school but discontinued later.

- The Sardar Agitation (1886-1890) had a strong impact on him and he became a part of the antimissionary and anti-government programmes.
- The Ulgulan movement of 1899 involved the use of weapons and guerrilla warfare to drive out foreigners.
- Munda encouraged the tribals to refuse following colonial laws and paying rent.
- He encouraged changes in the social sphere too, challenging religious practices to fight against superstition, and became known as 'Bhagwan' (God) and 'Dharati Aba' (Father of the earth) by his followers.

Rani Lakshmibai (November 1835 – June 1858)

- Maharani Laxmibai is regarded as one of the leading figures of India's rebellion in 1857 against the British, which is also referred to as the first war of independence.
- She was also known to have fiercely guarded Jhansi against the British till her death in 1858.

About her life

- She was born in 1835 in Varanasi. She was initially named Manikarnika Tambe.
- She was married to Gangadhar Rao Newalkar, the Maharaja of Jhansi, in 1842.

- The East India Company took advantage of the Maharaja's death and applied the Doctrine of Lapse.
- As per Doctrine of Lapse, any princely state under the direct or indirect control of the East India Company where the ruler did not have a legal male heir would be annexed by the company.
- She was determined to not give up on the Dominion of Jhansi and started assembling an army of rebellions, including women.
- She was supported by Tantia Tope and Nana Sahib.
- After a fierce war, when the British army entered Jhansi, Rani Lakshmibai tied her son Damodar Rao to her back and fought bravely using two swords in both her hands.
- She died on June 17, 1958, martyring her life for India's freedom.
- Rani Lakshmibai's tomb is situated in the Phool Bagh area of Gwalior.

Tamil scholar Avvai Natarajan dies at 86

- Tamil scholar Avvai Natarajan, who served as the Vice-Chancellor of Tamil University in Thanjavur and known for his exceptional oratorical skills, died in Chennai
- He taught Tamil in Raja Serfoji Government College in Thanjavur and Thiagarajar College in Madurai for a few years in the late 1950s and 1960s. He worked as news reader in All India Radio.
- He was brought to the Department of Information and Public Relations of Tamil Nadu government when M. Karunanidhi was the Chief Minister in 1974.
- He served as the Secretary of the Department of Tamil Development and Culture.
- He was the Vice-Chancellor of the Tamil University from 1992 to 1995.
- Later, he served as the Vice Chairperson in the Governing Board of Central Institute of Classical Tamil.
- He was the General Secretary of the 5th World Tamil Conference (WTC) held in Madurai.
- He was the member of the committee for the 7th World Tamil Conference (WTC) which was held in Mauritius.

- He was the Founder and Chairman of the National Dairy Development Board (NDDB) from 1965 to 1998.

1.6 BOOKS & AUTHORS

New Books on Siddha Medicine launched

- The book release ceremony of 'Sugam Tarum' Siddha Maruthuvam' (சுகம் கரும் மருத்துவம்), a collection of Siddha Medicine articles published in Dinamani by Government Siddha Doctor Cho. Thillaivanan, 'Noi Nadi Siddha Maruthuvam Nadi' (நோய் நாடி சித்த மருத்துவம் நாடி) and 'Ver Paru Thazhai Paru' (வேர் பாரு தழை பாரு) was held at Devaneya Pavanar District Library Hall in Anna Salai in Chennai.
- The English translation of the book 'Odalam Vanga', written by Minister M.Subramanian called "Come Let's Run" which is about the 125 marathons he ran will also be released.
- For the first time in Tamil Nadu, the government is cultivating 200 acres of herbal plants in Dindigul. The farmers of these areas have been trained on the method of cultivation.
- An office has been built for Siddha Medical University at a cost of Rs.2 crore.

- The university will be set up on 25 acres at Madhavaram Dairy in Chennai.
- Union AYUSH Minister Sarbananda Sonowal has approved the establishment of Siddha Hospitals at 100 places in Tamil Nadu and on these lines Siddha Medical College and Siddha Hospital with 50 beds each will be established at Namakkal and Palani.

Note

Siddhargal" or Siddhars were the premier scholars of this system in ancient times. Siddhars, mainly hailing from Tamil Nadu laid the foundation for Siddha system of medicine. Hence, it is called Siddha medicine.

- The award was received at the International Conference on Family Planning held in Pattaya, Thailand.
- India came out as the only country which bagged this award in the 'country category' at the conference.

 The International Conference of Family Planning focuses on universal access to family planning. It provides a platform to discuss various issues pertaining to family planning and awareness about the same.

National Family Health Survey (NFHS)

- First conducted in 1992-93 and the latest one in 2019-21 - NFHS 5 is a survey that is conducted nationwide in a representative sample of households.
- The survey is being conducted with an aim to provide high-quality data on the health and family welfare situation of the country and simultaneously highlight the main issues pertaining to the areas.

Mission Parivar Vikas

- The mission is one of the flagship schemes of the Government.

Tamil estampages to be moved from Mysuru to Chennai

- The Archaeological Survey of India (ASI) on January 6, 2022 directed the Director (Epigraphy), ASI, in Mysuru, to transfer the estampages and other connected Tamil documents and inscriptions to the Office of the Deputy Superintending Epigraphist, South Zone, ASI, in Chennai.
- These unpublished estampages will help unearth more information about Tamil Nadu's history and culture. Estampages are exact replicas of inscriptions copied from stone or copper plates to paper using specialised ink.

- These are made by pressing wet paper on to the rock or metal face, and wiping a specialised ink on it.
- The ASI move follows an order of the Madras High Court order dated August 19, 2021.
- The court also directed the ASI to name the Chennai branch as 'Epigraphy Branch-Tamil'. It also asked the Tamil Nadu government to provide assistance to the ASI to set up the branch.

- According to the UK Home Office data, around 118,000 Indian students received a UK student visa in the year ending June 2022, an 89 per cent rise from the previous year, Besides this, the British government said it is also strengthening the ability to remove immigration offenders.

2.2 PUBLIC AWARENESS & GENERAL ADMINISTRATION

Transfer of seven High Court judges

 The Supreme Court Collegium led by Chief Justice of India D.Y. Chandrachud published its resolution recommending the transfer of seven High Court judges.

Procedure of transfer of HC judge:

- Article 222 of the Constitution makes provision for the transfer of a Judge (including Chief Justice) from one High Court to any other **High Court.**
- The initiation of the proposal for the transfer of a Judge should be made by the Collegium consisting of Chief Justice of India (CJI) and the four seniors most Judges of the Supreme Court.
- The proposal once referred to the Government, the Union Minister of Law and Justice would submit a recommendation to the Prime Minister who will then advise the President as to the transfer of the Judge concerned.
- After the President approves the transfer, the notification will be gazetted and the judge remains transferred.

RTI portal of Supreme Court launched

- The Supreme Court launched its Right to **Information (RTI) portal** to help people access information about the Supreme Court.
- The RTI portal would help the people to file RTI applications online.

About RTI Act, 2005

- The RTI Act, 2005 sets out the rules and procedures regarding citizens' right to information. This act was enacted in order to consolidate the fundamental right in the Indian constitution 'freedom of speech'.
- It replaced the former Freedom of Information Act, 2002.

Consultation meeting for the Union Budget of 2023 7 - 24

- The States urged the Centre to rein in its reliance on raising revenues through cesses and surcharges which reduce the State's share in the divisible pool of taxes.
- The proposition was made by the states at a consultation meeting for the Union Budget

- of 2023¬-24, steered by Finance Minister Nirmala Sitharaman and attended by Chief Ministers, Deputy CMs as well as Finance Ministers of States.
- Tamil Nadu Finance Minister Palanivel Thiagarajan noted that the share of cesses and surcharges had grown from 10.4% of gross tax revenue in 2011-12 to 26.7% in 2021-22 which has deprived the States of their legitimate share of revenue collected by the Union Government.
- Some states raised concern about the pending dues from the five year GST compensation window for States that expired on June 30, 2022.

Note

 The Compensation Cess is a Cess that will be collected on the supply of select goods and or services or both till 1st July 2022. The Cess will compensate the states for any revenue loss on account of implementation of GST.

2.3 GOVT - WELFARE ORIENTED GOVT SCHEMES, THEIR UTILITY

Over 12.5 lakh to be enrolled in Naan Mudhalvan portal

• The Tamil Nadu Skill Development Corporation Managing Director, J. Innocent Divya, called on the corporates to partner with the Naan Mudhalvan project to help students passing out of various institutions to acquire new skills and find jobs.

About Naan Mudhalvan Scheme

- Launched on March 1, 2022.
- The scheme was launched as a skill development program for the students of Government Schools and Colleges.
- TN Government also launched the 'Kalloori Kanavu' programme under the 'Naan Mudhalvan' initiative which aims to guide and counsel students who have completed Class XII.
- Naan Mudhalvan portal was launched by Chief Minister M.K. Stalin on August 29, 2022 which is aimed to get over 12.5 lakh students registered on the portal by the end of the year.

Women save money due to free bus travel, finds T.N. Planning Commission study

 The study, 'A Report on the Zero Ticket Bus Travel Scheme for Women in State Owned Bus Transport Corporations,' was conducted by the State Planning Commission.

- The study was conducted among the women passengers in the three districts of Nagapattinam, Tiruppur and Madurai.
- Nagapattinam was chosen to see how women in the agriculture belt commute.
- Tiruppur was taken to see how women in industrial belts commute.
- Madurai was chosen for being a major trading centre as well as a tourist destination.

Key Highlights of the Study

- Women passengers in Nagapattinam, Madurai and Tiruppur, who avail themselves of the zero ticket bus travel scheme, save on an average ₹888 every month.
- Savings across different occupational categories of women passengers range from ₹756 to ₹1,012 a month.
- Though the scheme is operational in buses originating from urban centres, women from rural households benefit more than urban users.

2.4 COMMITTEE AND COMMISSIONS

Sinha Committee to look into MGNREGA's efficacy

- The Government has constituted a committee under the leadership of former Rural Development secretary Amarjeet Sinha to review the implementation of the Mahatma Gandhi **National Employment** Rural Guarantee Act (MGNREGA) scheme to assess the programme's efficacy as a poverty alleviation tool.
- The Committee has been given three months to submit its suggestions.
- The Committee will study the various factors behind demand for MGNREGA expenditure trends and inter-state variations, and the composition of work.

 The scheme will suggest the required changes in focus and governance structures to make MGNREGA more effective

About MGNREGA

- The scheme was launched in 2005.
- The scheme guarantees 100 days of unskilled work per year for every rural household that volunteers.
- The scheme was launched as a poverty alleviation instrument for the rural region providing them with a safety net in the form of guaranteed work and wages.
- It is implemented by the Ministry of Rural Development (MRD).

3.1 POLICY ON ENVIRONMENT AND ECOLOGY

Siberian rubythroat recorded in the Nilgiris

- A rare winter migrant, Siberian rubythroat (Calliope calliope), has been recorded in the Nilgiris recently
- The bird breeds in the coniferous forests of Siberia and is known to winter in Thailand, India, Indonesia and Bangladesh.
- The Siberian rubythroat is a ground loving song bird. The male has a red throat edged with a narrow black border and a broad white border. Females lack brightly coloured throat and borders.

Note

 According to the data posted on the eBird website, the bird had been seen only once in Tamil Nadu, in Chennai.

World's largest active volcano in Hawaii erupts

- Mauna Loa, the world's largest active volcano, has erupted for the first time in nearly four decades.
- It is the volcano's first eruption since 1984.

Note

 The active volcano in India is Barren Island and is uninhabited, located about 140 km from Port Blair.

NITI Aayog proposes decarbonising of industrial emissions

- NITI Aayog and MN Dastur & Company jointly prepared a report on the policy framework of the CCUS.
- Carbon Capture Utilisation and Storage (CCUS) is the technology which can be used for decarbonising carbon dioxide (CO2) from high polluting sectors such as steel, cement, oil, gas, petrochemicals, chemicals and fertilisers.
- It has a critical role to play for the country to halve CO2 emissions by 2050, CCUS technology would help in promoting the low carbon-hydrogen economy and in removal of the CO2 stock from the atmosphere.
- India needs a sustainable solution for the decarbonisation of sectors that contribute to 70% of emission.
- CCUS has an important and critical role to play for India to accomplish net-zero by 2070.

4. ECONOMICS

4.1 CURRENT SOCIO-ECONOMIC PROBLEMS

Over 10% increase in area under wheat and oilseeds cultivation

- Cultivation of wheat, the main rabi crop, begins in October every year. The harvesting takes place in March-April.
- Apart from wheat, other important crops like pulses and mustard are cultivated during Rabi season of 2022-23 crop year (July to June).
- It has been reported that wheat cultivation area has increased by 10.5 percent and oilseeds cultivation area by 13.58 percent during Rabi season.

4.2 NEW ECONOMIC POLICY AND GOVERNMENT SECTOR

Das to meet CEOs of banks to discuss slow deposit growth

- Reserve Bank Governor Shaktikanta Das will hold a meeting with CEOs of public sector banks on Wednesday to discuss issues concerning slow deposit growth and the sustainability of high credit demand.
- According to Reserve Bank of India (RBI) data,
 deposits rose by 9.6% compared with 10.2%
 on a year-on-year basis, while credit offtake witnessed a jump of 17.9% as against 6.5% a year earlier.
- The meeting would also review the functioning of **Digital Banking Units** unveiled by Prime Minister Narendra Modi recently.

About Digital Banking Units

 It is a specialised fixed point business unit or hub, set up by scheduled commercial banks, housing certain minimum digital infrastructure for delivering digital banking products and services as well as servicing existing financial products and services digitally in self-service mode at any time. The DBUs are being set up to ensure the benefits of digital banking reach across the country.

CCI to take up anti¬profiteering matters

- The government notified changes to empower the Competition Commission of India to take charge of matters relating to the anti profiteering provisions of the Central Goods and Services Tax Act, starting December 1.
- The CCI will now be entrusted with assessing whether firms have passed on benefits of GST rate reductions or input tax credits through commensurate price reductions for consumers.

Note

 So far, National Anti-profiteering Authority(NAA) is the anti-profiteering watchdog of GST and it is all set to be subsumed into the Competition Commission of India (CCI).

Centre sets standard for e-commerce reviews

- The Centre is planning to bring out a standard for publishing product reviews on e-commerce platforms titled "Indian Standard (IS) 19000:2022 Online Consumer Reviews - Principles and Requirements for their Collection, Moderation and Publication"
- The standard will initially be voluntary for compliance by all e-commerce platforms. BIS will also develop a Conformity Assessment Scheme for the standard to assess compliance.
- The framework for the standard was prepared by the Bureau of Indian Standards (BIS).
- The framework was meant to safeguard and protect consumer interest from fake and deceptive reviews on e-commerce platforms.
- Once made mandatory, if required, the violation of the standards by any entity may be considered as an unfair trade practice or violation of consumer rights and a consumer may submit such grievances to the National Consumer Helpline, Consumer Commissions or the CCPA.
- Taking cognizance of the impact of fake and deceptive reviews and protection of consumer interest in e-commerce, the Department of Consumer Affairs constituted a committee to develop a framework on checking fake and deceptive reviews in e-commerce on 10th June, 2022.

 The committee included various stakeholders including e-commerce companies, industry associations, consumer organizations and law chairs

Meesho included on the government's 'ONDC' site

- All e-commerce companies have joined the 'Open Network for Digital Commerce' (ONDC) platform created by the Central Government to facilitate the sale of goods at competitive prices.
- Customers who become members of ONDC can compare and buy products marketed by all e-commerce companies on the platform.
- 'ONDC has joined the central government's platform to provide more opportunities for the products of small traders and to make online trading a public welfare activity.

Note

 Open Network for Digital Commerce, (ONDC), is a private non-profit company established by the Department for Promotion of Industry and Internal Trade (DPIIT) to develop open **e-commerce**. It was incorporated on December 31, 2021.

4.3 CURRENT TRENDS IN INDIAN ECONOMY

Widening Trade Deficit

- India's merchandise exports shrank 16.7% in October to \$29.8 billion as the global slow down dented overseas demand for the country's goods.
- The first contraction since February 2021 October was the fourth successive month when dragged outbound ship¬ments below the \$30 billion level for the first time in 20 months.

■ The Imports grew 5.7% year¬ on ¬year to \$56.7 billion, windening the trade deficit in October to \$26.91 billion, as per data released by the Commerce Ministry.

Note

the gap between India's imports and exports exceeded \$25 billion.

 It is stated by the Ministry of Commerce that the October trade data was impacted by the Deepavali, Dussehra festive period as factory workers tend to go on leave and production drops.

Government earned Rs 33,422 crore from asset monetization, till date in **FY23**

- According to reports, the government has already monetized assets worth Rs 33,422 crore under the National Monetization Pipeline (NMP) for 2022–2023.
- The Coal Ministry has raised the most money, at Rs 17,000 crore, and the Ports and Shipping Ministry has surpassed its total budgetary target.
- By executing transactions of Rs 1 lakh crore in 2021-2022, the government exceeded the program's first-year objective of Rs 88,000 crore.
- The government's most recent assessment indicates that it will be difficult to reach its overall asset monetisation goal of Rs 1,62,422 crore in 2022–2023, which is expected to result in a shortfall of Rs 38,243 crore.

Note

- National Monetisation Pipeline (NMP) estimates aggregate monetisation potential GUARANTES of **Rs 6 lakh crores** through core assets of the Central Government, over a four-year period, 2011 from FY 2022 to FY 2025.
- Assets liquidated in FY 2022-23 (Ministry wise Monetisation)
 - Coal Rs.17,000 crore
 - National Highways Rs.4,100 crore
 - Railway Rs.1,829 crore
 - Energy Rs.2,000 crore

Periodic Labour Force Survey (PLFS) released by the National Statistical Office (NSO)

According to the **Periodic Labour Force Survey** (PLFS) released by the National Statistical Office (NSO), the unemployment rate in urban areas for persons above the age of 15 eased to 7.2% in July - ¬September from 9.8% a year ago and 7.6% in the previous quarter.

- The unemployment ratio is defined as the percentage of persons unemployed among the persons in the labour force.
 - The unemployment rate was 6.6% for men and 9.4% for women in July-September 2022. The rate was 9.3% and 11.6%, respectively, in July - September 2021.
 - The WPR-Working Population Ratio is defined as the percentage of employed persons in the population.
 - The WPR in urban areas for persons aged 15 and above stood at 44.5% in July -September 2022, an increase from 42.3% in the corresponding period in 2021. It was 43.9% in April - June 2022.
 - The WPR among men was 68.6% and among women, 19.7%. It was 66.6% and 17.6%, respectively, in 2021.
- The labour force participation rate (LFPR), defined as the percentage of persons in labour force who are working or seeking or available for work in the population.
 - The LFPR among men was 73.4% and 21.7% among women. In 2021, it was 73.5% and 19.9%, respectively.

4.4 INDICES

The Global Population achieved 8 billion

- According to the United Nations (UN) World Population Prospects 2022: Summary of Results (27th edition), the global population is projected to achieve 8 billion on November 15, 2022, and India is expected to overtake China as the world's most populated country in 2023.
- The UN population report said the global population is growing at its slowest rate since 1950, having fallen under 1 per cent in 2020. The world's population could grow to around 8.5 billion in 2030 and 9.7 billion in 2050. It is projected to reach a peak of around 10.4 billion people during the 2080s and to remain at that level until 2100.
- More than half of the projected increase in the global population up to 2050 will be concentrated in eight countries: the Democratic

Republic of the Congo, Egypt, Ethiopia, India, Nigeria, Pakistan, the Philippines and the United Republic of Tanzania. Countries of sub-Saharan Africa are expected to contribute more than half of the increase anticipated through 2050.

- As per UN estimates, over 27 per cent of the country's population is between the ages of 15-29. At 253 million, India is also home to the world's largest adolescent population (10-19 years).
- United Nations Population Fund (UNFPA) has noted that India has its largest ever adolescent and youth population. According to UNFPA projections, India will continue to have one of the youngest populations in the world till 2030 and is currently experiencing a demographic window of opportunity, a "youth bulge" that will last till 2025.

LATEST INVENTIONS ON SCIENCE & TECHNOLOGY

Mission Prarambh

- The Indian Space Research Organisation (ISRO) launched India's first privately built rocket - 'Vikram-S' (VKS), a suborbital launch vehicle, from the Satish Dhawan Space Centre in Sriharikota, Andhra Pradesh.
- The rocket "Vikram-S," which is the first in the Vikram series, is named after Vikram Sarabhai, the father of the Indian Space Programme and founder of ISRO.
- It is being developed under the mission "Mission Prarambh" (the beginning), which represents a new beginning.
- Prarambh is the maiden mission Hyderabad-based space-tech startup Skyroot **Aerospace**, and received support from ISRO as well as the Indian National Space Promotion and Authorisation Centre (INSPACe).
- The engine used in the launch vehicle is named after former president Dr A P J Abdul Kalam called 'Kalam-80'.

About 'Vikram-S' Rocket & Prarambh Mission

- Vikram-S" is one of the world's first allcomposite rockets with 3-D printed solid thrusters for spin stability of the launch vehicle.
- According to Skyroot Aerospace, Vikram-S is the quickest and most affordable voyage to space.
- It has a body mass of 545 kg, a length of 6 metres, and a diameter of 0.375 metres.
- The three satellites carried by Vikram-S Chairman Sreedhara Panicker Somanath includes one by SpaceKidz India called FunSat,

parts of which were developed by school students.

• The Vikram rockets will be able to carry between 290 kg and 560 kg payloads into sunsynchronous polar orbits.

ISRO to attempt 200th successful launch of sounding rocket in a row

- The Indian Space Research Organisation (ISRO) will attempt the 200th consecutive successful launch of the Rohini RH¬200 sounding rocket from Vikram Sarabhai Space Centre (VSSC), Thumba, Kerala.
- RH¬200 is a **solid motor powered**, expendable rocket capable of climbing up to a height of 70km bearing payloads designed to study the upper atmosphere.

- An RH¬200 had lifted of successfully from Thumba for the 199th time in a row in October, 2022.
- VSSC Director S. Un¬nikrishnan Nair.

5.2 SPACE

NASA's Artemis 1 Launch

- NASA's Artemis 1 mission was launched from Launch Complex 39B of the Kennedy Space Center in Florida at 12.17 PM IST on November 16, 2022.
- Around eight minutes after launch, the core stage engines cut off and the core stageseparated from the rest of the rocket.
- After this, the Orion spacecraft was propelled by the Interim Cryogenic Propulsion Stage (ICPS).
- NASA also deployed the Orion spacecraft's four solar arrays.
- After completing "translunar injection," Orion separated itself from ICPS and is on its way to lunar orbit.
- Artemis II will follow in Artemis I's footsteps.

PSLV-C54 successfully launched

- The Indian Space Research Organisation (ISRO) in one of its longest missions successfully placed nine satellites, including an Earth Observation Satellite (EOS - 06) in multiple orbits with the help of the space agency's Polar Satellite Launch Vehicle (PSLV-C54).
- The vehicle took off precisely at 11.56 a.m. The spacecraft carried three astronauts Fei from the first launch pad (FLP) at the Satish Dhawan Space Centre (SDSC), SHAR, Sriharikota, Andhra Pradesh.
- This is the 56th flight of the Polar Satellite **Launch Vehicle (PSLV)** and the 24th flight of the PSLV - XL version with 6 PSOM - XLs
- The eight nano satellites include
 - ISRO Nano Satellite 2 for Bhutan (INS -
 - Anand India's first private earth imaging India's first ever launchpad for a private satellite.
 - Astrocast (four satellites),
 - Two Thybolt satellites.
- Notably, EOS 6 is the Oceansat series' third generation satellite.

IndiaBhutan SAT or ISRO Nano Satellite 2 for Bhutan (INS2B)

- BhutanSat (aka INS-2B) is the collaborative mission between India and Bhutan.
- The INS 2B satellite has two payloads.
 - NanoMx, a multispectral optical imaging payload developed by SAC,
 - APRS Digipeater, which is jointly developed by DITTBhutan and URSC.

China sends new crew to Tiangong space station

- China successfully launched **Shenzhou-15** spaceship, spacecraft carrying astronauts to Tiangong (China's underconstruction space station) atop the Long March-2F Y15 carrier rocket from the Jiuquan Satellite Launch Centre in northwest China.
- Junlong, Deng Qingming, and Zhang Lu.

Note

 Tiangong (Palace in the Sky) is a space station constructed by China and operated by China Manned Space Agency (CMSA) in low Earth orbit between 340 and 450 km above the surface.

Sriharikota gets India's first private space launchpad

- launch vehicle was established at Satish Dhawan Space Center, Sriharikota, Andhra Pradesh.
- The launch pad was established by **Agnikul**, the Chennai headquartered space tech startup.

• The facility, which was designed by Agnikul and executed with the support of ISRO and Indian National Space Promotion and Authorization Center (IN¬ SPACe), has two 👊 sections: the Agnikul launchpad and the Agnikul mission control Center.

Note

- Agnibaan is Agnikul's highly customizable, two stage launch vehicle, capable of carrying up to 100 kg in payload to orbits 700 km high.
- Agnilet is the world's first single piece 3D printed engine, fully designed and manufactured in India.

- Its successful test¬ firing in early 2021 made Agnikul, the first company in the country to test its engines at ISRO.
 - Agnibaan and Agnilet will be used in the Agnikul's first launch.

No Money for Terror" Conference

- The 3rd Ministerial "No Money for Terror" (NMFT) Conference held from November 18 and 19, 2022 in New Delhi.
- The major topics discussed at the 2022 NMFT Conference spanning four sessions are
 - Global trends in terrorism and terrorist financing
 - Use of formal and informal channels for terrorism
 - Emerging technologies and terrorist financing
 - International cooperation to address challenges in combating terrorist financing.
- India has proposed a permanent secretariat for 'No Money for Terror' (NMFT), a ministerial conference, in order to sustain the global focus on countering the fi nancing of terrorism.

About NMFT Conference

- The Ministerial No Money for Terror (NMFT) Conference aims to create platform for international discussions on countering terror 20 financing.
- The conference includes discussions on technical, legal, regulatory and cooperative aspects of the terrorism financing. It aims to set pace for other high-level official and political discussions focusing on terror finance.
- The inaugural edition of this conference was held in Paris, France, in 2018. The second edition of the NMFT took place in Melbourne, Australia, in 2019.
- The third edition was set to take place in India in 2020 but was postponed because of COVID-19 pandemic that caused the globallevel restrictions on travel.

Biggest iPhone manufacturing unit near Hosur;

- Telecom and IT Minister Ashwini Vaishnaw said that the biggest unit to manufacture Apple iPhone in India is coming up near Hosur in Bengaluru, which will employ around 60,000 people.
- Apple has outsourced the manufacturing of iPhone enclosures to Tata Electronics, which has a plant at Hosur.
- The company gets iPhones manufactured by electronics giants - Foxconn, Wistron and Pegatron in India.

WHO Global Centre for Traditional Medicine (GCTM)

- On the sideline of G20 summit being held in Bali, Indonesia World Helath Organisation (WHO) chief Tedros Adhanom Ghebreyesus thanked Prime Minister Narendra Modi for collaborating with the world health body on hosting and building the global traditional health centre.
- Prime Minister Modi, World Health Organisation Director-General Ghebreyesus and Mauritius Prime Minister Pravind Jugnauth laid the foundation stone for the WHO Global Centre for Traditional Medicine (GCTM) in Gujarat's Jamnagar city in April 2022.
- The centre, supported by an investment of USD 250 million from India, aims at harnessing the potential of traditional medicine from across the world through modern science and technology to improve the health of people and the planet, according to the WHO.

Note

 The World Health Organization (WHO) defines traditional medicine as "the sum total of the knowledge, skills, and practices based on the theories, beliefs, and experiences indigenous to different cultures, whether explicable or not, used in the maintenance of health as well as in the prevention, diagnosis, improvement or treatment of physical and mental illness"

- The 53rd IFFI was conducted jointly by the National Film Development Corporation (NFDC) and the Entertainment Society of Goa (ESG) at Dr. Shyama Prasad Mukherjee Indoor Stadium in Goa.

- The legendary Spanish fifilmmaker Carlos Saura was given the Satyajit Ray Lifetime Achievement Award. Carlos Saura's daughter, Anna, accepts the award on behalf of the filmmaker at the opening ceremony of the IFFI.

India Launches Official Website of SCO for 2023 – "For a SECURE SCO"

 India has launched the official website of the Shanghai Cooperation Organization (SCO)
 "For a Secure SCO," as it will hold the next SCO summit as chairman in 2023.

- India will preside over the SCO Council of Heads of State in for the first time from September 2022, lasting for one year till September 2023.
- The official website of India's Chairmanship of the SCO Council of Heads of State is https:// indiainsco.in/home.
- At the 22nd Meeting of the SCO Council of Heads of State 2022 in Samarkand, Uzbekistan, India took over the rotating presidency of the SCO from Uzbekistan.
- Uzbek President Shavkat Mirziyoyev chaired the 22nd SCO summit in Samarkand.

Health ministry includes coronary stents in National List of Essential Medicines, 2022

- The Union Health Ministry has notified the inclusion of coronary stents in the National List of Essential Medicines, 2022.
- The inclusion is based on the recommendations by an expert committee constituted to review the inclusion of stents in the list based on requirement.
- A move that will help make these life-saving medical devices more affordable.
- The National Pharmaceutical Pricing Authority (NPPA) will fix the price of coronary stents.
- The Standing National Committee on Medicines (SNCM) had submitted its recommendation for inclusion of coronary stents in the National List of Essential Medicines (NLEM), 2022 in two categories -Bare Metal Stents (BMS) and Drug Eluting

- Stents (DES) which include metallic DES and bioresorbable vascular scaffold (VBS)/ biodegradable stents.
- Several anti-cancer drugs, antibiotics and vaccines were among 34 new additions to the National List of Essential Medicines released on September 13, 2022 taking the total number of drugs under it to 384.

Note

- The National List of Essential Medicines (NLEM) is a list released by the Ministry of Health and Family Welfare.
- The first National List of Essential Medicines of India in 1996 consisted of 279 medicines. This list was subsequently revised in 2003, 2011, 2015 and 2022.
- The medicines listed in the NLEM are sold below a price ceiling fixed by the National Pharmaceutical Pricing Authority (NPPA).
- In India, it was framed on the lines of the Essential Medicines List (EML) released by the WHO.

Union Health Ministry launches India's first suicide prevention policy

- The Ministry of Health and Family Welfare announced a National Suicide Prevention Strategy, the first of its kind in the country, with time bound action plans and multisectoral collaborations to achieve reduction in suicide mortality by 10% by 2030.
- The recent National Crime Records Bureau (NCRB) report stated that 1.64 lakh people died by suicide in 2021. This is 10 per cent higher than the COVID deaths in India 2020, and 6.8 times the maternal death (23800) in 2020.
- The UN's Sustainable Development Goal (SDG) 3.4 aims to reduce premature mortality from non-communicable diseases by onethird, through prevention and treatment, and promote mental health and well-being. One of the indicators for this is the suicide rate.
- In India, more than one lakh lives are lost every year to suicide, and it is the top killer in the 15-29 years category.
- In the past three years, the suicide rate has increased from 10.2 to 11.3 per 1,00,000 population.

 The most common reasons for suicide include family problems and illnesses, which account for 34% and 18% of all suicide¬ related deaths.

PM Rojgar Mela

- PM Modi will launch the second phase of the Rojgar Mela.
- PM Rojgar Mela 2022 was initiated by the Government of India and was announced by the Prime Minister of India, Narendra Modi on October 22, 2022 via a video conference.
- Rojgar Mela is an initiative by the Government of India wherein 10 lakh jobs will be available for candidates to apply in Group A and B Gazetted Posts, Group B Non-Gazetted and Group C Non-Gazetted posts.
- Earlier in the month of October 2022, in the first phase appointment letters were handed over to 75,000 new recruits.
- In the second phase, 71000 people will be given employment orders.
- Appointments will be made for the posts of Teacher, Lecturer, Nurse, Nursing Officer, Doctor, Pharmacist, Radiologist and other technical and paramedical posts. In particular, more appointments will be made in the Central Armed Police Forces.
- PM Modi will also launch online training courses for newly appointed candidates.
- According to the Prime Minister's Office, the training includes Code of Conduct for Government Servants, Workplace Ethics-Coordination, Human Resource Policies, Benefits and Steps for Government Servants.

Zorba, India's first dog on anti-poacher duty, is dead

- Zorba, India's first dog to be deployed for tracking down poachers, has died of agerelated ailments in Guwahati.
- The 12-year-old male Belgian Malinois was a member of 'K9', the nation's first dog squad to fight wildlife crime.
- Zorba was the first dog of the squad.
- Zorba retired from service in 2019 and was honored with a traditional Assamese gamosa (a scarf) and a citation on Independence Day on 2022.

 Zorba served mostly in the Kaziranga National Park from 2012 till his retirement.

Railways to simulate accident to test preparedness of relief teams

- In a first, the Indian Railways is assessing the preparedness and performance of its accident relief teams in real time by simulating a major accident, involving derailment of coaches and huge casualties in Bengaluru.
- The exercise is being organised by the Indian Railway Institute of Disaster Management, Bengaluru, in association with the National Institute of Disaster Management, New Delhi.
- About 40 senior railway officers, 50 officials incharge of Accident Relief Trains from across Indian Railways and 75 disaster management experts drawn from different fields will participate in the programme.

New guidelines for travel to the UAE

- The National Advance Information Center

 UAE has notified that the passport holder should have their primary (first name) and secondary (surname) names mentioned properly in their passports.
- The passengers with a single name (word) either in surname or given name will not be accepted by the UAE immigration and the passenger will be considered inadmissible.
- This is applicable only to passengers with visit visa, visa on arrival, employment, and temporary visas and is not applicable to existing UAE resindent card holders.

EV Charging Station at Chennai Airport

- First of its kind, an electric vehicle charging station was installed at the Chennai airport.
- Airports Authority of India, Chennai Airport and Indian Oil Corporation have jointly set up an electric vehicle charging station at Chennai Airport.
- The Airports Authority of India (AAI) has set up an electric vehicle charging station at the airside of Chennai airport for charging ground handling vehicles and passenger shuttle buses.
- This is the first electric vehicle charging station opened by Indian Oil Corporation outside retail outlets.

 EV Charging station will not only help reduce the carbon footprint within the airport, but will also be cost-effective in terms of daily operational costs.

Note

- e-AMRIT (Accelerated e-Mobility Revolution for India's Transportation) is a one-stop portal for creating awareness about electric mobility through Electric Vehicles (EVs) in India.
- The portal aims to ease the transition from fossil fuel driven vehicles to electric vehicles by providing all information about policies, incentives, charging stations, business requirements.

India's First Private Agricultural Mandi at Nashik

- The Sahyadri Farmer Producer Company (FPC) (based in Nashik) is set to launch the first ever private agricultural mandi (market) for grapes in Mohadi village in Dindori taluka, Nashik, Maharashtra.
- The world-class infrastructure will be established in the next three months at a financial outlay of Rs. 25 crores.
- FPC will develop a 100-acre dedicated market space integrated with world-class infrastructure along services from banking to storage, processing, and packaging under one roof.

Note

- Sahyadri FPC became the first farmer producer organisation in India in November 2022 to get the license to set up a private Agricultural Produce Marketing Committee (APMC) market.
- So far, the traditional agricultural produce market committees (APMCs) have played a major role in regulating the market for agricultural produce and have established a monopoly.

North East's first RRIUM in Silchar, Assam

 Sarbananda Sonowal, Union Minister of Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homeopathy (AYUSH), inaugurated the Regional Research Institute of Unani Medicine (RRIUM), the first of its kind institute for Unani Medicine in North East, in Silchar, Assam.

- The state-of-the-art institute will play a vital role in the promotion of Unani medicine, a traditional medicinal practice in the Ayush system.
- The complex was developed by the National Projects Construction Corporation (NPCC) Limited and handed over to the Central Council for Research in Unani Medicine (CCRUM), an autonomous organisation under AYUSH Ministry.

Himalayan yak gets food animal tag

- The **Himalayan yak**, a multi-purpose bovine found in high-altitude areas of the Himalayan region, has been designated as a food animal by the Food Safety and Standard Authority of India (FSSAI) based on the recommendation from the **Department of Animal Husbandry** and Dairying (DAHD).
- National Research Centre on Yak (NRCY) based in Dirang in Arunachal Pradesh, said his institution had submitted a proposal to the FSSAI in 2021 for considering the yak as a food animal.
- The FSSAI's recognition will help farmers rear the yak economically and open up several vistas of economic benefits for both farmers and food processors.

- Families, with an annual income less than Rs.1.8 lakh, can avail free health check-up and treatment under the Nirogi Haryana scheme.

- The framing of the Constitution took over 2 years, 11 months and 17 days.
- There were 299 members in the Constituent Assembly and 15 were women and when the constitution was adopted in 1949, 284 members finally signed it.
- During this period, it held 11 sessions covering 165 days, and its members submitted around 7,600 amendments to the draft Constitution.
- Dr. Rajendra Prasad was the chairman of the Constituent Assembly.

World's 'Longest' Gas Supply Deal

- Qatar and China signed the 27-year natural gas supply deal which will be the longest gas supply dead any country ever made.
- The China Petroleum and Chemical Corporation (Sinopec) will get 4 million tonnes of liquefied natural gas (LNG) annually from the state energy company's new North Field East project.
- The deal marks the **longest gas supply** agreement in the history of the LNG industry.
- Since Russia invaded Ukraine, European nations have become more interested in Qatar's gas, which is primarily sold to Asian nations led by China, Japan, and South Korea.

CM launches housing scheme for construction workers

- Chief Minister M.K. Stalin launched a housing scheme for construction workers, who are registered members of the Tamil Nadu Construction Workers' Welfare Board.
- In the first phase, over 100 beneficiaries are to be covered under the scheme, which aims at benefiting over 10,000 construction workers annually at a cost of Rs.400 crore.
- The Tamil Nadu Construction Workers Welfare Board was constituted to extend all possible assistance for the education of the children of the members, marriage and other welfare schemes, including the construction of houses.
- Between May 2021 and October 22, welfare assistance to the tune of Rs 322 crores was provided to over 4 lakh beneficiaries.
- Besides, more than 771 lakh workers enrolled during this period.

Healthcare Conference 2022

- TN CM MK Stalin inaugurated the Healthcare Conference 2022 in Omandurar Multi-Speciality Hospital in Chennai. He stated that the reasons for institutes' and districts' poor performance will be ascertained and steps will be taken to improve the situation.
- The government plans to provide quality medical care in rural areas, and urged deans of medical college hospitals, deputy directors of health services, joint directors of health services, and other health officials to improve healthcare services.
- TN aims to reduce communicable diseases and non-communicable diseases, and improve mental health and accident and trauma care in line with Sustainable Development Goals.
- The Tamil Nadu Health and Family Welfare Department has ranked State-run healthcare

institutions, and rated districts based on 17 criteria including Maternal Mortality Rate (MMR), Infant Mortality Rate (IMR), and out-patient treatment.

• This is the first time the State has ranked primary healthcare centres (PHCs), healthcare sub-centers, district headquarters hospitals, and medical college hospitals. Tenkasi, Tirupathur, and Dindigul are at the bottom of the list, and Kancheepuram, Namakkal, and Thoothukudi districts have performed the best.

Note

Schemes like Makkalai Thedi Maruthuvam, Nammai Kakkum 48 and Chief Minister's Comprehensive Health Insurance Scheme have been launched in Tamil Nadu to improve the healthcare infrastructure of the State.

Tamil Chair in Houston

- Tamil Nadu Chief Minister M.K. Stalin handed over a cheque of Rs.2.50 crore for the setting up of a Chair for Tamil at the Houston
 University in the USA, on behalf of the Tamil Development Department.
- Houston Tamil Studies Chair Inc. president, Sockalingam (Sam) Kannappan and its secretary Perumal Annamalai received the cheque from the Chief Minister at the Secretariat in Chennai.

Elephant death audit framework was introduced

- Tamil Nadu's Forest Department has introduced an elephant death audit framework to establish a more detailed and transparent process for recording and monitoring deaths.
- It is a first of its kind initiative in India.
- It prescribes a systematic standard protocol for conducting post mortem to determine the reasons for death.

- It will help study the circumstances of preventable and unnatural deaths and formulate measures to avoid them.
- The baseline data will help the officials to determine whether the mortality rates of the elephant are a cause for serious concern or within acceptable limits.

Note

 There remains a lack of clarity on the natural vs. unnatural deaths of elephants and how this is affecting the population in the long term, allover Tamil Nadu for the death of elephants in the wild. The framework will help to solve this issue.

Chennai's only 'white' police station was ISO certified

- Flower Bazaar police station was awarded ISO 9001:2015 and WASH (Workplace Assessment for Safety and Hygiene) standard certificates after independent assessment of the standards by an autonomous body.
- At 146 years old, **Flower Bazaar police station** is one of the oldest in the city. It is also the only police station, painted white, a deviation from the red colour, which has now become synonymous with stations across the State.
- It is the fifth police station in Tamil Nadu and the 10th in India to get both standard certificates.

Tamil Nadu Sustainable Energy Transformation Dialogues

- In the inaugural event Supriya Sahu, Additional Chief Secretary, Environment, Forests and Climate Change stated that Tamil Nadu is developing its own greenhouse gas emission inventory.
- The event is organised by WRI India, Auroville Consulting and Citizen consumer and civic Action Group (CAG).
- The steps Tamil Nadu had taken in its fight against climate change includes
- The declaration of 13 wetlands as Ramsar sites in six months, up from one
- Green Tamil Nadu Mission
- Climate Change Mission.

Challenges discussed regarding Sustainable Energy Transformation

- The higher peak demand usually occurs during summer, especially at night when the availability of renewable energy will be lower. So the reliance on coal based power plants will be higher at such times. So the fossil fuel based power plants would continue operating to meet the peak demand in summer.
- According to a study, though the installed capacity of renewable energy was higher, the unit consumption thereof had not crossed 21%, as mandated by regulation, at the national and State levels.
- According to WRI's working paper on 'Low Emissions Analysis Platform for Tamil Nadu', which was released at the event, the State could cut its emissions by 25%¬ 32% if it integrated 60% of its renewable capacity.

Tamil Nadu Day event

 Minister for Information and Publicity M. P. Saminathan inaugurated the Tamil Nadu Day celebrations at the 41st India International Trade Fair at Pragati Maidan in New Delhi.

About 41st India International Trade Fair

- Minister of Commerce and Industry Piyush
 Goyal inaugurated the fair.
- The fair will be held from **November 15 to 27 November.**
- Since 2014 The theme of the trade fair for 2022 is "Vocal for Local, Local to Global".

8th State Conference of Construction Workers' Union of the All Indian Trade Union Congress

- The Construction Workers' Union of the All Indian Trade Union Congress' 8th State Conference took place in Ranipet.
- In order to improve the academic performance of children of construction workers studying 6th to 9th standard will receive a grant of Rs. 1,000 from the current year.
- In case of death of construction workers in accidents, Rs. 2 lakh will be given and Rs.5 lakh in case of death of the worker at the construction site.

• For construction workers Rs.4 lakh subsidy, Rs.400 crore has been allocated for the scheme of building houses. 103 houses have been provided in the first phase.

5,035 children children get cochlear implants under CMCHIS'

- As many as 5,035 children have undergone cochlear implant surgeries at a cost of Rs.358.44 crore under the Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS).
- Golden Jubilee of upgraded Ear, Nose and Throat Department at Rajiv Gandhi Government General Hospital, Chennai.
- The Department of Otorhinolaryngology was started in 1927 under the leadership of Dr. Cherian.
- In 1972, the department was elevated to the status of a Treatment Facility and the golden jubilee is being celebrated to mark 50 years.
- In 2010, the cochlear implant program was launched by the then Chief Minister Karunanidhi. It is now linked to the Chief Minister's Comprehensive Health Insurance Scheme.
- Various advanced treatments include all advanced tests for hearing, speech lab for computerized voice analysis, treatment center for vertigo, sleep lab, polysomnography for snoring, endoscopy test for swallowing disorders, narrow band imaging for early detection of laryngeal cancer.

Naan Mudhalvan Scheme

- MoUs were signed with 6 industrial companies to provide training to engineering and polytechnic students while studying under the 'Naan Mudhalvan' project.
- 1,560 students will benefit from this agreement through 6 institutions namely Mando India (Sriperumbudur), **VVDN Technologies** (Pollachi), Sri Kannapiran Mills Limited (Coimbatore, Madurai, Perundurai), Group of Mills, Lakshmi Machine Works (Coimbatore), Gabriel India (Villupuram, Hosur).

About Naan Mudhalvan Scheme

- Launched on March 1, 2022.
- a skill The scheme was launched as development program for the students of Government Schools and Colleges.
- TN Government also launched the 'Kalloori Kanavu' programme under the 'Naan Mudhalvan' initiative which aims to guide and counsel students who have completed Class XII.
- Naan Mudhalvan portal was launched by Chief Minister M.K. Stalin on August 29, 2022 which is aimed to get over 12.5 lakh students registered on the portal by the end of the year.

Tamil Nadu: Internet page on VOC launched

- Chief minister M K Stalin launched an internet page on freedom fighter V.O. Chidambaram Pillai at the Tamil digital library and released the 150th birthday souvenir magazine, on the occasion of his 86th death anniversary.
- The internet page in the Tamil digital library consists of 11 books written by him including seven editions and four translations.
- The web page also has e-books; 20 biographic books on VOC, six centenary year souvenirs, a compilation of essays written on him, five research books and six other books on VOC.
- Besides, the web page has 17 documentaries, seven handwritten copies and 38 other documents on the life of VOC.
- Tamil virtual academy is involved in turning all the books on VOC into e-books.
- In view of 150th birthday of VOC on September 3, 2021, Stalin had announced that Tamil virtual academy will take up the task of converting all the literature on VOC into e-books.

Online Processing of Government **Documents**

- A project is being implemented to process all files in government departments only via
- More than 2.5 lakh e-files have been generated so far.

- This would result in better utilisation of manpower, thereby, avoiding delays, leading to better governance.
- It would help improve efficiency, consistency and effectiveness of Government responses; reduce turnaround times and meet the demands of the citizen charter. It will also help in providing effective resource management to improve the quality of administration; transparency and accountability; and cost-effective e-storage facilities.
- As per the e-Governance scheme, all the files will be generated in a computerized manner.
- The Tamil Nadu government is implementing e-Office applications developed by NIC (National Informatics Centre) to process all the files electronically in all government departments/ PSUs/ boards/ agencies.

TN CM reviews implementation of five major government schemes

- Chief Minister M.K. Stalin chaired a meeting of the District Development Coordination and Monitoring Committee (DISHA) to review the implementation of five major schemes in the State.
- The five schemes include implementation of the MPs Local Area Development Scheme, the National Health Mission, the Integrated Child Development Scheme, the National Food Security Act and the Prime Minister's Model Village Scheme.
- Procuring equipment designed by IIT Madras to avoid the death of workers while cleaning sewers, in creasing the unit cost of houses constructed under the Prime Minister's Housing Scheme, renaming villages and streets with caste surnames, installing more electric crematoriums in local bodies, ensuring crematoriums for all sections of society and increasing the income slab for availing the Post Matric Scholarship were among the issues that had been raised at the meeting.

T.N. mahouts and cavadies set to train in Thailand

 Thirteen mahouts/cavadies from the Anamalai and Mudumalai Tiger Reserves are set to visit the Thai Elephant Conservation

- Centre in Thailand for training and capacity building to learn how to manage camps and look after elephants better.
- The programme will involve an expenditure of Rs.50 lakh, and tiger foundation funds will be used for the purpose.
- Tamil Nadu is already a pioneer in the rehabilitation and maintenance of captive elephants. The camps at Theppakadu in the Mudumalai Tiger Reserve and Kozhikamuthy in the Anamalai Tiger Reserve. are some of the ol¬ dest elephant camps in the country. There are a total of 63 elephants, cared for by 37 mahouts and 28 cavadies, at these camps.
- On the occasion of World Elephant Day 2022 (12 August) Tamil Nadu notified Agasthyamalai Elephant Reserve as its 5th Elephant Reserve with a total area of 1,197.48 sq.km at Agasthyamalai in Tirunelveli and Kanyakumari district. This is India's 32nd Elephant Reserve. There are 5 elephant reserves in Tamil Nadu in total.

Other Elephant reserves are

- Nilgiris-Eastern Ghats 4,663 km2
- Nilambur Silent Valley in Coimbatore 566 km2
- Srivilliputhur 1,249 km2
- Anamalai 1,457 km2
- Project Elephant was introduced in 1992.

About Indian Elephant (Elephas maximus)

- It is included in Appendix I of the Convention on International Trade in Endangered Species of Flora and Fauna (CITES) and Schedule I of the Indian Wildlife (Protection) Act of 1972.
- IUCN Status Endangered
- The Project is primarily carried out in 16 States/ Union Territories (UTs): Andhra Pradesh, Arunachal Pradesh, Assam, Chhattisgarh, Jharkhand, Karnataka, Kerala, Maharashtra, Meghalaya, Nagaland, Orissa, Tamil Nadu, Tripura, Uttarakhand, Uttar Pradesh, West Bengal.

Revenue from stamp duty and registration goes up in the State

 Tamil Nadu accounted for 9% of India's overall revenue collection from stamp duty and registration charges in the first half of 2022¬-23 (H1FY2023).

- The State came third after Maharashtra and Uttar Pradesh, respectively, as per a study by Motilal Oswal Financial Services Limited.
- As per the report, the overall collections grew by 35% from Rs.70,120 crore in the first half of 2021-722 to about Rs.94,847 crore in the first half of 20227-23.
- The study examined 27 States and one Union Territory (Jammu and Kashmir).
- Tamil Nadu's revenue from stamp duty and registration charges grew by 39% from Rs.6,200 crore in the first half of 2021-22 to Rs.8,662 crore in the first half of 2022-23.
- As per the provisional figures of the 🐠 Comptroller and Auditor General of India (CAG), Tamil Nadu has achieved 53.07% of the budgeted revenue from stamp duty and registration charges for 2022-23.
- Karnataka and Telanga¬na have been placed N fourth and fifth.

Egg export soars to 4 crores

- The number of eggs exported from Namakkal district to Qatar have been increased to 2.5 crore from 1.50 crore due to an increase in demand owing to the FIFA World Cup in 2023 and a cheaper price compared with Turkish eggs.
- In Namakkal district, approximately 1,100 poultry farms are functioning, and these farms produce 5.5 crore to 6 crore eggs per day. Out of these, 1.50 to 1.75 crore eggs are sent to Kerala, 45 lakh eggs to the noon meal scheme, 40 lakh eggs to Bengaluru, and the remaining to various parts of the State and to various countries like Saudi Arabia, Iran, Iraq, Oman, Qatar, Bahrain, Maldives etc.
- Earlier, 1.5 crore eggs were exported to Qatar, and now it has increased to 2 crore to 2.5 crore.
- The World Cup in Qatar has tripled the demand for eggs in Qatar.

Note

- According to the Economic Survey 2021-22, India ranks third in production of eggs and eight in meat production in the world.
- Andhra Pradesh. **Tamil** Nadu and Maharashtra are the top egg producers in the country.

Tamil Nadu gets its first biodiversity heritage site

- Based on the recommendation of the Tamil Nadu Biodiversity Board the Tamil Nadu government issued a notification declaring Arittapatti and Meenakshipuram villages in Madurai district as the first biodiversity heritage site in the State.
- The declaration had been made under Section 37 of the Biological Diversity Act, 2002.
- The site comprises 139.63 hectares in Arittapatti village (in Melur taluk) and 53.58 hectares in Meenakshipuram village (Madurai East taluk).
- Arittapatti, known for its ecological and historical significance. It houses around 250 species of birds, including three important raptors - the Laggar Falcon, the Shaheen Falcon and Bonelli's Eagle. It is also home to wildlife such as the Indian pangolin, slender loris and pythons.
- The area is surrounded by a chain of seven hillocks, or inselbergs, that serve as a watershed, charging 72 lakes, 200 natural springs and three check dams.
- The Anaikondan tank, built during the reign of the Pandiyan kings in the 16th Century, situated in the site.
- Arittapatti has been declared as a biodiversity heritage site to prevent the loss of biodiversity 20and preserve the cultural and architectural heritage of the bygone times.

Dream House' scheme (Kanavu illam thittam) for 10 Tamil scholars and writers

- The State government has issued orders to provide a house under the 'Dream House' scheme (Kanavu illam thittam) for 10 Tamil scholars and writers, who have received the Sahitya Akademi awards or Kalaignar M.Karunanidhi Classical Tamil Award or from the Central Institute of Classical Tamil.
- Houses would be provided either in their district of residence or in a place of their choice.

Director ¬General of Audit for T.N.

- Tamil Nadu is the first State to create the role of Director ¬General of Audit, and has hired an officer from the Indian Audit and Accounts Service for the purpose.
- The officer's responsinity would be to strengthen and streamline the functioning of internal audit departments so that they perform their functions professionally.
- The State government recognised the importance of internal audits, and had proper control mechanisms so that it could improve the efficiency of expenditure.
- The internal audit departments had been operating under the same department they were supposed to audit and there was no independence. The new post would ensure independence.

T.N. notifies police law providing for Complaints Division

- The State government has notified the Tamil Nadu Police (Reforms) Rules, 2022, which provide for a Police Complaints Division under the administrative control of the ADGP of the Crime Branch CID and under the overall control of the DGP.
- The complaints received will be referred to the division for inquiry under Sections 13 and 16 of the Act by the State Police Complaints Authority and the District Police Complaints Authority.

- The Police Complaints Division is to complete its inquiry within six months from the date of receipt of a complaint and send the report to the State Police Complaints Authority or the District Police Complaints Authority, as the case may be.
- The rules also provide for the State Security Commission, which is to meet at least once in a year.

Safe Surgery - Protocols and Checklists

- Health Minister Ma. Subramanian releasing the 'Safe Surgery Protocols and Checklists', a manual on safe surgery protocols and checklists which will be issued to nearly 5,000 surgical specialists in Tamil Nadu.
- It was announced that every surgery would be audited in the State. To facilitate it, four regional death audit committees will be constituted in Madurai, Coimbatore, Tiruchirapalli and Chennai.
- Four higher speciality doctors from surgery, medicine, anesthesia and orthopedics would be members of each committee.
- The State government had reduced the fee for foreign medical graduates to take up internship in the State from Rs.3.54 lakh to Rs.25,000 in February, 2022.

Incentives to sportspersons who won in national, global events

- Chief Minister M.K. Stalin handed over incentives worth ₹4.85 crore to 190 sportspersons who won medals in various national and international events.
- Athlete T. Selva Prabhu, who bagged men's triple jump silver in the World Under-20 Athletics Championships in Cali, Colombia, and Barath Sridhar, part of the Indian mixed 4×400 relay team which won silver in the same event, received cheques for ₹4 lakh each.
- S. Marees waran and S. Karthi, who was part
 of the Indian team that secured bronze medal
 in the Asia Cup Hockey Championship 2022,
 received cheques for ₹10 lakh each.
- Winners in the International Wheelchair & Amputee Sports Federation World Games in Sharjah in 2019.

- R. Balasubramanian, who secured two gold medals in the 200 metre and 100 metre athletics, received a cheque for ₹10 lakh. A. Selvaraj, who won a gold medal in javelin event received a cheque for ₹5 lakh.
- G.Vijayasarathy, who got two bronze medals in shot put and discus throw events, received a cheque for ₹4 lakh.
- TN CM also handed over incentives to 180 sportspersons who took part in the 36th National Games 2022 in Gujarat.

T.N. to implement scheme for persons with disabilities

- The Tamil Nadu government is planning to implement a scheme for persons with disabilities' rights, with a financial assistance of ₹763.19 crore from the World Bank.
- The scheme would be implemented in all districts over the next six years.
- Industrial training would be imparted to persons with disabilities by coordinating with different government agencies.
- Under the scheme, arrangements for sign language interpreters during important public meetings organised in Collectorates will be made.

- A two-day 'Porunai Literary Festival' is being held in Palayamkottai in Tirunelveli district. TN CM Stalin virtually inaugurated the ceremony.
- Porunai is the first of five literary festivals conducted by the government of Tamil Nadu.
- The other literary festivals are Vaigai, Cauvery, Siruvani and Chennai.
- Porunai which is conducted on the banks of Thamirabarani is a significant one.
- The two-day event will see special lectures delivered by authors and literary figures.

- Archaeology is being established scientifically through various excavations and various initiatives, following Keezhadi, Sivagalai and Korkai.
- The Literary festivals are being held with the aim of taking this pride to the next generation and bringing the intellectual community to the fore.

Initiative to promote STEM education in T.N. government schools from Monday

- In a bid to encourage scientific thinking and to increase interest in science and mathematics among students, government schools across the State will form 'Vanavil Mandrams' with a focus on STEM (Science Technology Engineering and Mathematics) education.
- The School Education Department said that all 13,210-government middle, high, and higher secondary schools would initiate the forming of these STEM clubs from 2 p.m. for students of classes 6 to 8.
- To mark the beginning of this initiative, the teachers are asked to demonstrate some simple experiments in class.
- Every school has been allocated Rs.1,200 initially to buy materials for these experiments.

Permanent Walkway for the differently abled

- Since 20The country's first Permanent Walkway for Differently Abled was inaugurated at a cost of Rs 1 crore 14 lakhs under Singara Chennai 2.0 project at Chennai Marina beach.
 - Paved with eco-friendly wooden planks. The track is 263 m long and 3 m wide.
 - 11 meters long and 6 meters wide ramps have been set up for the disabled to stand in between.

Small Grain Scheme Policy

- NABARD Bank has finalized the report for Tamil Nadu regarding Small Grain Scheme Policy.
- Till the last 25 years in Tamil Nadu, small grains such as millet, varaku, samaai, sorghum and sorghum and small grain crops like corn, rye and ragi were grown extensively. These were the traditional food items of Tamils.

- In recent years, the lack of acceptance of these food items among the people has decreased and the nutritional deficiencies have started to increase in the people and diseases like diabetes and high blood pressure have started to increase.
- Thus, the general public is reverting back to small grain foods.
- The Department of Agriculture has taken forward a scheme to implement the Small Grains Scheme with the financial support of Central and State Governments at Rs.12.44 crores.
- The Central Government entrusted NABARD Bank with the task of preparing the thesis for implementation of Tamil Nadu Small Grains Movement.

State's net market borrowings go down by 30.3%

- Tamil Nadu's net market borrowings (after adjusting for repayments) have been down by about 30.3% (₹24,403 crore) till September in FY 2022¬-23, from ₹35,000 crore in the same period last year, according to data from the Reserve Bank of India (RBI).
- Tamil Nadu borrows from the market through the issue of bonds known as State Development Loans (SDLs).
- The State's gross borrowings were ₹33,000 crore till September compared with ₹39,000 crore last year. The lower borrowings reflect the improved financial performance of Tamil Nadu in the first half of 2022¬-23.
- As on September 30, 2022, Tamil Nadu's fiscal deficit stood at ₹18,726.32 crore and the revenue deficit at ₹4,184.10 crore.

Railways, India Post join hands to offer parcel service in Coimbatore

- Indian Railways and India Post have come together to offer 'Joint Parcel Product', an initiative to collect parcels at the doorstep of customers.
- The service would be rolled out in Coimbatore soon.
- The programme was announced in the Union budget and it was first launched between Surat and Varanasi on March 8, 2022.
- Under the initiative, India Post will provide the first-mile and last-mile connectivity and station-to-station connectivity will be provided by Railways.
- The service will benefit MSMEs and various industries like spare parts manufacturers.
 Apart from Coimbatore, it will also benefit the A textile industry in Tiruppur, Erode and Salem.
