- It is an afforestation project to root out invasive plants, especially Senna spectabilis and restore natural forests.
- It is being executed in Sulthan Bathery forest range of Wayanad Wildlife Sanctuary.
- Its pillars include planting saplings of Bamboo, fruit plants etc. and rainwater harvesting.
- Wayanad Wildlife Sanctuary is an integral part of Nilgiri Biosphere Reserve.

## India's First and World's Second Infantry Museum

- India's first and World's 2nd Infantry Museum and Research Centre was inaugurated in the Mhow cantonment in Indore district, Madhya Pradesh.
- The museum was inaugurated on the eve of 75 years of raising of the Infantry School and to commemorate the Vijay Diwas (December 16, 2022)
- It has been set up under the aegis of The Infantry School, Mhow.

## Palm- leaf manuscript

- India's first palm leaf manuscript museum was inaugurated at the Central Archives at a Fort in Thiruvananthapuram, Kerala.
- Palm-leaf manuscripts are one of humanity's most ancient and widespread technologies for transmitting and preserving knowledge in written form.
- The museum will feature a rare collection of over 1 crore of palm-leaf manuscripts available with the Archives Department including administrative documents from the Venad era and political and social documents from Travancore, Kochi and Malabar.

 The museum will also display manuscripts featuring ancient alphabets including Vattezhuthu, Kolezhuthu and Malayanma.

## **Maternity Leave to Pregnant Students**

- In a first in Kerala, the Mahatma Gandhi University (MGU) in Kerala has decided to grant maternity leave of 60 days to UG and PG students of 18 years and above
- The move will help the girl students continue their studies without any interruptions.
  - According to the university, maternity leave can be taken before or after delivery, but will be granted only for the first or second pregnancy and only once during the duration of a course.

## Goa Liberation Day

 Goa Liberation Day is celebrated on December 19 to commemorate the state's liberation from Portuguese rule in 1961.

#### History

- Dr. Ram Manohar Lohia led the Goa liberation movement on June 18, 1946, with the aim of liberating Goa by gathering the people.
- On 19 December 1961, under the Prime Ministership of Jawaharlal Nehru Indian Armed Forces carried out Operation Vijay that resulted in annexation of Goa, Daman and Diu into the Indian Union
- They were constituted as a Union Territory (UT) by 12th Constitutional Amendment Act, 1962.
- Later, in 1987, Goa was conferred a statehood. Consequently, Daman and Diu was made a separate UT.

## **Yudh Abhyas 2022**

- The 18th edition of Indo US joint training ... exercise "Yudh Abhyas 22" was conducted in Auli, Uttarakhand,
- Exercise Yudh Abhyas is conducted annually between India and USA with the aim of exchanging best practices, Tactics, Techniques and Procedures between the Armies of the two nations.
- The joint exercise will also focus on Humanitarian Assistance and Disaster Relief (HADR) operations. Troops from both nations will practice launching of swift & coordinated - The 5 basic principles to address issues of relief efforts in the wake of any natural calamity.

## **ICG** commissions Advanced Light Helicopter Mk-III squadron

- The Coast Guard Region East, 840 Sqn (CG), an Indian
- Coast Guard Advanced Light Helicopter (ALH) Mk-III squadron, was commissioned by the Director General of Coast Guard VS Pathania at ICG Air Station, Chennai.
- The commissioning of 840 Sqn (CG) is indicative of the leap towards self-reliance in the field of helicopter manufacturing, in line with the government's vision of 'Aatmanirbhar Bharat'.
- It will provide a major fillip to the abilities of the Indian Coast Guard in the security sensitive waters off Tamil Nadu and Andhra region.
- The ALH Mk-III helicopters are indigenously. manufactured by Hindustan Aeronautics Limited (HAL)
- The helicopters feature state-of-the-art equipment including advanced RADAR as well as Electro optical sensors, Shakti engines, full glass cockpit, high-intensity searchlight, advanced communication systems, automatic identification system as well as search-andrescue homer.
- A total of 16 ALH Mk-III aircraft have been inducted into the Indian Coast Guard in a phased manner and four of these aircraft are positioned in Chennai.

## **Coastal Security Conference in Chennai**

- Coastal Security Conference (CoSC) under the aegis of Colombo Security Conclave (CSC) was inaugurated at Chennai.
- The heads of the Coast Guard of member countries India. Sri Lanka. Maldives and Mauritius and observer countries-Bangladesh and Seychelles-participated in the conclave.
- The theme of the Coastal Security Conference 2022 is "collaborative efforts for coastal security".
- Maritime Security include
  - Legitimate maritime trade
  - Settling maritime disputes by peaceful
  - Mitigating natural disasters & maritime threats
  - Preservation & protection of maritime environment
  - Encouraging responsible maritime for increasing connectivity maritime trade through creation of sustainable infrastructure.

## **About Coastal Security Conference**

- The CSC, was formed in 2011 as a trilateral maritime security grouping of India, Sri Lanka and the Maldives.
- The grouping is in line with India's vision of "SAGAR: Security and Growth for all in the Region" and now it includes Mauritius as a full-time member and Bangladesh and Seychelles as observer countries.

#### **B-21 Raider nuclear stealth bomber**

- Northrop Grumman Corporation (US) has recently unveiled its new B-21 "Raider" jet, the first of a new class of long-range stealth nuclear bombers for the United States Air Force.
- The **B-21 Raider** will utilize cutting-edge stealth technologies for nuclear missions and long-range bombardment. The B-21 Raider aircraft will be subsonic. The average speed is 563 miles per hour.

## 39th Edition of India - Indonesia **Coordinated Patrol**

- The 39th edition India-Indonesia of Coordinated Patrol (IND-INDO CORPAT) between the Indian Navy and the Indonesian Navy is being conducted from 08 - 19 December 2022.
- Indian Naval Ship (INS) Karmuk, an The Indian Navy is the naval branch of the Corvette 🕠 indigenously built Missile participated in the pre-deployment briefing at . Belawan, Indonesia.
- The CORPAT will be executed along the International Maritime Boundary Line (IMBL).
- INS Karmuk, L-58 (indigenously built Landing Craft Utility vessel) and Dornier Maritime Patrol Aircraft will be participating in the CORPAT.

## **Defense Logistics Industry Corridor**

- To achieve the goal of self-reliant India and to achieve the goal of manufacturing in India, the Central Government has established two Defense Logistics Industrial Corridors (DICs) in the country, one in Uttar Pradesh and the other in Tamil Nadu.
- Six terminals namely Agra, Aligarh, Chitrakoot, Jhansi, Kanpur and Lucknow have been identified for development of Uttar Pradesh Defense Logistics Industrial Corridor (UPDIC).
- Similarly, five terminals namely Chennai, Coimbatore, Hosur, Salemand Tiruchirappalli have been identified for development of Tamil Nadu Defense Logistics Industrial Corridor (TNDIC).
- The government moots to create a better defense manufacturing ecosystem.
- Based on the data from the TN Government, MoUs have been signed with 53 companies for

investments of 11, 794 crore rupees in the state and have already received 3,847 crore rupees as investment.

It has been reported that 910 hectares of land has been acquired for the Tamil Nadu Defense Logistics Industry Corridor.

- The Maratha Emperor, Chhatrapati Shivaji Maharaj is considered the Father of the Indian Navy.
- The Indian Navy was established by the East India Company in 1612.
- Later it was named as Royal India Navy and post-Independence, it was reconstituted as the Indian Navy in 1950.

## Interesting Facts about the Indian Navy

- Earlier called the Royal Indian Navy, the naval wing of the armed forces of India was renamed the Indian Navy on January 26, 1950, as India became a Republic.
- Indian Naval Academy, Ezhimala is Asia's largest naval academy. Situated in Kerala, the campus occupies an area of 2452 acres, with a total perimeter of 22 km. The Academy also includes a beach stretch of 7 km.
- Indian Navy's **BrahMos missile is the fastest** cruise missile in the world.
- The INS Arihant is the first ballistic missile submarine to be built by a nation other than the five permanent members of the UN Security Council (UNSC).

- IN completed an expedition to the South Pole and the North Pole in 2006 and 2008 respectively. The Indian Navy became the only organisation in the world to conquer all three poles viz. South Pole, North Pole and Mount Everest.
- Sagar Pawan is the Indian Navy's aviation arm's aerobatic demonstration team. It is one of only two naval aerobatic teams in the world, the other being the US Navy's Blue Angels.
- The new ensign of the Indian Navy was unveiled on September 2, 2022, which is inspired by the seal of Indian emperor Chhatrapati Shivaji Maharaj. The move came to do away with the colonial past as the previous naval ensign consisted of the St. George's Cross.

## Agni V ballistic missile with 5,000 km range

- India successfully test fired nuclear capable ballistic missile Agni V from the APJ Abdul Kalam Island off Odisha coast.
- It can strike targets at ranges up to 5,000 km, marking a significant boost to the country's strategic deterrence.
- Agni V can bring almost the entire Asia including the northernmost part of China and regions in Europe under its striking range.

 Agni-V is a nuclear capable Intercontinental ballistic missile developed by the Defence Research and Development Organisation (DRDO)

## India's First anti-submarine warfare ship

- The Indian Navy launched the INS Arnala.
- It is the first of eight indigenously built Anti-Submarine Warfare Shallow Water Craft (ASW-SWC) at shipbuilding facility of Larsen & Toubro (L&T) in **Kattupalli**, **Chennai**.
- It is built by Garden Reach Shipbuilders and Engineers Ltd. (GRSE), Kolkata, West Bengal.

• The ship's name, "Arnala" honours the strategic maritime significance that was bestowed on the Island of Arnala by the Maratha ruler Chhatrapati Shivaji.

#### Note

On April 2019, the Ministry of Defence and GRSE, Kolkata, signed a deal for the construction of eight ASW-SWC ships.

## IAF test-fires extended range BrahMos

- The Indian Air Force (IAF) successfully fired the Extended Range (ER) version of BrahMos cruise missile.
- The ship is scheduled to be commissioned into 🖐 It was launched against a ship target from a SU-30MKI fighter aircraft.
  - The test was conducted in the Bay of Bengal region.
  - The test signifies a capability boost to carry out precision strikes from SU-30MKI aircraft against land/sea targets over very long ranges.
  - The test gives the IAF a strategic reach and allows it to dominate the future battlefields.

#### **About Brahmos:**

- It is a ioint venture between Defence Research and Development Organisation (DRDO) and Russia's NPO Mashinostroveniya
- The missile derives its name from Brahmaputra and Moskva rivers.
- The missile is capable of being launched from land, sea, sub-sea and air against surface and sea-based targets. Range - 450 kms.

## India assumes monthly presidency of UNSC

- India assumed the monthly rotating presidency of the UN Security Council Multilateral Export Control Regimes (UNSC) on December 1 for the second time in its two-year tenure as an elected member of the Council in 2021-22.
- India had earlier assumed UNSC presidency in August 2021.
- Under India's December presidency of UNSC, there are two signature events at the ministerial level, scheduled for December 14 (Reformed Multilateralism) and December 15 (Counter-Terrorism).
- The other signature event planned is the high-level briefing on the theme "Threats to International Peace and Security Caused by Terrorist Acts: Global Approach to Counter Terrorism - Challenges and Way Forward", scheduled for December 15.

#### **About UNSC**

- One of the six organs of the UN.
- Formation 24 October 1945
- Membership 15 countries (5 permanent and 10 non permanent members)
- The permanent members are China, France, Russia, the United Kingdom, and the United States.
- 10 non permanent members are elected for a term of two years.
- At Present, India is a non permanent member whose tenure ends in December 2022.

## India to assume Chairmanship of Wassenaar Arrangement (WA)

- India will assume the chairmanship of the Wassenaar arrangement on January 1, 2023.
- Wassenaar Arrangement is a multilateral export control regime (MECR) that works to promote transparency and responsibility in transfers of conventional arms and dualuse goods and technologies through regular exchanges of information among its members.
- WA was established in 1996. It is a voluntary export control regime consisting of 42 members.

• India joined WA in 2017 as its 42nd participating state.

#### Note

• MECR are voluntary and non-binding agreements. It prevents proliferation of Weapons of Mass Destruction (WMD) which includes nuclear, radiological, biological or other weapons.

## Other regimes under MECR includes

Nuclear Supplier Group (NSG), 1975:

- Prevents nuclear proliferation by implementing guidelines for nuclear and nuclear-related exports.
- India is not a member of NSG

### Australia Group, 1985

- Ensures that exports do not contribute to development of chemical or biological weapons.
- 43 members including India and EU.

## Missile Technology Control Regime (MTCR),

- Prevent proliferation of missile and unmanned aerial vehicle technology capable of delivering WMD.
- It is not legally-binding treaty.
- 35 members including India.
- China is not a member of MTCR.

## 17th Asia and Pacific Regional Meeting (APRM) of ILO

- The 17th APRM of the International Labour **Organisation (ILO)** was held in **Singapore** to discuss national action to deal with the issue of dwindling wages of workers, inflation and unemployment in Asia, Pacific and Arab State.
- It focuses on actions to enhance job-rich growth that is inclusive and transformative.
- Meeting concludes with adoption of the Singapore Declaration.

#### **Key highlights of Singapore Declaration**

 Strengthen social dialogue and labour market institutions to a sustained inclusive growth.

- Ensure labour protection for all through effective recognition of the right to collective bargaining.
- Strengthen governance frameworks to protect. rights of migrant workers.

#### COP 15 of CBD

- The 15th Conference of Parties (COP15) to the UN Convention on Biological Diversity the Kunming-Montreal adopted Global Biodiversity Framework (GBF).
- The framework has 4 goals and 23 targets that the world needs to achieve by 2030.
- Nature is critical to meeting the Sustainable Development Goals and limiting global warming to 1.5 degrees.
- Adoption of a global biodiversity framework that addresses the key drivers of nature loss is needed to secure our own health and wellbeing alongside that of the planet.
- The framework's four overarching global **goals** are
  - GOAL A -increasing the area of natural ecosystems by 2050.
  - GOAL B Supporting the achievement of sustainable development, for the benefit of present and future generations by 2050.

- GOAL C The monetary and non-monetary benefits from the utilization of genetic resources, and digital sequence information on genetic resources, and of traditional knowledge of the indigenous peoples and local communities are substantially increased by 2050.
- GOAL D Progressively closing the biodiversity finance gap of \$700 billion per year, and aligning financial flows with the Kunming-Montreal Global Biodiversity Framework and the 2050 Vision for Biodiversity.

## About Convention on Biological Diversity (CBD)

- CBD is an international treaty for the conservation of biodiversity, the sustainable use of the components of biodiversity and the equitable sharing of the benefits derived from the use of genetic resources.

- Known as the "Indian Robin Hood", Tantya Bhil Tantia Bhil symbolized the feelings of tribals and general masses with his indomitable courage and passion for uprooting British rule.
- Going by the British accounts of that time, he has been described as a criminal but was considered a heroic figure by Indians.
- He was popularly called "Mama" by people of all age groups. This address of Tantia became so popular that the Bhils still feel proud of being addressed as "Mama".

#### About his life:

- Tantya Bhil, who belonged to the Bhil tribe of the indigenous Adivasi community, was born in 1840 in Badada village under East Nimar, now known as Khandwa, in Madhya Pradesh.
- Tantya is hailed as one of the revolutionaries who waged an armed struggle against British rule for 12 years.
- As per reports, he used to plunder the treasuries of the British government and the wealth of their followers to distribute it among the poor and needy.

#### Note

 In 2021, Madhya Pradesh Chief Minister, Mr, Shivraj Singh Chouhan announced that the Patalpani railway station in Indore to be renamed after Tantya Bhil.

- First Indian to be elected as a Fellow of Trinity College.
- His biography "The Man Who Knew Infinity: A Life of the Genius Ramanujan" was authored by Robert Kanigel and published in 1991.
- (2015) is based on his life.

## Atal Bihari Vajpayee

## About Atal Bihari Vajpayee (25 December 1924 - 16 August 2018)

- He was an Indian politician and statesman who served three terms as the 10th Prime Minister of India.

- he novel depicts the defeat and exile of 72 people, including Vengai Periya Udayanna Devar, the ruler of Sivaganga, and Duraisamy, son of Chinna Marudu, after the Kalayarkoil war June.
- Deporting people to an unknown island was called Kala Pani, also referred to as Theevanthira Thandanai
- The novel was published by Agani Publishers in 2020.
- The novel begins with the exile of the 72 people in a ship on February 11, 1802. They reached Penang after 62 days.

## 16th century Vijayanagara inscription near Tirupattur

- Vijayanagara inscription belonging to 16th century AD has been found near **Tirupattur**.
- The inscription has been found at Annandapatti near Tirupattur in the field study conducted by K. Mohan Gandhi, professor of Tamil Department of Sacred Heart College, and 'Kani Nilam' M. Munisamy.
- The inscription is engraved in 22 lines on the front side and 13 lines on the back side on a 3 feet high slab stone.
- This inscription was written during the reign of Vijayanagara king Venkatapati Deva Raya
- This inscription is written in a mix of both Tamil and Grantha script.
- This inscription glorifies Venkatapati Raya as Maha Mandaleshwaran and Rajathi Raja Raja Parameswaran.
  - This inscription mentions Tiruppettroor (Tirupathur) in Ail Nadu. Here Thiru means wealth.
  - Currently Tirupattur is a separate district. Tirupattur has been a prosperous town for the last 500 years.
  - There were 79 countries in Thondai Nadu. Ail Nadu is one of them.

#### **Exhibition at Israel Museum**

- A cultural event was organised at the Israel Museum where a new exhibition titled 'Body of Faith: Sculpture from the National Museum of India' was inaugurated.
- Recently, India and Israel celebrated the 30th anniversary of the establishment of full diplomatic relations.
- Body of Faith draws from three major epochs in the history of Indian sovereignties, namely, the Gupta dynasty (4th - 8th century CE), the mid-Chola dynasty (10th -12th century CE), and the Pala dynasty (8th - 12th century CE).
- Among the 14 sculptures of Hindu deities in bronze and stone, eight have been loaned from the National Museum and other six are taken from the Israel Museum's own collection.
- The loaned artefacts from the Indian National Museum include
  - Nataraja (12th Century, Chola period, in bronze)
  - Ganesha (13th century, Pala period, in stone)
  - Vishnu (11-12th century, Pala Period, in stone)

## India to help Sri Lanka to boost dairy production

- Sri Lanka to scale up its dairy production to become self-sufficient has sought technical assistance from India's National Dairy Development Board (NDDB) and market leader Amul.
- The assistance will revive a collaboration that Sri Lanka attempted in the late 1990s, but failed to take forward.
- The former president of Sri Lanka Chandrika Bandaranaike Kumaratunga invited India's "milk man" Verghese Kurien to set up the 'Kiriya' dairy project, named after the Sinhala word for milk.
- A \$20 million joint venture between the NDDB and Sri Lanka's MILCO was announced, but the project did not take off, in the wake of resistance from nationalist worker unions and powerful business lobbies in Sri Lanka.
- The UN World Food Programme (WFP) said that at least 56,000 children in Sri Lanka currently suffer from severe acute malnutrition.
- The severe acute malnutrition among children had increased to 1.4 per cent this year up from 1.1 per cent.

## First India-Central Asia meeting of **NSAs**

- The first India-Central Asia Meeting of the National Security Advisers was held in New Delhi
- The National Security Advisor (NSA) of India Ajit Doval presided over the meeting.
- This is the first time India is hosting a conclave of top security officials including the National Security Advisors (NSAs) from Central Asian countries including Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan focussing on the evolving security situation in Afghanistan and ways to deal with the threat of terrorism . Australia emanating from that country.

#### India - Australia ECTA comes into force

- Economic and Cooperation Trade Agreement (ECTA) provides an institutional mechanism to encourage and improve trade between India and Australia and covers almost all tariff lines dealt by the two countries.
- India-UAE After the Comprehensive Economic Partnership Agreement, ECTA will be the second trade agreement for India that will be operationalised in 2022.

#### Benefits of signing ECTA.

- Raise bilateral trade to USD 45-50 billion in next five years.
- Create an additional employment of at least 10 lakhs jobs in India.
- Create opportunities for investment, promotion of start-ups.

#### Key features of ECTA

- India will benefit from preferential market access provided by Australia on 100% of its tariff lines, including all labour-intensive sectors of export interest to India, such as Gems and Jewellery, Textiles, leather, footwear etc.
- has offered wide ranging commitments in several services sub-sectors like IT, ITES, Health, Education.
- A separate Annex on Pharmaceutical products which will enable fast-track approval for patented, generic and biosimilar medicines.
- Covers areas like Rules of Origin, Sanitary and Phytosanitary (SPS) measures, Dispute Settlement, Movement of Natural Persons etc.

## 2.2 PUBLIC AWARENESS & GENERAL ADMINISTRATION

## **Parliament passes Anti-Maritime Piracy** Bill

 Parliament passed the Anti-Maritime Piracy Bill. The Bill would provide an effective legal instrument to combat maritime piracy.

#### Key highlights of the bill

- Presently, India does not have a separate domestic legislation on piracy. Once enacted, the Bill will bring into law the UN Convention on the Law of the Sea (UNCLOS), (ratified by India)
- The Bill provides for stringent punishment to those convicted of such crimes.
- It will apply to all parts of the sea adjacent to and beyond Exclusive Economic Zone (EEZ) of India, i.e., beyond 200 nautical miles from the coastline.

- Defines piracy in accordance with UNCLOS.
- Empowers the Central government to make Rules on subjects such as powers of arrest, investigation and prosecution, designated court and its jurisdiction, and trial of the offenses by designated court.

#### Note

UNCLOS is an international agreement that establishes a legal framework for all marine and maritime activities. It was signed on 10 December 1982.

#### Winter Session 2022

The Winter Session of Parliament adjourned four working days ahead of its schedule, making it the 8th consecutive session to be adjourned ahead of schedule in the current Lok Sabha.

- According to the statistics published by the voluntary organization PRS Legislative, the number of parliamentary session days has decreased by half since the 1950s and 1960s.
- The winter session 2022 has been held for 13 days only.

#### **Highlights:**

- Lok Sabha functioned for 88% of scheduled time (of actual sitting days), while Rajya Sabha functioned for 94%.
- **Seven Bills** were passed in the Session.
- Two of these were introduced in the same session. So far, in the 17th Lok Sabha, 72% of the Bills (94 of 130) have been introduced and passed in the same session.

#### Note

- Adjournment sine die means terminating a sitting of Parliament for an indefinite period, that is, when the House is adjourned without naming a day for re-assembly.
- The power lies with the presiding officer of the House

## EC to begin delimitation exercise in **Assam**

- The Election Commission of India ECI has initiated the delimitation process for assembly and parliamentary constituencies in Assam, as per Section 8A of Representation of People Act (RPA), 1950.
- Last delimitation of constituencies in Assam was done on the basis of 1971 census figures.
- The process will be based on Census data from 2001
- As per Section 8A of the Representation of People's Act RPA 1950, the President can order a delimitation exercise to be carried out in four North East States (NES)-Arunachal Pradesh, Assam, Manipur and Nagaland.

#### Note

- Delimitation is the process of fixing limits or boundaries of territorial constituencies in a country or a state with a legislative body.
- The job of delimitation is assigned to the Delimitation Commission or a Boundary Commission.
- It has been constituted 4 times in 1952 under the Delimitation Commission Act, 1952, in

- 1963 under Delimitation Commission Act, 1962, in 1973 under Delimitation Act, 1972 and in 2002 under Delimitation Act, 2002.
- Its orders cannot be questioned before any court.
- A retired Judge of SC, Chief Members: Election Commissioner of India, State Election Commissioner (of respective state).

## Lokayukta Bill passed by Maharashtra **Assembly**

Maharashtra became the first state to pass a Lokayukta Bill that brings the Chief Minister of the state and the council of ministers under the ambit of the anti-corruption watchdog.

#### **Key Highlights**

- Under the new bill, the Lokayukta will have the power to recommend action based on its investigation and also be able to direct the state agencies to conduct further investigations.
- It will have all the powers of a civil court i.e. the power to summon government officials.
- The Lokayukta can initiate the investigation against the Chief Minister with the prior approval of the Assembly.

#### History

- The Lokayukta is the apex anti-corruption ombudsman that holds the power to investigate complaints and corruption allegations against government officials and lawmakers.
- Maharashtra is known as the first state to establish Lokayukta in 1971.

#### Note

- The **National Commission for Minorities** was set up under the National Commission for Minorities Act 1992.
  - In India, six religious communities have been notified as minority communities - Muslims, Sikhs, Buddhists, Christians, Zoroastrians and Jains.

## Minorities Rights Day

• The Day is observed on December 18 every year to create awareness among the people about the rights of minorities.

#### **Constitutional Provisions**

 Article 30(1) - Right of all religious and linguistic minorities to establish and administer educational institutions of their choice

 Article 30(2) – Freedom of minority-managed educational institutions from discrimination in the matter of receiving aid from the State.

### **National Consumer Day or Bhartiya Grahak Diwas**

 The Day is annually observed across India on December 24 to create awareness about consumer rights and responsibilities.

#### **About the Consumer Protection Act, 2019**

- The Consumer Protection Bill of 2019, was passed by Parliament in 2019.
- It replaced the Consumer Protection Act of
- Rights of the consumers recognised under the Act are
  - Right to information
  - · Right to protection against goods and services that can be dangerous to life and property.
  - Right to be protected from unfair or restrictive trade practices.
  - Right to access a variety of goods and

services at competitive prices.

• Right to redressal.

# 2.3 GOVT - WELFARE ORIENTED GOVT SCHEMES, THEIR UTILITY

### Medicine kit under Makkalai Thedi Maruthuvam scheme

 A total of 99.717 medicine kits in 15 zones under the Greater Chennai Corporation were distributed under the Makkalai Thedi Maruthuvam scheme.

#### About Makkalai Thedi Maruthuvam Scheme

- Launched by CM MK Stalin on 5th August 2022 in Samanapalli village in Krishnagiri district and 7 other districts (Thanjavur, Tiruchi, Tirunelveli, Coimbatore, Chennai, Salem and Madurai)
- The scheme will screen those above 45 years of age and others with infirmities through routine door-to-door check-ups and detect non-communicable diseases.
- The scheme will hinge on women public health workers, women health volunteers (WHVs),

physiotherapists and nurses, who will provide healthcare at the doorstep.

# Innuir Kappom - Nammai Kaakkum 48' **Scheme**

- 1.31 lakh people benefited under the Innuir Kappom - Nammai Kaakkum 48' Scheme.
  - 500 accident prone places in Tamil Nadu have been identified under the scheme.
  - The scheme is implemented through 679 hospitals (232 government hospitals, 447 private hospitals) located near those places.
  - The government spends up to Rs 1 lakh through the insurance scheme for treatment provided immediately within 48 hours of the accident.
  - So far 1,31,164 people have benefited under this scheme and Rs.116 crore has been spent.

# About 'Innuir Kappom - Nammai Kaakkum 48' Scheme

- The scheme was launched on December 18, 2021 in Melmaruvathur.
- The scheme aims to reduce the loss of life in road accidents by providing free treatment up to 48 hours after the accident in government and private hospitals
- The government will bear the cost of emergency medical treatment for two days for those injured in road accidents.

#### PM SVANidhi extended

 The Centre has extended the PM Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) scheme beyond till December 2024.

#### About PM SVANidhi

- PM SVANidhi is a Central Sector Scheme.
- It was launched with an objective to provide affordable working capital loan up to ₹10,000 to Street Vendors for facilitating resumption of their livelihoods adversely affected by the COVID-19 pandemic
- Targets to benefit over 50 lakh Street Vendors.
- Implementing partner Small **Industries** Development Bank of India (SIDBI).

# **Sanitation Workers' Development Schemes**

- Chief Minister M.K.Stalin inaugurated the Sanitation Workers' Development Scheme to protect the welfare of conservancy workers in the State.
- A mobile application was launched to help identify and collect census data of sanitation workers as part of the scheme.
- The scheme will be implemented on a pilot basis in select local bodies.
- Under the scheme, steps will be taken to
  - Ensure that the workers benefit from various government welfare schemes
  - Provide them the necessary training to gain skills essential in mechanised cleanliness drives Ensure that they get pension and insurance
  - Ensure that their children have access to proper education, among other measures

 The sanitation workers will also be encouraged to start alternative businesses and be supported in their endeavor through loans.

#### Cancer Cases on the rise in India

- Based on the data from the National Cancer Registry Program, the central government has announced in the Lok Sabha that the number of people suffering from cancer in the country will increase by 12.8 percent this year.
- The Rashtriya Arogya Nidhi (RAN) offers financial aid to low-income patients from families that are below the poverty line who have serious life-threatening illnesses and need medical care at one of the super specialty hospitals or institutes or other public hospitals.
- Under the Health Minister's Cancer Patient Fund (a component of RAN), Rs.216. 98 lakh was utilised for 40 beneficiaries as on December 5, 2022, in the 2022-23 fiscal.
- During the previous fiscal year, 64 beneficiaries received Rs.585.05 lakh, while 196 patients received Rs.1,573 lakh in 2020-21 and 470 patients received Rs.2,677.08 lakh in 2019-20.

- Cancer treatment under the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana.
- High-quality generic drugs at affordable price 20under Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP)
- Affordable Medicines and Reliable Implants for Treatment (AMRIT) pharmacy stores
  - Free or subsidized treatment in government hospitals
- Funding for poor patients through Rashtriya Arogya Nidhi (RAN)

# Infrastructural Development for Cancer **Treatment**

- Cancer Treatment Facilities in all 22 AIIMS Hospitals.
- Development of cancer treatment facilities in 13 State Government Medical Colleges-Hospitals.
- 20 Tertiary Cancer Care Centers (TCCCs)
- 19 State Cancer Institutes (SCIs)

 The establishment of the National Cancer Institute in Jhajjar (Haryana) and the second campus of the Chittaranjan National Cancer Institute in Kolkata

#### TB Elimination in India by 2025

- The National Tuberculosis Elimination Programme (NTEP), previously known as Revised National Tuberculosis Control Programme (RNTCP), aims to strategically reduce TB burden in India by 2025, five years ahead of the Sustainable Development Goals.
- In 2022, from January to October 20.16 lakh people were infected with TB (Tuberculosis) and 73,551 people died from the disease.
- According to the Global TB Report 2022, the incidence of TB in the country has decreased by 18 percent.
- In 2015, 256 out of 100,000 people in India were affected by the disease, while last year it was 210 out of 100,000.
- The central government plans to eliminate tuberculosis in the country by 2025 through measures such as state-district level program in areas where the incidence of tuberculosis is high. The screening for tuberculosis is done among weak and those suffering from other diseases.
- According to the statistics of the states, 1,864 primary health centers and 8,327 sub-health centers are functioning as Ayushman Bharat Health and Wellness Centers in the country.
- States and Union Territories have been directed to convert 1.50 lakh rural and urban primary health centers in the country into Ayushman Bharat Health and Wellness Centres.

#### Note

- TB is caused by a bacterium called Mycobacterium tuberculosis.
- Currently, two vaccines VPM (Vakzine) Projekt Management) 1002 and (Mycobacterium Indicus Pranii) have been developed and identified for TB which are under clinical trials.
- The World Tuberculosis (TB) Day is observed on 24th March every year.
- The Bacille Calmette-Guérin (BCG) vaccine is presently the sole vaccine available for the prevention of TB.

### PARAVAI Programme launched

- Greater Chennai City Police launched the PARAVAI (Personality and Attitude Reformation Assistance Venture Affirming Identity) programme.
- The programme focuses on the **reformation** of first time petty offenders in the 18--24 age group and their reintegration into society, thereby preventing them from turning to a life of crime.
- PARAVAI programme is a six stage process flow, wherein the young offenders are followed up on from the time they are arrested and lodged in the Saidapet sub jail and subsequently released on bail.
- The programme was offcially launched in April, 2022.
- The Neighbourhood Police Officers (NPOs) nominated for each Assistant Commissioner range are tasked with ensuring that the youth undergo the six¬ stage process.

#### Sanitary Napkin Scheme

- Under Nirbhaya Fund, Chennai corporation is to supply free sanitary napkins for corporation school students of classes VI-XII at a cost of Rs 4.67 crore
- Under the initiative 'Kanniyam' the sanitary napkins are distributed to promote menstrual hygiene management in corporation schools.
- Under the Nirbhaya Niti, Girl Child Safety Scheme in Chennai schools, a scheme to provide sanitary napkins to girl students from classes 6 to 12 was launched.
- Under this scheme, sanitary napkins will be provided to 25,474 girl students studying in Chennai Corporation schools.
- 20 sanitary napkins will be provided to the girl students every 2 months at the rate of 10 sanitary napkins per month.
- Under the scheme, 26.59 lakh sanitary napkins will be provided to schools in Chennai every year.

#### Note

 Nirbhaya Fund was an Indian rupee 10 billion corpus announced by the Government of India in its 2013 Union Budget.

• 'Nirbhaya Fund' for implementation of initiatives aimed at enhancing the safety and security for women in the country.

#### 'Namma School' scheme was launched

- TN Chief Minister MK Stalin launched the Namma School Foundation, an initiative of the school education department.
- The scheme aims to improve infrastructure facilities at government schools in the state ... by attracting investments via CSR (Corporate of social responsibility) Funds.
- The initiative aims at creating a web page for each school in which they could update details about teacher-student ratio, number of buildings, classrooms and lab facilities among others.
- This will help corporations and individuals (alumni) to identify the schools that need funds.
- In the first phase, details of 100 schools that are randomly selected will be uploaded on the page.

# TN launches mental health helpline and support forum for students

- Chief Minister M.K. Stalin launched the MaNaM Initiative (Mananala Nallaadharavu Mandram - Mind Health Support Forum).
- The forums will be created in all the medical colleges to offer government counseling programmes to improve students' mental health.
- The programme will be extended to all colleges and schools.
- The helpline 14416 was also introduced to reach out to psychiatrists at government medical colleges.

# Cabinet approves distribution of free food grain till December 2023

 The Cabinet approved the decision to make distribution of ration free for 81.3 crore poor for one year under National Food Security Act, 2013.

#### About NFSA, 2013

 The National Food Security Act (NFSA) 2013 was passed on July 5, 2013

- Upto 75% of the rural population, as well as 50% of the urban population, are legally entitled to receive subsidised food grains through the Targeted Public Distribution System
- Schemes such as the Mid-Day Meal Scheme (MDMS), the Public Distribution System (PDS), and the Integrated Child Development **Services (ICDS)** are included under the Act.
- The Act covers two-thirds of the entire population under two categories beneficiaries:
  - Antyodaya Anna Yojana (AAY) households
  - Priority Households (PHH)
- The Act entitles 35 kg of food grains per AAY Household per month, whereas 5 Kg of foodgrain per PHH Person per month.

- Meanwhile, the government decided not to extend the free ration scheme Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY).
- PMGKAY was launched during the lockdown in April 2020, and was scheduled to end on December 31, 2022.
- Under PMGKAY, five kg of foodgrains were distributed for free for the poor were distributed for 28 months.

# Mental health helpline receives 20k calls in two months

- The International Institute of Information Technology Bangalore (IIITB) reported that Tele Mental Health Assistance and Networking Across States (MANAS) toll free **24/7 number (14416)** received over 20,000 calls since its launch.
- The **Top five States/UTs** from where maximum number of calls were received are
  - Tamil Nadu 3,631
  - Maharashtra 2,125
  - Madhya Pradesh 1,892
  - Jammu and Kashmir 1,338
  - Telangana 1,056

#### About Tele - MANAS

- An initiative of the **Health Ministry**.
- Launched on October 10 on World Mental Health Day.

- The initiative aims to open at least one Tele-MANAS cell in each State/U.T.
- National Institute of Mental Health and Neuro Sciences (NIMHANS) was appointed as the nodal center for the helpline
- IIITB has been providing technical support for the initiative.
- It is based on the Karnataka government's e-Manas service, which was launched during the first wave of COVID-19.

### e-HRMS (Electronic- Human Resource Management System)

- Revamped e-HRMS 2.0 Portal was launched by the Department of Personnel and Training (DoPT).
- e-HRMS was introduced by DoPT to facilitate a digital working environment, and streamline Human Resource services for Government employees.
- Revamped portal was launched because the e-HRMS launched earlier was limited in scope, where employees could avail limited services and it was not connected with other HR applications.
- Revamped e-HRMS 2.0 is the first digital system in Government of India to provide end-to-end HR Services.
- It will also save several thousand man-hours and tonnes of printing paper.

# Amrit Bharat Station Scheme (ABSC)

- Indian Railways is planning to modernise 1,000 small yet important stations under ABSC.
- It aims to identify developing cities with potential and envisage railway stations as city centres that would link not just various parts of the city but also between different cities in future.
- Modernisation of stations will be done in a cost-effective manner and a special fund will also be armarked with divisional railway managers (DRMs).
- Redevelopment will be done under "Khurda (Station in Odisha) model of redevelopment".

# National Mobile Monitoring System (NMMS)

 Centre has made digital capturing of MGNREGA attendance universal from January 1, 2023 through NMMS.  Capturing of attendance through NMMS is compulsory at worksites where 20 or more workers are employed under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGREGS).

#### About NMMS

- It is a mobile application which was launched by the Ministry of Rural Development in 2021.
- It aims to bring more transparency, and ensure proper monitoring of schemes.
- It permits taking real time attendance of workers at MGREGS worksites along with geo-tagged photographs.

# 2 key initiatives to upgrade Urban Rejuvenation

- The Ministry of Housing and Urban Affairs launches 2 key initiatives - 'City Finance Rankings, 2022' and 'City Beauty Competition' to upgrade India's Urban Rejuvenation journey to next level.
- City Finance Rankings
- Launched to evaluate, recognize and reward ULBs on the basis of their strength across key financial parameters.
- The rankings aim to motivate city/state officials and decision makers to implement municipal finance reforms.
- The participating ULBs will be evaluated on 15 indicators across three key municipal finance assessment parameters, namely:
  - Resource Mobilization
  - Expenditure Performance
  - Fiscal Governance.

#### City Beauty Competition

- Aims to encourage and recognize the transformational efforts made by cities and wards in India to create beautiful, innovative and inclusive public spaces.
- Wards and public places of cities would be judged against the five broad pillars
- accessibility
- amenities
- activities
- aesthetics and
- ecology

#### **One District One Product Scheme**

- The Ministry of Commerce and Industry informed that ODOP initiative is operationally merged with 'Districts as Exports Hub (DEH)' initiative.
- ODOP initiative is aimed at fostering balanced regional development across all districts of the country.
- It focuses on the district as a unit for converting into a manufacturing and export hub by identifying products with export potential in the district.
- ODOP was launched by the Ministry of Food Processing Industries.
- Under the 'Districts as Export Hubs Initiative', products and services (including GI products, agricultural clusters, toy clusters etc.) with export potential have been identified in all districts of the country in consultation with the stakeholders including the States/UTs.

# Government to turn 36,428 villages as 'model tribal villages'

- The Union Ministry of Tribal Affairs planning to develop 36,428 villages with at least 50% tribal population and 500 STs across the country into 'model tribal' villages.
- The efforts were part of the existing **Special** Central Assistance to Tribal Sub Scheme (SCA to TSS), which has now been renamed to the Pradhan Mantri Adi Adarsh Gram Yojna (PMAAGY), for implementation from 2021-22 to 2025-26.
- The project will cover as many as 4.22 crore tribal people in the country, which comprises around 40% of the total ST popular tion in India.

# 3.1 POLICY ON ENVIRONMENT AND ECOLOGY

#### Himalayan medicinal plant species

- Three Himalayan medicinal plant species have been added to the IUCN Red List.
- Meizotropis pellita (Critically Endangered): Endemic to Uttarakhand. Oil extracted from leaves possesses strong antioxidants and can be a natural substitute for synthetic antioxidants in pharmaceutical industries.
- Fritilloria cirrhosa (Vulnerable): Used in treatment of bronchial disorders and pneumonia.
- Dactylorhiza hatagirea (Endangered): Used in Ayurveda, Siddha, Unani, and other alternative systems of medicine to cure fever, cough etc.

#### **About IUCN**

- The International Union for Conservation of Nature is an international organization working in the field of nature conservation and sustainable use of natural resources.
- Formation October 5, 1948
- Headquarters Gland, Switzerland

# Single window system for Green Initiative

- A single window system will be used to approve green initiatives through 'Guidance TN' in the State.
- It will play a major role in making Tamil Nadu a trillion dollar economy by 2030.
- Tamil Nadu is focusing on climate literacy to create awareness on climate change among school and college students.
- The government planned to raise Rs.1,000 crore towards a Green Climate Fund, and the State government had contributed Rs.100 crore to it.

• A Climate Change Mission was also launched.

#### **About Guidance TN**

- Guidance Tamil Nadu (formerly Tamil Nadu Industrial Guidance and Export Promotion Bureau) is the investment promotion agency of the Government of Tamil Nadu.
- It is constituted to reach out to prospective investors and make them invest in the state of Tamil Nadu.

#### **About Climate Change Mission**

- The Mission aims to protect the natural resources in the state besides restoring them on a long-term basis.
- The mission will ensure that the state shall achieve carbon neutrality much ahead of the 2070 target set by India.
- The state is first to launch its own Climate Change Mission to make Tamil Nadu a climate smart state.

# TN allows quarrying near reserve forest

- TN government has rescinded the prohibition of quarrying and mining activities within one kilometre radius of reserve forests.
- As per a government order issued by Industries, Investment Promotion and Commerce Department in 2021, prohibition of mining, quarrying and crushing activities within one kilometre radial distance from the boundaries of Reserve Forests were prohibited
- Based on this, an amendment has been made in Tamil Nadu Minor Mineral Concession Rules, 1959 which removed 'reserve forests' from the line "national parks, wildlife sanctuaries, tiger reserves, elephant corridors and reserve forests".

#### **Invasive mussel in Ennore and Pulicat**

- Mytella strigata or Charru mussels is an invasive mussel species native to South America.
- The species is spreading in the coastal waters of Tamil Nadu and Kerala due to the discharge of ballast waters from ships visiting the ports of Kattupalli and Ennore.
- The South American Mussel is locally known as kakka aazhi.
- Its spread is threatening the existence of the locally prevalent yellow clams (manja matti) and green mussels (pachai aazhi).

# Nilgiri Tahr conservation project launched

- The Tamil Nadu government launched an initiative for the conservation of the Nilgiri **Tahr** at a cost of Rs.25.14 crore.
- Nilgiri Tahr is designated as the State animal of Tamil Nadu in recognition of its ecological and cultural significance.
- Under the Nilgiri Tahr project, the government plans to
  - Develop a better understanding of the Nilgiri Tahr population through surveys and radio telemetry studies
  - Reintroduce the Tahrs to their historical habitat
  - Address proximate threats
  - Increase public awareness of the species.
- The project is to be implemented from 2022 to 2027.
- The funds for the project are to be provided by the Tamil Nadu Pollution Control Board.
- The Government announced that October 7 will be celebrated as 'Nilgiri Tahr Day' in honour of E.R.C. Davidar, who was responsible for pioneering one of the first studies of the species in 1975.

### Challenges in the conservation of the Nilgiri **Tahrs**

- Potential local extinction due to highly fragmented populations
- Invasion of exotic species into the habitat
- Forest fires

- Overexploitation of forest resources
- Lack of ecological data and understanding.

#### **Historical References**

- References are found in Tamil Sangam literature dating back to 2,000 years with reference to Nilgiri Tahr.
- The late Mesolithic (10,0004,000 BC) paintings highlight the significance of the Tahr in folklore, culture and life.

#### About Nilgiri Tahr

- It is an endangered species and the sole Caprinae species found in the tropical mountains of southern India.
- The animal inhabits meadows with steep cliffs at elevations between 300 metres and 2,600 metre above sea level.
- It is estimated that there are 3,122 Nilgiri **Tahrs** in the wild.
- Found mostly in Western Ghats (around Kerala and Tamil Nadu)
- It has become locally extinct in around 14% of its traditional shola forest grassland habitat.

# U.N. recognises Ganga project among 10 initiatives restoring natural world

- The 10 global environmental initiatives which aim to restore more than 68 million hectares including Ganges River Rejuvenation project from India were declared as World Restoration Flagships, under the banner of the United Nations Decade on Ecosystem Restoration.
- United Nations Decade on Ecosystem Restoration is a global movement coordinated the UN Environment **Programme** (UNEP) and the UN Food and Agriculture Organisation (FAO).
- was launched in 2014 as Namami Ganga Initiative.

# About The Ganges River Rejuvenation project

 Namami Gange Programme', is an Integrated Conservation Mission, approved as 'Flagship Programme' by the Union Government in June 2014 with budget outlay of Rs.20,000 Crore to accomplish the twin objectives of effective abatement of pollution, conservation

and rejuvenation of National River Ganga.

- Main pillars of the Namami Gange Programme are:-
  - Sewerage Treatment Infrastructure
  - River-Front Development
  - River-Surface Cleaning
  - Biodiversity
  - Afforestation
  - Public Awareness

# First ever butterfly survey conducted in Mudumalai reserve

- The first Butterfly Survey was conducted at the Mudumalai Tiger Reserve (MTR) (688.5sq.km)
- The survey was conducted by the TN Forest Department with the assistance of the Nature and Butterfly Society (TNBS), Coimbatore and the Worldwide Fund for Nature (WWF-India).
- The survey revealed that MTR is home to 175 species of butterflies.

# 4.1 NEW ECONOMIC POLICY AND GOVERNMENT SECTOR

# GST Council keeps tax rate same, but defers key reforms

- The Goods and Services Tax (GST) Council met over video conference under the chairmanship of Union Finance Minister Nirmala Sitharaman
- Important decisions taken at the council
  - Decision to scrap the 5% GST levy on a cattle feed ingredient — husk of pulses
  - Reduction of the levy on ethyl alcohol used by refineries to blend with petrol to 5% from 18%
  - Extending the 5% tax levy for ethyl alcohol, allowed for oil marketing companies to blend with petrol, to refineries will further reduce our dependence on imported crude and save the foreign exchange.
  - Decriminalisation of petty GST offenses.
  - Doubling of threshold limits of tax amounts for initiating prosecution from Rs.1 crore to Rs.2 crore for all offences other than those involving fake invoices.
  - The compounding amount under certain offenses has been reduced from 50% to 150% of the amount, to 25% to 100% of the amount involved
- However, the decisions would take time to implement as States would have to amend their respective GST legislations, while the Centre would include these changes in the Finance Bill of 2023-24.

#### **About GST:**

 GST was launched on July 1, 2017 through 101st Constitution Amendment Act, 2016 by amending the Artcile 279A

- GST had replaced the old Indirect tax regime in India
- It was introduced with the idea of "One Nation-One Market-One Tax".
- 2022 marks the Fifth Anniversary of GST.
- GST is an indirect, multi-stage, consumptionbased tax system. It subsumes several domestic indirect taxes like service tax, purchase tax, value-added tax, excise duty, and others under one head.
- It does not include Petroleum, Liquor, and stamp duty.
  - The Three taxes application under the GST are CGST (Central) SGST (State) and IGST (integrated)
- The Four tax slabs are 5%, 12%, 18%, 28%.

#### **About GST Council**

- It is a constitutional body for making recommendations to the Union and State Government on issues related to Goods and Service Tax.
- It is chaired by the Union Finance Minister and other members are the Union State Minister of Revenue or Finance and Ministers in-charge of Finance or Taxation of all the States.

# 4.2 CURRENT TRENDS IN INDIAN ECONOMY

# GDP growth dips to 6.3% as manufacturing slides

- Manufacturing and mining output contracted year on year in the July - September quarter, dragging Gross Value Added growth to a slower than expected 5.6%, which together with high inflation and weak exports combined to slow overall Gross Domestic Product (GDP) growth to a 6.3% pace, as per estimates released by the National Statistical Once.
- The April to June quarter of 2022 fiscal had witnessed GDP growth of 13.5%, with GVA expanding 12.7%.

#### November GST revenues rise 11%

- India's gross GST revenues were ₹1,45,867 crore in November 2022, 11% higher than a year ago, but nearly 4% below October's collection.
- Revenues from import of goods were 20% higher while domestic transactions, including import of services, yielded 8% higher taxes than November 2021.
- State GST collections in November accounted for ₹32,651 crore of revenues, while the Integrated GST was ₹77,103 crore, including 38,635 crore col¬lected on import of goods. 21
- GST Compensation Cess collections were at ₹10,433 crore, factoring in ₹817 crore collected on import of goods – marginally lower than the ₹10,505 crore collected in October 2022.
- Six States recorded a contraction in revenues in November, including Gujarat, Rajasthan and Kerala (-2%), Punjab (-10%), Himachal Pradesh (-12%) and Goa (-14%).

# World Bank raises India's growth projection to 6.9%

- The World Bank has released the India Development Report titled 'Navigating the Storm'.
- The World Bank raised its gross domestic product (GDP) growth forecast for India during the current financial year (FY23) to 6.9 per cent from 6.5 percent, citing the economy's relative resilience to external headwinds, and a strong out-turn in the second quarter of the current financial year.
- After three downgrades in its 2022¬-23 GDP growth estimates, Bank reverses course, citing strong Q2 growth and strong demand at start of Q3; report lauds strong macroeconomic fundamentals.
- Previously, the World Bank had cut India's FY23 GDP forecast to 6.5 per cent from 7.5 per cent in October 2022, which came in the wake of a series of growth downgrades by rating agencies, investment banks and other multilateral institutions.

# RBI increase reporate 35 bps

 India (RBI) raised the policy repo rate by 35 basis points (bps) to 6.25%, downshifting gears from consecutive increases of 50 bps, and scaled down GDP growth hopes for the year to 6.8% from 7%.

- A 100 basis points equals one percentage point.
- The central bank retained its inflation projection for 20227-23 at 6.7%, noting that inflation will ease but stay well above the 6% upper tolerance limit set for the RBI.

#### **First Payment Gateway to support** Credit cards on UPI

- Razorpay becomes India's First Payment Gateway to support credit cards on Unified Payments Interface (UPI)
- Razorpay in partnership with Axis Bank announced its readiness to support Credit Card Transactions on UPI.
- Earlier, Reserve Bank of India (RBI) announced the linking of RuPay credit cards to BHIM (Bharat Interface for Money) UPI app.
- BHIM is a payment app that allows simple, easy and quick transactions through UPI.
- Benefits: No need to carry credit cards for payments, strengthen digital payments and boost India's credit penetration.
- Currently, only 6% Indians have access to credit cards.
- In a similar development, RBI will introduce 'single-block-and-multiple debits' feature on UPI platform.
- Under this, customers will create payment mandates against a merchant by blocking funds in their bank account for specific purposes which can be debited, whenever needed.
- Benefits: Improve ease of making payments for online shopping, build trust among consumers etc.
- RBI also announced an expansion of Bharat Bill Payment System (BBPS) to include all payments and collections.
- BBPS is a one-stop ecosystem for all recurring bills with multiple features (see image).

#### **About UPI**

- UPI is a real-time payment system, launched in 2016 by National Payments Corporation of India (NPCI). It links multiple bank accounts into a single mobile application
- NPCI is an initiative of RBI and Indian Banks Association under Payment and Settlement Systems Act (2007). It is an umbrella organization for operating retail payments and settlement systems in India.

# Remission of Duties and Taxes on Exported Products (RoDTEP) Scheme

- The RoDTEP scheme has been extended to chemicals, pharma, iron & steel. The RoDTEP scheme is under the Ministry of Commerce and Industry.
- It refunds exporters the embedded duties/ taxes that are not rebated under other schemes. This includes VAT on fuel used in transportation, mandi tax, duty and electricity used during manufacturing.
- The RoDTEP scheme replaces the earlier Merchandise Export from India Scheme (MEIS) which violated provisions of WTO by giving export subsidies for a wide range of goods.

### Wholesale price inflation fell to 5.85% in November

- According to the data released by the Ministry of Commerce and Industry, India's wholesale inflation measured by the wholesale price index (WPI) eased to a 21-month low of 5.85 per cent in November from 8.39 per cent in September.
- The decline in rate of inflation in November, 2022 is primarily contributed by fall in prices of food articles, basic metals, textiles, chemicals & chemical products and paper paper products as compared to the corresponding month of the previous year.

#### Note

 Wholesale Price Index (WPI) represents the price of goods at a wholesale stage i.e. goods

that are sold in bulk and traded between organizations instead of consumers. WPI is used as a measure of inflation in some economies.

 India uses Consumer Price Index (CPI) to measure inflation.

# India's direct tax collection grows 26% to ₹13.63 lakh cr for FY23

- According to the Income Tax Department of India, India's gross direct tax collections for the financial year 2022-23 have registered a growth of 25.90%.
- The gross collection stands at ₹13,63,649 crore as of 17 December 2022. Last year, in the corresponding period it was at ₹10,83,150 crore.
- The Budget had estimated a direct tax collection of ₹14.20 lakh crore this financial year, higher than the ₹14.10 lakh crore collected last fiscal (2021-22).
- The largest share in Net Direct Tax collection is of Corporation Tax then Personal Income Tax (PIT) including Security Transaction Tax (STT) constitutes the rest.

#### Note

• A direct tax is a tax that a person or organization pays directly to the entity that imposed it. Example: income tax, real property tax, personal property tax, or taxes on assets.

# \$13 bn FDI in non-conventional energy sector

- India's Domestic non-conventional energy sector has received over USD 13 billion through Foreign Direct Investment (FDI) route in the last 22 years.
- 100 percent FDI through automatic route is allowed for the promotion of solar power generation in the country.
- Non-conventional sources of energy include solar, wind and other renewable sources.
- As per the country-wise details of FDI/ equity inflow during the period April, 2000 to September, 2022, India received USD 13.034 billion as offshore investment.
- The top contributor is Mauritius, followed by the United Kingdom, Singapore, Netherland and UAE.

# 4.3 REPORTS AND INDICES

# **Climate Investment Opportunities in** India's Cooling Sector

• The report titled, "Climate investment opportunities in India's cooling sector" was released by the World Bank.

# **Key Highlights of the Report**

- From 2030, 160 million to 200 million people will be exposed to lethal heat waves in India every year, and nearly 34 million Indians will face **job losses due to heat stress** related productivity decline.
- By 2037, the demand for cooling is likely to be eight times more than the current level.
- India should deploy alternative and innovative energy efficient technologies for keeping spaces cool which could open an investment opportunity of \$1.6 trillion by besides reducing greenhouse gas emissions significantly and creating 3.7 million jobs.

- There will be a demand for a new air conditioner every 15 seconds in the coming years.
- The report proposes a road map to support New Delhi's India Cooling Action Plan (ICAP), 2019, through new investments in three major sectors: building construction, cold chains and refrigerants.
- It proposed enacting a policy for "district **cooling**". District cooling technologies generate chilled water in a central plant which is then distributed to buildings via underground insulated pipes. This brings down the cost for providing cooling to individual buildings.

#### Global Wage Report 2022-23

 Report, by International Labour Organisation (ILO), presents an analysis of how concurrent crises - COVID-19 pandemic followed by cost-of-living crisis - have impacted wages and purchasing power across countries and regions.

#### Key highlights of the Report

- Rising inflation is causing real wage growth to dip into negative figures in many countries thereby reducing purchasing power.
- On average, Wage employees lost six weeks of wages due to COVID-19 crisis.
- Low wage earners, workers in the informal economy and women wage earners group suffered most.

# India Inequality Report 2022 : Digital Divide released by OXFAM India

- It is an annual report to highlight ongoing inequality crises in the country.
- The 2022 report highlights the extent of digital divide in India and its impact on essential services such as education, health and financial inclusion.
- Oxfam India is a non-profit organization working support child education, empowering women & fighting against inequality in India.

### Key highlights of report

- 61% of men owned mobile phones in 2021, compared to just 31% women.
- Only 31% of the rural population uses the Internet compared to 67% of their urban counterparts.
- Use of computer devices has decreased (post-COVID) in rural areas. Likelihood of a digital payment by the richest 60% is four times more than the poorest 40% individuals, households, businesses
- Maharashtra has the highest internet penetration, while Bihar has the lowest.

# Recommendations to bridge digital divide

 Improve internet availability in rural and hardto-reach areas through community networks and public Wi-Fi/ internet access points.

- Government needs to improve affordability by investing in digital infrastructure, bringing a strong regulatory framework and lowering taxes on computers and phones.
- Conduct digital literacy camps, especially in rural India, and digitize panchayats and schools.
- Grievance redressal mechanism to handle EdTech and Healthtech related complaints.

#### Note

- Digital divide refers to "the gap between and geographic areas at different socio-economic levels with regard to both their opportunities to access information and communication technologies (ICTS) and to their use of the internet for a wide variety of activities.
- This is different from the State of Inequality in India Report released by the Economic Advisory Council to the Prime Minister (EAC-PM).

### Renewable Energy (RE) Report 2022

 Report was released by International Energy Association (IEA).

#### Key findings of the report

- RE will comprise 90 percent of global electricity capacity expansion in next five years and much of it will be in India.
- RE's installed power capacity addition will grow to 2,400 gigawatts (GW) between 2022 and 2027.
- With addition of 145 GW, India is forecast to almost double its renewable power capacity over 2022-2027.
  - Solar photovoltaic accounts for three-quarters of this growth, followed by onshore wind (15 percent) and hydropower providing rest of it.

# World Bank's Report released

The World Bank's flagship "Toolkit on **Enabling Gender Responsive Urban Mobility** and Public Spaces in India" was released.

- This toolkit will bridge knowledge gaps policy making and between implementation for gender-responsive urban mobility and public space in India.
- details It four-pillar implementation framework for urban bodies
  - Assess the Ground Situation
  - Strengthen planning and policies
  - Build Capacity and Raise Awareness
  - Improve Infrastructure and Services
- Need for gender-responsive urban mobility
  - Women are amongst the biggest users of public transport across Indian cities.
  - On average, 45.4% women walked to work compared to 27.4% men.
  - · Lower income groups have higher usage of public transport.
  - · Urban mobility systems are often not designed to account for gender-based differences in mobility patterns. Lack of safe public transport deters women from accessing promising opportunities.
  - It also deters women from stepping out, creating a vicious cycle that lowers their presence in public spaces.
- **Initiatives** taken to gender-responsive urban mobility
  - Integrated Sustainable Urban Transport Systems for Smart Cities (SMART-SUT) focus on improving transportation systems and integrating social and gender equity solutions.
  - Delhi Government has made public transport free for women in the national capital.
  - Kerala's all women cab service 'She taxi'.
- Recommendations
  - Introduce digital ticketing systems and common mobility cards.
  - Introduce a text-based SOS system to indicate distress and awareness campaigns for popularising helpline numbers.

# **World Malaria Report 2022**

 The report was published by the World Health Organization (WHO).

- According to the report, the COVID-19 pandemic has disrupted attempts to control malaria, resulting in 63,000 more deaths and 13 million more infections globally over the last two years.
- The report offers in-depth information on the latest trends in malaria control and elimination at global, regional and country levels.
- The report highlights progress towards global targets and describes opportunities and challenges for curbing and eliminating the disease.

#### Key highlights of the Report

- Malarial Deaths : High-burden malaria countries maintained a strong fight against the disease in 2021 despite the Covid-19 pandemic, with cases and deaths stabilising.
- While deaths came down to 619,000 in 2021 from 625,000 in the first year of the pandemic, it remained higher than the pre-pandemic level of 568,000 deaths in 2019.

#### Trend of Malaria Cases

- As for Malaria cases, the upward trend continued but at a slower rate - 247 million cases in 2021, compared to 245 million cases in 2020 and 232 million in 2019.
- Among the 11 high-burden countries, five - the Democratic Republic of the Congo, Ghana, India, Niger and the United Republic of Tanzania - recorded a decline in deaths.

# Report by Confederation of Indian Industry (CII) and KPMG.

- The report titled 'Metaverse and web 3.0 opportunities in India - Nurturing Tamil Nadu's growth ambitions through nextgen technologies' was released by the Confederation of Indian Industry (CII) and KPMG.
- According to the report, a thriving and a vibrant culture has been noticed across the broad spectrum of new age technologies, including Metaverse, Web 3.0, Blockchain and others in Tamil Nadu.

- The report pointed out that all major Information Technology (IT) companies in Tamil Nadu are focusing on Metaverse and Web 3.0 technologies via metaverse design, development, testing and support services.
- Metaverse, Web 3.0 and related technologies will help propel the overall GSDP of the state and help Tamil Nadu achieve its target to become a \$1 trillion economy by 2030.

#### Note

- The i-Tamil Nadu Technology (iTNT) hub, India's first Emerging and DeepTech Innovation Network, is expected to be launched in early 2023.
- Metaverse is a hypothetical iteration of the **Internet** as a single, universal and immersive virtual world that is facilitated by the use of virtual reality and augmented reality headsets.
- Web 3.0 Technology is an idea for a new iteration of the World Wide Web which incorporates concepts such as decentralization, blockchain technologies, and token-based economics.

# **Ease of Living Index 2022**

- Ease of Living Index of Indian cities is published every year by the Union Ministry of Housing and Urban Governance.
- The EoL is an assessment by the ministry based on the quality of life, economic ability of a city and its sustainability and resilience and the municipal performance index (MPI) to assess the performance of various cities.
- The assessment also incorporates residents' views on the services provided by the administration through a Citizen Perception Survey. The Greater Chennai Corporation (GCC) urged people to take part in the Ease of Living 2022 (EoL), a citizen perception survey and ensure that Chennai emerges on top of other Indian cities.
- Citizens can provide feedback on the cities they live in at https://eol2022.org/ CitizenFeedback%2c.

- Public feedback will help the Corporation to know where it is lagging and improve its management and it will play an important role in helping Chennai in the 2022 national rankings.
- It has been informed that Rs.5,000,000 prize money will be given to the person who shares the most posts related to Chennai Corporation and Chennai Smart City.

#### Global Wage 2022-2023 Report

- The report "Global Wage Report 2022-23: The impact of COVID-19 and inflation on wages and purchasing power" was released by the International Labour Organisation (ILO)
- According to the report, it is estimated that the global monthly wages fell in real terms to minus 0.9 percent (-0.9%) in the first half of 2022.
- This is the first time in a century that the real global wage growth has been negative.
- In Asia and the Pacific, real wage growth increased to 3.5% in 2021 and slowed down in the first half of 2022 to 1.3%.

#### **Key Findings:**

- Among advanced G20 countries, real wages in the first half of 2022 are estimated to have declined to minus 2.2% and the real wages in emerging G20 countries grew by 0.8%, 2.6% less than in 2019.
- The rising inflation has a greater impact on the cost of living on low income earners because they spend most of their disposable income on essential goods and services.
- Inflation also affects the purchasing power of minimum wages.
- The reports highlight the need to apply welldesigned policy measures to maintain the purchasing power and living standards of wage workers and their families.

- In 2015 WHO launched the Global Action Plan to tackle AMR (GAP-AMR). The goal of GAP-**AMR** is to foster Antimicrobial Resistance (AMR) surveillance and inform strategies to contain AMR.
- The report summarises global AMR and Antimicrobial Consumption (AMC) data to date.
- The report shows high levels (above 50%) of resistance were reported in bacteria frequently.

- AMR occurs when bacteria, viruses, fungi and parasites change over time and no longer respond to medicines making infections harder to treat.
- Government of India has taken following initiatives increase to awareness about antibiotics misuse:
- ICMR (Indian Council of Medical Research) has initiated antibiotic stewardship program (AMSP) on a pilot project basis in 20 tertiary care hospitals across India to control misuse

- and overuse of antibiotics in hospital wards and ICUs.
- ICMR worked in collaboration with Indian Council of Agriculture Research, Department of Animal Husbandry, Dairy and Fisheries and the DCGI to ban use of Colistin as growth promoter in animal feed in poultry.
- National action plan on containment of Antimicrobial Resistance (NAP-AMR) focusing on One Health approach was launched in April 2017.
- AMR Surveillance Network: ICMR AMR surveillance and research network (AMRSN) comprising 30 tertiary care hospitals, both private and government, to generate evidence and capture trends and patterns of drug resistant infections in the country.
- AMR Research & International Collaboration: **ICMR** develops new drugs/medicines through international collaborations in order to strengthen medical research in AMR.

### Social Progress Index (SPI) for States and Districts

- Social Progress Index (SPI) for States and Districts is prepared by the Institute for Competitiveness and Social **Progress** Imperative.
- SPI measures a country's social progress at the The index has been developed with the national and sub-national levels (district and local level)
- The index assesses states and districts based on 12 components across three critical dimensions of social progress - Basic Human Foundations of Wellbeing, Needs, Opportunity.
- The index uses 89 indicators at the state level and 49 at the district level.
- Based on the SPI scores, states and districts have been ranked under six tiers of social progress
- The tiers are
  - Tier 1: Very High Social Progress
  - Tier 2: High Social Progress

- Tier 3: Upper Middle Social Progress
- Tier 4: Lower Middle Social Progress
- Tier 5: Low Social Progress
- Tier 6: Very Low Social Progress.

#### IGX launches India's First Gas Price Index

- The Indian Gas Exchange (IGX) launched GIXI which is the first ever, nationwide price index to reflect benchmark natural gas prices for India.
- purpose to derive a single price for the country in line with international benchmarks.
- The Price Index was introduced in line with the Central Government's vision of achieving 15% share of natural gas in India's energy mix. Established in 2020, the IGX is India's first automated national-level gas exchange for the physical delivery of natural gas.
- The gas trade takes place at multiple delivery points, such as - Dahej, Hazira, Ankot, Mhaskal, Bhadhbhut, Dabhol, KG Basin, and Gadimoga. It covers six regional gas hubs, namely, the western hub, southern hub, eastern hub, central hub, northern hub, and northeastern hub across India.

# Financial Stability Report (FSR) released by RBI

- FSR is a bi-annual report that reflects risks to financial stability and the resilience of the Indian financial system.
- Based on the inputs from all financial sector regulators, it reflects the overall evaluation of the Sub Committee of Financial Stability and Development Council.

#### Key highlights of the Report

- Gross non-performing asset (GNPA) ratio of scheduled commercial banks (SCBs) fell to a seven-year low of 5.0%
- Net NPA (Non Performing Assets) have dropped to ten-year low of 1.3% in September 2022.
- Buoyant demand for bank credit and early signs of a revival in the investment cycle.

#### Note

• Global Financial Stability Report is released by the International Monetary Fund.

# RBI releases Report on Trend and Progress of Banking in India 2021-22

- The report is a statutory publication in compliance with Banking Regulation Act, 1949.
- The report presents the performance of the banking sector, including co-operative banks and non-banking financial institutions.

### Key Highlights of report

- Consolidated balance sheet of Scheduled Commercial Banks (SCBs) registered double digit growth in 2021-22, after a gap of seven years.
- Gross non-performing assets (GNPA) ratio of SCBs has declined from 9 percent in 2017-18 to 5.8 percent at end-March 2022.
- Financial performance of urban co-operative banks showed improvement.

- Non-banking financial company (NBFC) sector improved in 2021-22. With strong capital buffers, adequate provisions, and sufficient liquidity,
- The reasons for declining NPA include Loan write-off by PSBs (public sector banks) Upgradation of loans in PVBs (private banks), reduced Share of large borrowings

### Road accidents in India 2021 report

 It is an annual report based on parameters of road accidents like the number of accidents, fatalities, fatal accidents, injuries, etc. by the ministry of road transport and highways

#### **Key Highlights**

- Road accidents decreased by 8.1 % and injuries decreased by 14.8 % in 2021 compared to 2019.
- Fatalities, however, on accounts of road accidents increased by 1.9 percent in 2021 corresponding to the same period in 2019.
- In 2020, there is an unprecedented decrease in accidents, fatalities, and injuries due to the COVID-19 pandemic.
- Uttar Pradesh accounted for the largest share of fatalities at 13.8% followed by Tamil Nadu (10%).

### Initiatives for road safety

- The Road Safety Programme funded by the World Bank for capacity building of states.
- Integrated Road Accident Database (iRAD) system for analysis of road accidents data to enhance road safety.
- National Road Safety Board under Motor Vehicles (Amendment) Act, 2019.
- Scheme for District Driving Training Centres.
- Awards for outstanding work in the field of Road Safety.
- India is a signatory to Brasilia Declaration on Road Safety (2015).

# 4.4 MONEY & BANKING

# Reserve Bank of India (RBI) launched Retail Digital Rupee

- RBI released the central bank digital currency (CBDC)- digital rupee or e-rupee - for retail customers and merchants.
- Earlier, RBI launched digital rupee in the wholesale segment to settle secondary market transactions in government securities.
- Initially, four banks will be involved in controlled launch of digital currency namely, SBI, ICICI Bank, Yes Bank, and IDFC First Bank in Mumbai, New Delhi, Bengaluru and Bhubaneswar.
- These banks will issue digital tokens in the same denominations as paper currency, which can be used to make and receive payments.
- This is an Indirect model of CBDC.

#### About Retail e-rupee

 Retail e-rupee will be an electronic version of cash and primarily meant for retail transactions.

- It will be potentially available for use by all i.e., private sector, non-financial consumers and businesses.
- It will provide access to safe money for payment and settlement, as it will be a direct liability of the central bank.
- CBDC or Digital rupee is a **legal tender issued** by RBI in digital form.
- It is the same as fiat currency and exchangeable one-to-one with fiat currency.

#### Model for Issuance and Management of CBDC

- Direct model (Single Tier model) where the central bank is responsible for managing all aspects of the CBDC system viz. issuance, account-keeping and transaction verification.
- Indirect model (Two-Tier model) where central bank and other intermediaries (banks and any other service providers), each play their respective role.

# **5.1 LATEST INVENTIONS ON SCIENCE & TECHNOLOGY**

# Bharat Biotech's nasal COVID vaccine as booster

- Health Minister Mansukh Manda¬viya announced that nasal vaccine iNCOVACC would henceforth be available for public use as booster dose.
- The vaccine is co-developed by Hyderabad Bharat Biotech and the U.S. based Washington University, was approved in November 2022, for 'restricted emergency use' for those aged 18 or older.
- The appointments for the nasal vaccine would be available via the **CoWIN website**.

# Vainu Bappu Observatory (VBO)

• The Vainu Bappu Observatory celebrated

its **50 years anniversary** since its inception in 1972.

- It is an astronomical observatory owned and operated by Indian Institute of Astrophysics.
- Located at Kavalur in the Javadi Hills, near
   Vaniyambadi in Tirupathur district
- Stellar discoveries of the 40-inch telescope at VBO were highlighted at its 50-year celebration.
- Telescope was set up in 1972 by Professor Vainu Bappu.
- It is credit with discoveries like presence of rings around planet Uranus, new satellite of Uranus, presence of an atmosphere around Ganymede which is a satellite of Jupiter.

# **5.2 NEW SCIENTIFIC LABORATORIES**

# M Centre for Responsible AI at IIT-¬M

- The Indian Institute of Technology Madras has received a grant of \$1 million to set up a new multidisciplinary centre for research and development on responsible artificial intelligence.
- The Centre for Responsible AI is under the aegis of the Robert Bosch Centre for Data Science and Artificial Intelligence (RBC¬DSAI).
- The center will be established in partnership with Google.

# Sindhuja-I or 'Ocean Wave Energy Converter' by IIT Madras

 The researchers at the Indian Institute of Technology Madras (IIT Madras) have

- developed a device called Sindhuja-I or 'Ocean Wave Energy Converter', that can generate electricity from sea waves.
- Sindhuja means "created from the ocean" in Sanskrit.
- The device was deployed approximately 6 kilometres (km) off the coast of Tuticorin at a location with a depth of 20 metres.
- The Ocean Wave Energy Converter targets generating 1 megawatt (MW) of power from ocean waves in the next 3 years.
- The device trials were completed during the second week of November 2022.
- It could assist India in meeting its climate change-related goals of generating 500 GW of electricity from renewable energy by 2030.

# Drone Yatra, "Operation 777" by **Garuda Aerospace**

- Union Minister for Information and Broadcasting and Youth Affairs and Sports Anurag Singh Thakur inaugurated a drone yatra organised by the Chennai headquartered startup Garuda Aerospace.
- India will become a hub of drone technology and would require at least one lakh drone pilots by next year.
- Garuda Aerospace made an announcement about India's first Drone Skilling and Training Virtual E-Learning Platform at its Chennai manufacturing facility.
- Garuda Aerospace's drone yatra, 'Operation 777' will educate and demonstrate the efficacy of drones for agricultural purposes across 777 districts in India.

#### Note

- SWAMITVA scheme (Survey of villages and mapping with improvised technology), the survey of the land and houses were being pre¬pared through drones in the villages.
- Drones are increasingly being used to sprinkle pesticides and nano fertilizers in the field

# Asia's first Drone delivery hub

 The facility was unveiled by Meghalaya government in partnership with startup TechEagle.

- It aims to deliver vital supplies like drugs, diagnostic samples, vaccines quickly and safely to different regions of state using a dedicated drone delivery network.
- Benefits: Universal access to healthcare to 2.7 million people, overcome problem of lack of visibility, high delivery costs, etc.

# RFID technology to monitor the blood

- It also launched a computerised registry and mobile application with details of voluntary blood donors.

# DigiYatra facility at Delhi, Varanasi, Bengaluru airports

- Under the **DigiYatra initiative**, passengers can use their face as a boarding pass from December 1 in the airports **of Delhi**, **Varanasi and Bengaluru**.
- The facial recognition can be used to access the security check area and pass the boarding gate.
- Providing Aadhaar details is mandatory for travelers to avail themselves of this service.

#### **About DigiYatra**

- The Ministry of Civil Aviation has launched the 'DigiYatra' initiative to provide a digital experience for Air Travellers through DigiYatra Platform.
- The 'DigiYatra' is an industry-led initiative coordinated by the Ministry in line with the contry's Digital India's vision to transform the nation into a digitally empowered society.
- Digi Yatra platform will be built on 4 key pillars, like Connected Passengers, Connected Airports, Connected Flying and Connected Systems.

# India took over G-20 Presidency

- India formally took over the G20 presidency for one year from December 2022 to November 30, 2023.
- Hundred centrally-protected monuments, including UNESCO world heritage sites spread across the country, will be lit up for a week from December 1 to December 7.
- All illuminated heritage structures shall "highlight the G-20 logo over the monument".
- In Tamil Nadu, Brihadeeswara Temple was lit with the G-20 logo. It is officially called Rajarajeshwaram and known locally as Thanjai Periya Kovil and Peruvudaiyar Kovil, is a Shaivite Hindu temple built in a Chola architectural style located on the south bank of the Cauvery river in Thanjavur

#### About G-20 Logo

- The logo draws inspiration from the vibrant colours of India's national flag - saffron, white and green, and blue.
- It juxtaposes planet Earth with the lotus, India's national flower that reflects growth amid challenges.
- The Earth reflects India's pro-planet approach to life, one in perfect harmony with nature.
- Below the G20 logo is Bharat, written in the Devanagari script.

#### G - 20 Theme

- Vasudhaiva Kutumbakam or One Earth One Family One Future.
- The theme affirms the value of all life human, animal, plant, and microorganisms and their interconnectedness on the planet Earth and in the wider universe.
- During the course of its Presidency, India will be holding about 200 meetings in 32 different sectors in multiple locations across the country.
- g and The first **G20 Sherpa meeting** under India's presidency was inagurated in Rajasthan's Udaipur, Rajasthan.

#### About G20

- The **G20** or **Group** of **Twenty** is an intergovernmental forum of major developed and developing economies comprising 19 countries and the European Union (EU).
- Formation 26 September 1999.
- Chairman Narendra Modi, Prime Minister of India
- First Meeting in Cologne, Germany
- G20 Countries Argentina, Australia, Brazil, Canada, China, France, Germany, Japan, India, Indonesia, Italy, Mexico, Russia, South Africa, Saudi Arabia, South Korea, Turkey, the United Kingdom, the United States, and the European Union.

### **G-20 Finance and Central Bank Deputies meeting**

- The first G-20 Finance and Central Bank Deputies meeting and the first Finance Ministers and Central Bank Governors meeting was held in Bengaluru.
- The meeting has marked the beginning of discussions on the finance track agenda under the Indian G-20 presidency.
- There will be 40 such meetings on Finance across the country.
- Brand Karnataka is promoted on the sidelines of the international event.
- Karnataka will host 14 G20 meetings. Among them 11 will be held in Bengaluru, two in Hampi, the world heritage site and one will be held in Mysuru the heritage city.
- The consultative meeting will examine India's G20 priorities and activities on 8 key tasks: Financial Mechanism, International Financial Framework, Global Economy, Infrastructure Investments, Sustainable Finance, International Taxation, Health and Finance, Financial Sector Regulatory Issues and Financial Inclusion.
- A coordinated approach to regulating crypto assets, managing debt vulnerabilities and global reorienting financial institutions have been identified as critical focus areas of the Finance Track agenda for India's G-20 Presidency.

#### **HIV Infection rate declines by 46%** between 2010 and 2021: NACO

- The National AIDS Control Organization (NACO) has revealed that the country's annual rate of HIV infection has declined by 46% between 2010 and 2021 against a global average of 32%.
- Also, AIDS-related mortalities have declined by 76%.
- NACO, under the Ministry of Health & Family Welfare (MoH&FW), acts as nodal agency for activities of National AIDS Control Program (NACP).
- MoH&FW also released several initiatives at the event. It includes

- National Digital Repository, a Digital hub where all resource materials related to HIV and AIDS will be available for the common public.
- National Data Hub of NACO, central digital repository for key reports, documents and all approved data of NACO for internal use.
- #AbNahiChalega campaign to eliminate HIVrelated stigma and discrimination.

#### Note

- Tamil Nadu State AIDS project cell was formed in 1993 and in 1994, it has been registered as a Society under the Societies act, as Tamil Nadu State AIDS Control Society (TANSACS), the first of its kind for the nation.
- TANSACS is fully funded by the National AIDS Control Organization (NACO).

#### **About HIV**

- HIV is a virus that weakens a person's immune system by destroying important cells that fight disease and infection.
- Currently, there is no effective cure for HIV. But with proper medical care, HIV can be controlled.
- If HIV is not treated, it can lead to AIDS.
- In 2021, 52% of children living with HIV were accessing antiretroviral treatment (ART) 2 globally.

# India scores highest ever ranking in aviation safety

- India has been ranked 48 in terms of comprehensive safety audits conducted by the International Civil Aviation Organization (ICAO) which is among the top 50 countries of the world.
- India's ranking places it ahead of China (49).
- The ICAO undertakes the Universal Safety Oversight Audit Programme (USOAP), Continuous Monitoring Approach, an ICAO Coordinated Validation Mission which was undertaken from November 9 to 16, 2022.

- Amitabh Kant, the G20 Sherpa of India, welcomed G20 guests to Udaipur. He stressed that Rajasthan is known for warm hospitality and historical splendor and it is a "symbolic" beginning for G20 to demonstrate the tradition of 'Atithi Devo Bhava.' (Meaning - A guest is akin to God)
- The Sherpa meetings will work to establish consensus on key issues, which will be discussed in the various G20 workstreams, for inclusion in the Leaders' Declaration, which will be tabled at the G20 Summit in New Delhi in 2023.

#### Note

 India assumed the Presidency of the G20 for one year from December 1, 2022 to November 30, 2023 and the G20 Leaders' Summit will take place in New Delhi in 2023.

#### First Ministry for Divyang in India

- On the occasion of International Day of Disabled Persons, a Ministry for Divyang (differently-abled) was inaugurated Mumbai to help the physically and mentallydisabled people in Maharashtra, educationally and professionally.
- Maharashtra is the first State in the country to have a separate Ministry for the disabled that aims to ensure the welfare of the disabled and effective implementation of various government schemes for them.
- The Ministry is expected to hire 2000 special trainers for different disabilities, however only 300 special trainers have been hired so far.

# World's Longest double-decker viaduct (metro)

 Nagpur Metro and NHAI (National Highways Authority of India) has successfully created a Guinness World Record by constructing the longest double-decker viaduct (metro) is 3,140 meters located in the Wardha Road in Nagpur, Maharashtra

- The double-decker viaduct of 3.14 km on Wardha Road has three metro stations -Chhatrapati Nagar, Jai Prakash Nagar and Ujjwal Nagar.
- Double decker viaduct carries highway flyover at the first level and Metro Rail at second level making it a three-tier transportation system with the existing highway at ground level. This helped in avoiding additional land acquisition thus saving land cost and reducing construction time and project cost.
- The project has already bagged records from Asia Book and India Book.

### India unveils plan to install Renewable Energy

- The committee constituted by the Central Electricity Authority (CEA) prepares a detailed Transmission Plan titled "Transmission System for Integration of over 500 GW RE Capacity by 2030"
- According to the plan, the installation of 500 GW (gigawatt) of renewable energy capacity by 2030 will involve an investment of at least 2.44 lakh crore or 2.44 trillion.
- The committee was headed by the Chairman of the Central Electricity Authority.
- The committee was tasked with setting out a plan for the transmission system required for having 500 GW of non-fossil fuel based installed capacity by 2030.
- The transmission plan also includes systems required for transporting 10 GW of off shore wind based energy located in Gujarat and Tamil Nadu at an estimated cost of `28,000 crore.
- The plan has identified upcoming non fossil fuel generation centers in the country, including at Fatehgarh, Bhadla and Bikaner in Rajasthan, Khavda in Gujarat, and Anantapur and Kurnool in Andhra Pradesh.

# Aariculture Investment Portal

- The Union Minister for Agriculture and Farmers Welfare inaugurated the integrated Agriculture Investment Portal.
- It will be a centralized one stop portal for agri-investors to avail benefits of various government schemes implemented by various departments related to agriculture and allied sectors.

- Aim is to boost investments, ease the handholding process for investors, tap potential of all sub-sectors in Agriculture etc.
- Focus sectors for investment promotion include Agriculture machinery, Seeds, Fertilisers, agrochemicals, Precision agriculture, Logistics, warehousing and cold chain etc.

#### Supreme Court mobile app 2.0 launched

- The Supreme Court launched android version 2.0 of its mobile application.
- Android version 2.0 is available while iOS will be available in a week's time. Besides lawyers and advocates on-record, the application will give exclusive real-time access to all law officers and nodal officers of various Ministries of the Central Government. They can watch the court proceedings by logging in through this application

#### **Energy Conservation (Amendment) Bill,** 2022

• The Energy Conservation (Amendment) Bill, 2022 was passed in the parliament.

#### Highlights of the Bill

- The Bill amends the Energy Conservation Act, 2001 to empower the central government to specify a carbon credit trading scheme.
- Designated consumers may 2 be required to meet a proportion of their energy needs from non-fossil sources.
- The Energy Conservation Code for buildings will also apply to office and residential buildings with a connected load of 100 kilowatt or above.
- Energy consumption standards may be specified for vehicles and ships.
- The Bill seeks to mandate use of non-fossil sources, including Green Hydrogen, Green Ammonia, Biomass and ethanol for energy and feedstock and establish Carbon Markets.
- The Bill seeks to bring large residential buildings within the fold of the Energy

Conservation regime, enhance the scope of the Energy Conservation Building Code and amend penalty provisions.

#### India's First Carbon Neutral Farm

- Pinarayi Vijayan, Chief Minister (CM) of Kerala, declared Kerala Seed Farm in Aluva, Ernakulam district as India's First Carbon Neutral Farm in India.
- The total amount of carbon emission from the farm, located at Thuruthu in Aluva, in the last one year was 43 tons but its overall procurement was 213 tonnes.
- Compared to the emission rate, as many as 170 tons of more carbon have been procured at the farm, which helped it to be declared as the first carbon neutral seed farm in the country.
- Kerala Government aims to achieve 40% of its energy needs from renewable energy sources by 2025.
- Kerala aims to establish Carbon-neutral farms in all 140 Assembly constituencies.

- involves Internet Governance Internet Protocol Addressing (IP Addressing), Domain Name System (DNS), Routing, Technical Innovations, Standardization, Security, Public Policy, Privacy, Legal Issues, Cyber Norms, Intellectual Property and taxation.

 India supports a multi-stakeholder approach in matters on Internet Governance.

#### **Challenges to Internet governance:**

- Continuously evolving nature of the internet.
- Concentration of digital power in a few companies and countries.
- Decision making skewed to the supply side rather than to the demand side etc.

#### Note

- India is the largest 'connected' nation in the world with 800 million Indian users.
- BharatNet is a flagship mission implemented by Bharat Broadband Network Ltd. (BBNL) with an aim to connect all the 2,50,000 Gram panchayats in the country and provide 100 Mbps connectivity to all gram panchayats.
- National Optical Fibre Network (NOFN) was launched in October 2011 and was renamed as Bharat Net Project in 2015.

# India International Science Festival (IISF)-2022

- The IISF-2022 will be held in Bhopal, Madhya Pradesh in January 2023.
- The IISF 2022 is the **eighth edition** since its **inception in 2015.**
- IISF is the initiative of the Ministry of Science & Technology and Ministry of Earth Science in association with Vijnana Bharati.

- Vijnana Bharati is a science movement with a swadeshi spirit led by eminent scientists of the country.
- IISF aims to engage creative and imaginative minds in India and across the globe to celebrate science through various programs and activities connected to Aazadi ka Amrit Mahotsay.
- The first and second IISF were held in New Delhi, the third in Chennai, the fourth one in Lucknow, fifth in Kolkata, sixth through virtual mode and the seventh IISF was held in Goa.

#### India's First Green Steel Brand

 Union Minister of Steel, Jyotiraditya Scindia launched India's first Green Steel Brand, "Kalyani Ferresta" in New Delhi.

- The brand is manufactured by a Pune-based Steel company, Kalyani group by using renewable energy resources, leaving zero carbon footprints in the environment.
- The Government of India is promoting green steel manufacturing and has framed the National Steel Policy to achieve zero carbon emissions by the steel industry to achieve its goal of carbon neutrality by 2070.
- The policy makes it mandatory for steelmakers to dedicate a certain percentage of their production lines for making green steel and also encourages its usage in government projects, as a promotion towards the use of the product.

#### Note

- The steel industry produces 7 percent of Carbon dioxide (CO2) emissions globally, while the Indian steel industry accounts for 12 percent of such emissions. It is a fossil free steel.
- Green steel is manufactured using lowcarbon energy sources such as hydrogen, coal gasification and electricity rather than using coking coal.
- India is the world's second-largest producer of crude steel after China.

# Govt projects record wheat production in 2022

- The government projected record wheat production in the ongoing 2022-23 crop year (July-June) as total area sown to the winter crop has increased by 3.18 per cent to 312.26 lakh hectares so far in the ongoing rabi (winter) season.
- Sowing of wheat, the main rabi (winter) crop, begins in October while harvesting starts in April.
- Mustard seed and gram are other major crops sown in the rabi season.
- The country's wheat production had declined to 106.84 million tonnes during 2021-22 crop year due to a heatwave in some key growing states, as against 109.59 million tonne in the previous year, as per official data.
- According to the ministry's latest data, wheat has been sown in 312.26 lakh hectares (ha) in

- the ongoing rabi season as of December 23, as against 302.61 lakh ha in the year-ago period.
- Higher area is reported from Rajasthan (1.99) lakh ha), followed by Gujarat (1.74 lakh ha), ... Uttar Pradesh (1.57 lakh ha), Bihar (1.51 lakh ha), Maharashtra (1.43 lakh ha), Madhya Pradesh (0.83 lakh ha), Chhattisgarh (0.64 lakh ha), West Bengal (0.24 lakh ha), Jammu and Kashmir (0.23 lakh ha), Karnataka (0.15 lakh ha) and Assam (0.01 lakh ha).

# Cabinet approves MSP for copra for 2023 season

- The Cabinet Committee on Economic Affairs chaired by Prime Minister Narendra Modi has approved Minimum Support Prices (MSPs) for copra for 2023 season.
- The approval is based on recommendations of the Commission for Agricultural Costs and Prices and views of major coconut growing states.
- The MSP for Fair Average Quality of milling copra has been fixed at Rs. 10860/- per quintal and for ball copra at Rs. 11750/- per quintal for 2023 season.

- This is an increase of Rs. 270/- per quintal for milling copra and Rs. 750/- per quintal for ball copra over the previous season.
- The announced MSP of copra for 2023 season is in line with the principle of fixing the MSP at a level of at least 1.5 times all India weighted average cost of production as announced by the Government in the Budget 2018-19.
- National Agricultural Cooperative Marketing Federation of India Ltd. (NAFED) and National Cooperative Consumers' Federation (NCCF) will continue to act as Central Nodal Agencies (CNAs) for procurement of copra and de-husked coconut under Price Support Scheme (PSS).

# **MEITY: Nodal Ministry for Online** Gaming

- The Ministry of Electronics and Information Technology has appointed MeitY as the central regulatory authority that will provide clarity and certainty to investors, industry and consumers.
- Online games refer to games that are played over some form of computer network, most often the Internet.
- As per All India Gaming Federation, India's online gaming industry is expected to be worth Rs.15,500 crore by 2023.

#### Types of online gaming

- Game of skill
- It requires a player's skill and mental or physical strength to win. It does not depend on sheer luck.
- Games of chance
- It is considered as gambling as it depends on factors like luck and unpredictability.
- The winnings from games of skill attract 18 per cent Goods and Services Tax (GST). On the other hand, winnings from games of chance attract 28 per cent GST.

- The concept of a climate club was developed by Yale economist William Nordhalus in 2015 and has since gained popularity in policy circles. Mr. Nordhaus also won the 2018 Nobel Prize in economics for his work on climate change.
- Germany has held the G-7 presidency since January 1, 2022, when it took over from the United Kingdom (UK), and it will be passed on to Japan in 2023.

#### **Key Points:**

- The new International Climate Club will be a global endeavour rather than a **G-7** initiative.
- The **Paris Agreement (2015)**, which aims to keep global warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit), will be swiftly and intensely implemented with assistance from the climate club.
- The club will aim to expedite the industrial shift to cleaner energy sources and to create - Capital-Kathmandu more emission-reduction initiatives.

- This campaign is being implemented through State Nodal Agencies (SNAs) designated by States for coordinating activities related to rolling out Public Charging Infrastructure in States.

# San Antonio - Chennai Corporation signs a Pact

- A consultation meeting was held under the leadership of the mayors of San Antonio, Ron Nirenberg and Chennai, Priya Rajan.
- The meeting was held at Ripon House under the Sister City Agreement.
- The two mayors said that as a merger of sister cities, they will work together to improve the creative relations of the people of the two cities and to improve education, health and basic structures, and to further enrich the character, intelligence and economy of the people of the two cities.

#### Note

Chennai-San Antonio Sister agreement was signed on February 27, 2008, and laid the foundation for significant economic and cultural exchanges in areas

such as commerce, health, education, and technology.

# Madurai Bench of Madras High Court gets its first woman mace-bearer

- **D.** Lalitha, has been appointed as the first woman chobdar (mace-bearer) of the Madurai Bench of the Madras High Court. She is the mace-bearer for Justice N. Mala.
- Earlier in June 2022, the Madras High Court had got its first woman mace-bearer, R.N.Manjula
- In the High Court, the mace-bearer walks in front of the judges so as to ensure free passage for them as they move from their chambers to the court halls.

#### Tamil Nadu Climate Summit 2022

- The first ever Tamil Nadu Climate Summit begins at Chennai.
- The Tamil Nadu Green Climate Change Company will focus on preparing decarbonisation pathways for various sectors; conceptualising and setting up finance models and a climate studio; climate budgeting; and partnerships with local agencies.
- Tamil Nadu Climate Summit 2022 highlighted the State's flagship missions and initiatives, one of which is the Green Climate Change Company, a special purpose vehicle to steer Tamil Nadu to become a climate smart State.
- The summit was inaugurated with **three major missions** of the State government.
  - Climate Change Mission The mission will help to strengthen the government's climate response at the grassroots.
  - Green Tamil Nadu Mission The mission aims to Increase the State's green cover (areas including forest and the tree cover around it) from 23.71% to 33%.
  - Tamil Nadu Wetlands Mission It aims to restore 100 wetlands across the state in five years

#### Climate-smart Agriculture

At the first Tamil Nadu climate conference hosted in the city the experts emphasised that being climate-smart is the only way to adapt to

- the effects of climate change on many sectors, especially agriculture.
- Presentations on diverse strategies adaptation, problem- solving, and resilience to the effects of climate change on sectors like transport, agriculture, solid waste, innovation, and energy were given by experts from many > It was constructed by T.Samynada Pillai, a professions, including the local communities.
- TN is preparing an inventory of greenhouse gases and has already completed it for Tirunelveli, Coimbatore and Trichy
- It was stated that real time crop advisory, use of drones to manage crops, and implementation of smart farming techniques using artificial intelligence were a few action points taken to achieve food security.

# **Body worn cameras to monitor** prisoners activities in TN jails

- Body worn cameras to monitor the activities of high-risk prisoners in Tamil Nadu were introduced in Central prisons.
- Apart from 9 Central prisons in the State, the facility will also be introduced in Pudukkottai district jail.
- Initially, the body worn cameras were introduced in Central prison Puzhal for the first time.
- In total, there are 142 prisons in Tamil Nadu under the Prisons Department which includes 9 Central Jails, 14 District Jails, 96 Branch Jails, 5 Women's Special Jails, 12 Juvenile Schools (Borstal Schools), 3 Open Air Jails, 3 Special Tails.

# Southern Railway headquarters celebrates centenary

- The interiors of the Southern Railway headquarters lit up in blue to celebrate its centenary.
- The building is marked by the displaying a decommissioned steam loco engine, PL691 at the front.
- The building was inaugurated by Lady Willingdon, the wife of the then Governor of Madras Freeman Freeman-Thomas, on December 11, 1922.

- The foundation of the building was laid by Lord Pentland, the then Governor of Madras. in 1915.
- Le Designed by N. Grayson, an architect and employee of the Madras and Southern Mahratta Railway, it cost Rs.30.76 lakh
  - Bengaluru-based building contractor.
  - A postal cover to mark the centenary of the headquarters was released in January 2022.

# Women Commandos in the core security team.

- The unit, called the **core cell**, is a **special unit** that provides security to the Tamil Nadu Chief Minister.
- The unit is attached to the Security Branch-CID.
- It provides foolproof and round-the-clock security at the places where the Chief Minister visits and to his convoy.
- The unit has so far been staffed by policemen. Now a team of policewomen will be inducted into the special unit.
- Currently 9 women commandos are appointed in the special division.
- For this, women commandos with the status of Assistant Inspector of Police, Head Constable are selected through separate exams and after receiving special training, they are posted in the "Core Cell".
- The core cell comprises close protection teams, a bomb detection and disposal squad, the motor transport wing and the technical wing.
- This is the first time that women commandos have been appointed in Chief Minister's Security

# Financing of Urban Infrastructure: **Exchange of Contracts for Tamil Nadu Projects**

 Contracts for Tamil Nadu projects were exchanged in the presence of Chief Minister M K Stalin under the Funding Scheme for Development of Sustainable Urban Infrastructure.

- The Joint Development Bank of India and the Government of Tamil Nadu are implementing the Financing Scheme for Sustainable Urban Infrastructure.
- The objective of the project is to improve the capacity of urban local bodies to address climate resilience, drinking water supply, sewage disposal and related issues in urban infrastructure.
- The first phase of the project is worth Rs.1969.47 crore. Both phases of the project will be completed this month.
- The third phase of the project will be completed by June 30, 2030.

# Aavin's ice cream plant in Salem inaugurated

- Chief Minister M. K. Stalin inaugurated a new ice cream plant at the Aavin's Salem dairy, the third such facility of the cooperative federation.
- The plant had been constructed at a cost of Rs.12.26 crore using funds from the Coimbatore, Erode and Salem unions of the Tamil Nadu Cooperative Milk Producers **Federation**, whose popular brand is Aavin.
- The plant has a capacity to manufacture 6,000 liters of ice cream per day and supply it to three districts.

- Inclusion of silambam and kabaddi at all levels in the State games conducted by the Sports Development Authority of Tamil Nadu for the Chief Minister's trophy.
  - Earlier only 10 sports events were conducted under the Chief Minister's trophy.
  - Now, it has been decided to increase the

- number to 16 by includ-ing traditional games.
- The participation of persons disabilities, government employees and the general public will be encouraged.
- Rs.47.04 crore will be sanctioned towards the Chief Minister's trophy and for forming State Level coordination committees, district youth welfare and sports deve¬ lopment committees and another committee to con-duct district level sports events.
- Announcement regarding a scheme to grant pension to needy sportspersons.
  - They will receive Rs.3,000 per month from March 2022 to August 2022 and subsequently get Rs.6,000 per month.
  - Rs.4 lakh reward was given to Ms. Niveditha Nair, who won a silver medal in the pistol competition at the Junior World Championship held in Peru by the International Shooting Sport Federation in 2021

# TIDCO plans to develop six thematic industrial parks across the State

- Tamil Nadu Industrial Development Corporation Limited (TIDCO), a governmental agency in the state of Tamil Nadu is planning to develop six thematic industrial parks two in Chennai, three in Coimbatore and one space park at Kula sekarapattinam in Thoothukudi to support the micro, small and medium enterprises in the State.
- Tamil Nadu has been ranked third in the country in the Ease of doing business for 2020-21.
- The state aims to improve the ranking to number 1 by supporting the micro, small and medium enterprises in the aerospace and defense sector.

# Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural **Property**

• The Idol Wing CID (IWCID) of the Tamil Nadu police stopped the auction of Nataraja Idol in France and insisted for its return under the UNESCO Convention of 1970.

 The rare variety bronze idol was stolen from Kayathar in Thoothukudi district half a century ago.

#### **About UNESCO 1970 Convention**

- The UNESCO 1970 Convention international treaty to take measures to prohibit and prevent the illicit trafficking of > Widely known as 'Perasiriyar' (Professor) his cultural property.
- The return and restitution of cultural property is central to the Convention.
- It entered into force in 1972 and is ratified by 143 states including India.

#### Aadhaar now mandatory for all Government schemes

- The Tamil Nadu government issued a notification making possession of Aadhaar number or undergoing Aadhaar identification mandatory for availing various welfare schemes of the government.
- The 'Scheme' is the Integrated Financial and Human Resources Management System, administered by the Treasuries and Accounts Department, to make online payments of bills and payments to beneficiaries through the Electronic Clearing Service.
- Aadhaar will be mandatory now for registering on 'Scheme'

#### Note

- **TANGEDCO** made it 201 Recently, has compulsory for the electricity consumers (only those seeking subsidies) to link Aadhar card with TNEB (Tamil Nadu Electricity Board).
- Tamil Nadu Electricity Board (TNEB) was formed on July 1, 1957 under section 54 of the Electricity (Supply) Act 1948.
- TNEB was restructured on 1.11.2010 into
  - TNEB Limited
  - Tamil Nadu Generation and Distribution **Corporation Limited (TANGEDCO)**
  - Tamil Nadu Transmission Corporation Limited (TANTRANSCO)

# Bill to include Narikoravan, Kurivikkaran tribes in ST list of Tamil Nadu passed

- Parliament passed the Constitution (Scheduled Tribes) Order (Second Amendment) Bill, 2022, to include the Narikoravar and Kuruvikarar tribes of Tamil Nadu in the Scheduled Tribes list of the State.
- Tamil Nadu's population is over seven crore and the two communities constitute just about 27,000 of the population.
- On the basis of the recommendation of Tamil Nadu and after consultation with the Registrar General of India and the National

Commission for Scheduled Tribes, it is proposed to amend Part XIV of the Schedule to the Constitution (Scheduled Tribes) Order, 1950.

• Since the Bill is approved by Parliament, the members of Narikoravar and Kurivikkarar communities will be entitled to all benefits which are provided to those belonging to the ST category, especially reservation in educational institutions and government jobs.

#### Note

- Article 342 deals with the provisions related to Scheduled Tribes.
- It states that the President after consultation with the Governor by public notification may specify a particular tribe deemed to be deemed as scheduled tribe.

#### 6 Lakh Trees in 4 hours

- Tamil Nadu's Food and Civil Supplies Minister R.Sakkarapani and his team have set out to create a new Elite World Records by planting 6 Lakh trees in just 4 hours, in a bid to honour the Green Tamil Nadu Mission.
- The Objective of the Mission is to increase its forest to 33 per cent cover from the present 23 per cent before 2030 to combat climate change.
- About 16,000 volunteers are involved in the huge plantation campaign in which saplings will be planted at Idayakottai Village of Oddanchatram Constituency in Dindigul District.

# Introduction of 'Blockchain technology in Tamil Nadu Idol Wing Police

 The Idol Wing CID of Tamil Nadu Police has launched an initiative on the blockchain where informants who wish to pass inputs on idol smuggling or possession or sale of

- illicit antique idols can anonymously give information to the police.
- The staff of Idol Wing can submit their grievances on the blockchain.
- The public wishing to lodge their complaints can also do so on the decentralised blockchain at complaints.tnidols.com.
- Blockchain Technology has been introduced for the first time in Tamil Nadu.
- A case will be registered within 7 days if the complaints are confirmed to be genuine.
- Similarly, complaints made by departmental police officers and officers will be resolved within 15 days.

# **Greenhouse Gas Inventory compendium** for Coimbatore, Tiruchi and Tirunelveli

- TN government has launched greenhouse gas inventory compendium for Coimbatore, Trichy and Tirunelveli.
- The aim is to prepare a contextual and inclusive climate resilient action plan for these cities.
- The manufacturing and construction sectors accounted for the highest quantum of greenhouse gas emissions in Coimbatore (35%).
- In Trichy, the residential sector topped the list (35.6%), followed by waste (31.7%). Transport accounted for 15% in both Trichy and Coimbatore.
- The residential buildings were the largest contributor in Tirunelveli, at 51%, followed by o road transport, at 22%.

# ISO Certification for 4, 517 Fair Price Shops in TN

- 4,517 fair price shops in Tamil Nadu have been given ISO certification so far.
- There are 35,000 fair price shops in Tamil Nadu in total. Of these, 25,000 shops are operating as full-time shops and less than 10,000 shops are operating as part-time shops.
- The ISO certification in public distribution system means that the shops have established mechanisms to prevent adulteration or safety hazards to food items they handle and supply.
- Fair price shops across Tamil Nadu will be revamped with improved facilities.

#### Note

- Tamil Nadu follows the Universal Public Distribution System where classifications such as BPL, APL, do not exist.
- TN is providing rice at free of cost under Public Distribution System to all eligible card holders from 01.06.2011.
- Tamil Nadu Civil Supplies Corporation procures the essential commodities from Food Corporation of India and stores them in godowns across the state.

# Solution to repel Wild animals

- Erode district administration with the help of Indian Council of Agricultural Research is launching a sustainable solution to repel wild animals.
- In order to protect the crops and humans from the attack of wild animals, Herboliv manufactured by a private manufacturer will be sprayed in the crops.

- It is produced using a combination of different botanical extracts and other natural products.
- crop damage caused by elephants, pigs, deer, wild buffaloes, monkeys, rabbits, peacocks, rats and parrots due to the aroma emitted from it. can be prevented. It gives immunity to crops so that they grow well.
- Other schemes like Food processing Plants at village, biofortification of maize grains and Green fodder bank have been launched to help the farmers in the area of Western Ghats.

#### Makkal ID

- TN Government is planning to launch Makkal ID
- Under the unique individual identification system each individual will be provided with 'Makkal ID'
- The card will be issued for the seamless implementation of government schemes.
- Makkal ID will be generated as a random number (10 digits) and not as a pattern-based number with encoded information or the alphanumeric string.

#### **Modernisation of Forest Force**

- The Government of Tamil Nadu has decided to modernise Tamil Nadu Forest Force by equipping them with modern equipment and technology, training and capacity building etc.
- Strategic objectives include
  - Sustainable growth of forest resources.
  - Build an efficient and effective department.
  - Enable better protection and management of biodiversity and ecosystems.
  - Strengthen the service delivery infrastructure through regional facilities.
  - Ensure continuous updating of knowledge of forest personnel.
  - Improve the capability and mobility of field staff to handle Human wildlife conflict issues.

# TNPL unit II, SIPCOT park inaugurated

 Chief Minister MK Stalin inaugurated Unit-II of Tamil Nadu Newsprint and Papers Limited (TNPL) hardwood pulp mill at a capital outlay of Rs 1,385 crore at Mondipatti village near Manaparai in Trichy.

 The first SIPCOT industrial park of Trichy was inaugurated at Manapparai at a cost of Rs 47.44 crore.

#### Note

- State Industries Promotion Corporation of Tamilnadu Ltd (SIPCOT) was established in the year 1971 to develop industrial growth in Tamilnadu.
- The Tamil Nadu Newsprint and Papers Limited (TNPL) was established to produce newsprint and writing paper using bagasse, a sugarcane residue.
- The factory is situated at Kagithapuram, Karur and Manapparai, Trichy.

### Portal for benefit of private schools

- The Tamil Nadu Government launched a portal established by the School Education Department for processing applications for opening private schools and getting fresh government recognition or extension of recognition for schools.
- Over 15,000 private schools will be benefitted from the portal.

# **Installation of Transponders**

- TN Government launched a scheme for **installing transponders** in over 4,990 fishing vessels at a total cost of RS.18.01 crore.

- Women led Startups are those startups that should be owned by women or co-founded by a group of women having a minimum equity of 75% in the enterprise.
- Green tech Startups which take upon commercially viable infrastructure projects that promote sustainability and circularity will be funded by the **Green Climate Fund**.

#### Note

 TANSEED was launched to support early stage startups with a seed grant of up to Rs.10 lakh each.

#### Blood art to be banned in Tamil Nadu

- TN government has banned the use of blood for art works or blood art.
- The government took the decision after considering the health and safety of the people.
- The ban was followed by the concerns about taking the blood which can result in the spread of infections like HIV.
