



### **1.2 DEFENCE, NATIONAL SECURITY AND TERRORISM**

## Third edition of the high-level virtual interaction MAHASAGAR

- The third edition of the high-level **virtual** interaction MAHASAGAR was conducted by the Indian Navy on **05 Nov 24**.
- Heads of Navies/ Maritime Agencies and Senior Leadership from Indian Ocean Region littorals viz., Bangladesh, Comoros, Kenya, Madagascar, Maldives, Mauritius, Mozambique, Seychelles, Sri Lanka and Tanzania. Are present in this meeting
- MAHASAGAR which stands for vast ocean in Hindi, is the Indian Navy's flagship outreach for high-level virtual interaction between Maritime Heads for Active Security and Growth for all in the region.

#### Unmanned vessel finishes 1,500-km voyage from Mumbai to Thoothukudi

- An autonomous surface vessel built by Sagar Defence Engineering has completed a 1,500km voyage from Mumbai to Thoothukudi without human intervention, in an endeavour supported by the Indian Navy.
- It is supported by the Indian Navy's Naval Innovation and Indigenisation Organisation (NIIO), the Technology Development Acceleration Cell (TDAC), and the Innovations for Defence Excellence (iDEX) initiative under the Defence Innovation Organisation (DIO).
- Sagarmala Parikrama journey was virtually flagged off on October 29

#### 550 'Asmi' machine

#### What is the Atmanirbharta Initiative?

- The goal is to make India self-sufficient in various sectors, including defence. It encourages local production and reduces dependency on imports.

#### **Development and Manufacturing**

• The 'Asmi' was developed by Colonel Prasad Bansod of the **Indian Army**. It was created in collaboration with the **Defence Research and Development Organisation (DRDO).** 

#### Successful Test of Long-Range Surfaceto-Surface Missile

- The Defense Research and Development Organization (DRDO) successfully conducted the first test of a long-range missile capable of hitting ground targets
- Defense Minister Rajnath Singh praised that this would serve as a model for future indigenously manufactured missile projects.
- The missile test, conducted at the Integrated Test Range in **Chandipur**, **Odisha**, performed better than expected and fulfilled the project's objectives, according to the Ministry of Defense.

## According to the ministry's press release:

- The missile's performance was monitored through radars, electro-optical tracking systems, and telemetry installed at various locations.
- It traveled accurately along the predetermined path to reach its target, demonstrating its capabilities at various altitudes and speeds.
- The missile is equipped with modern aviation technologies and software.
- Bharat Dynamics in Hyderabad and Bharat Electronics in Bangalore played crucial roles in the missile's development and production.

#### Nationwide Coastal Surveillance Exercise to Begin on Nov. 20

 The Ministry of Defence announced that the Indian Navy will conduct a nationwide
 'Coastal Surveillance - 24' (Sea Vigil-24) exercise on November 20 and 21.

- These surveillance exercises have been conducted to strengthen coastal security following the 2008 Mumbai terrorist attacks. The country has approximately 11,098 km of coastline and an Exclusive Economic Zone covering 2.4 million square kilometers along the coastal region.
- This comprehensive exercise aims to create awareness about security threats from the sea by simultaneously engaging all maritime stakeholders, including the fishing community, coastal residents, and various coastal security infrastructure facilities.
- The exercise is conducted under the leadership of the Indian Navy's CDSRE (Coastal Defence Security Readiness Evaluation) team, which includes naval commanders from all coastal states and Union Territories (Lakshadweep, Andaman Islands). The exercise aims to assess and enhance coastal security and defense preparedness.

#### AFSPA reimposed in six riot-hit areas of Manipur

- The Union Home Ministry has reimposed AFSPA (Armed Forces Special Powers Act) in six police station areas across five districts of Manipur, declaring them as "disturbed areas."
- The affected areas include police stations in Imphal West (Sekmai and Lamsang), Imphal East (Lamlai), Jiribam, Bishnupur (Moirang), and Kangpokpi (Leimakhong) districts.
- AFSPA had previously been withdrawn from these areas in April 2022 due to improved security conditions, but is now reinstated until March 31, 2025.
- The reimposition comes in response to

ongoing ethnic violence, with recent incidents including intermittent firing in violence-prone areas and increased insurgent group activity.

- Since May 2023, over 240 people have died in ethnic conflicts between the Meitei people (valley residents) and the tribal Kuki-Zo-Hmar people (hill residents), with 14 deaths reported just since November 7.
- The security presence in the region includes 22,000 Central Armed Police Force personnel and approximately 140 Army columns, with AFSPA allowing armed forces to conduct operations without waiting for magistrate or state police presence.

#### About AFSPA:

- **Objective**: Conferring certain special powers upon members of the armed forces in disturbed areas in North eastern States.
- Section 3 of Act: Governor of State or Administrator of Union territory or Central Government may declare whole/such part of such State/UT to be a disturbed area.
- Disturbed area is an area where use of armed forces in aid of civil power is necessary.

#### Section 4 of Act:

- Gives special powers to armed forces although they must be exercised with extreme caution.
- After giving due warning, it can fire upon/ use force against any person acting in contravention of laws,
- If reasonable suspicion exists, can also arrest a person without a warrant;
- Unless otherwise authorized by the central government, Army soldiers operating under AFSPA are shielded from all legal actions.

#### 'Hypersonic' Missile Test Success

 India successfully tested its first long-range hypersonic missile capable of traveling over 1,500 km carrying nuclear weapons.  Russia and China are leading globally in hypersonic missile development. The United States is actively working on developing hypersonic missiles under its ambitious program. Countries like France, Germany, Australia, Japan, and Israel are also pursuing similar projects.

The missile, developed by the **Defence Research and Development Organisation (DRDO)** under India's first long-range hypersonic missile program, was successfully tested from Dr. APJ Abdul Kalam Island off the Balasore coast in Odisha.

 It's worth noting that DRDO has previously developed long-range missiles including Prithvi, Akash, and Agni.

#### **Naval Exercise**

- Indian Navy's sail training ship INS Tarangini participated in a joint sailing exercise with Italian sailing vessel Amerigo Vespucci off the Kochi coast.
- This exercise, which took place last Friday (Nov. 22) off the Kochi coast in Kerala, demonstrates the Indian Navy's commitment to fostering global maritime traditions and international friendship.

#### New Telecom Cyber Security Regulations

- The Government of India has implemented new telecom cyber security regulations, aimed to enhance the protection of communication networks and services.
- Telecom companies are now required to report security incidents to the government. They must also share specific data for cybersecurity purposes.

#### **Reporting Security Incidents**

• Telecom companies must report any security incidents within six hours. Reports should include details about the affected systems.

- Within 24 hours, they must provide information on the number of users impacted and the geographic area affected.
- Companies must share traffic data and other relevant information, which excludes message content. The government can request this data to boost cyber security efforts.

#### **Cyber Security Policies**

- Each telecom entity must adopt comprehensive **cyber security policy**.
- This policy should encompass security measures, risk management, and incident response strategies. Training and network testing are also essential components.

#### SAREX-24

- The Indian Coast Guard will conduct SAREX-24 in Kochi from November 27 to 30, which focuses on enhancing search and rescue operations.
- It is organised by the National Maritime Search and Rescue (NMSAR) Board. The exercises will involve national agencies and foreign partners, whose aim is to improve India's capabilities in handling maritime emergencies.
- Participants will include officials from government agencies, ministries, and armed forces. Foreign delegates will also be present to share insights and experiences.

## France to Provide Technology for Navy's Submarine Projects

- The Indian Navy plans to build 66 warships under "Project 66" as part of its expansion.
  - According to this, 50 ships are under construction. Similarly, under "Project 77," the Navy plans to acquire nuclear-powered submarines.
  - For these projects, France will provide advanced pump-jet propulsion technology that reduces noise levels, similar to what's used in their Barracuda-class submarines.
  - This will increase the ability to operate without attracting enemy attention. By using this technology, Indian submarines in the Indian
     Ocean region will become much quieter

## Joint Defense Cooperation Committee (JDCC)

 India and Tanzania conducted their third Joint Defense Cooperation Committee (JDCC) meeting on November 26, 2024. The meeting was held in Goa, with the objective of strengthening defense relations between the two countries.

#### **Committee Activities**

 The Tanzanian delegation visited the Goa Shipyard, aimed at understanding India's ship-building capabilities.

### **1.3 WORLD ORGANISATIONS – PACTS AND SUMMITS**

## **International Cooperative Alliance (ICA)** This marks the first time in the 130-year **Global Cooperative Conference**

- India will host the International Cooperative Alliance (ICA) Global Cooperative Conference in New Delhi from November 25 to 30, 2024.
- This marks the first time in the 130-year history of the ICA that the global cooperative movement's premier event will be held in India.
- Theme: "Cooperatives Build Prosperity for All"

### **1.4 EMINENT PERSONS**

- The Constituent Assembly of India had 15 women members, including prominent figures
   like Sarojini Naidu, Sucheta Kripalani, and Vijaya Lakshmi Pandit.
- President Droupadi Murmu highlighted the role of these women on Constitution Day (November 26).
- Five notable women from the Constituent Assembly:

#### 1. Ammu Swaminathan (1894-1978)

- born in Palakkad, Kerala.
- Opposed widow restrictions after her mother's experience.
- Spoke on the Hindu Code Bill and gender equality in the Assembly.

#### 2. Annie Mascarene (1902-1963)

- Born in Travancore in a Latin Christian family.
- Advocated for universal adult franchise and a strong Centre.

### 1.5 SPORTS

#### India submits letter expressing interest to host 2036 Olympics to International Olympic Committee

 The Sports Ministry sources indicate that this great opportunity will bring benefits in terms of economic growth, social progress, and or youth development for India.

### **1.6 BOOKS AND AUTHORS**

#### **British Author Wins Booker Prize**

- British author **Samantha Harvey** has won this year's Booker Prize.
- She was awarded the prize for her novel 'Orbital'.
- Written for the first time with six astronauts living on the International Space Station as characters, the book became a bestseller in Britain.

#### 3. Begum Qudsia Aizaz Rasul (1909-2001)

- Came from a privileged background with a royal family heritage.
- Joined politics and opposed separate electorates based on religion.
- Promoted women's hockey postindependence.

#### 4. Dakshayani Velayudhan (1912-1978)

- First Dalit woman to graduate in science in Cochin.
- Disagreed with Ambedkar on separate electorates, advocating nationalism.
- Faced financial difficulties, which limited her political career.

#### 5. Renuka Ray (1904-1997)

- Born in Pabna (present-day Bangladesh).
- Quit college to join the freedom struggle after meeting Gandhi.

#### • Strong countries like Saudi Arabia, Qatar, and Turkey are in the lead. India will have to Since 20 compete with these countries.

• Regarding the 2036 Olympics, Ahmedabad is the leading candidate city to host the competition.

### The judges stated that the Booker Prize, one of the world's highest literary awards, was given to this book for its compact size yet beautifully expansive ideas.

 Along with this prize, Samantha Harvey will receive a cash prize of 50,000 pounds (approximately Rs. 53.63 lakhs).

#### Kalitogai, a classical Tamil anthology

- Rebel Theatre: A poem from Kalitogai portrays unconventional characters, a hunch- **1** Play Description: The poem's play involves back woman and a dwarf, falling in love, showcasing their indomitable spirit and wit.
- Controversial Interpretation: The author previously suggested that the 'Kutru' in Tholkappiyam could have evolved into 'koothu' (theatre), stirring debate among scholars.

#### Thirukkural

Tamil Nadu Textbook and Educational Services Corporation (TNTECS) plans to publish Thirukkural in Tamil, English, and a third language.

- This includes Maori, Scottish, and Albanian.
- The English translation will use work by Thomas Hitoshi Pruiksma.
- Thirukkural has been translated into over 70 languages worldwide.
- Supporting translations additional into languages, including those with fewer than five lakh speakers.
- TNTECS plans to translate other Tamil epics like Silappadikaram and Manimekalai.
- There will be 150 bilingual books released.
- The 2025 Chennai International Book Fair will feature sessions on self-publishing, the book trade, and children's literature.

### **1.7 CULTURAL PANORAMA**

#### Sky is the limit for development of tribes: President Droupadi Murmu

- · President Droupadi Murmu addressed the nation on the eve of Birsa Munda's birth anniversary (Janjatiya Gaurav Divas), emphasizing that India's true development depends on tribal communities' progress.
- She praised the government's commitment

to tribal development, highlighting a 74% increase in the Tribal Affairs Ministry's budget to Rs.13,000 crore.

Murmu recalled tribal freedom fighters who fought against British rule and shared her personal connection to tribal welfare, having started her public service career on the Tribal Advisory Council.

 She expressed optimism about tribal communities' future development prospects.

#### About Bhagwan Birsa Munda (1875 -1900)

 He was born in the Munda tribe at Ulihatu, Khunti district of the Chotanagpur Plateau region (Jharkhand). Also known as 'Dharti Aaba'.

#### Contributions

- Started faith of Birsait and stressed the importance of prayer, staying away from alcohol, and having faith in God.
- Started a movement called 'Ulgulan (The Great Tumult)' against the exploitation of tribals by local authorities.
- This led to the enactment of the Chotanagpur Tenancy Act (1908) which restricted the transfer of land from tribal people to nontribals.

#### Legacy

 His birth anniversary (on 15th November) is <sup>201</sup> celebrated as Janjatiya Gaurav Divas.

#### Guru Nanak Dev

Founder of Sikhism and Social Reformer

#### Historical Context and Life

- Guru Nanak Dev (1469-1539) emerged as one of the most influential spiritual leaders in South Asian history.
- Born in Nankana Sahib, Pakistan, he stablished Sikhism as a faith that would transform the religious and social landscape of the Indian subcontinent.

 His journey from a thoughtful young man to a revolutionary spiritual leader marked the beginning of a movement that continues to influence millions worldwide.

#### **Core Philosophy**

- At the heart of Guru Nanak's teachings lies a revolutionary understanding of divinity and human existence.
- His fundamental belief in "Ek Onkar" (One Universal Creator) challenged the prevailing religious orthodoxies of his time. This concept wasn't merely theological; it formed the foundation for a radical social philosophy that emphasized human equality and dignity.

#### Key Tenets and Innovations

- Social Reform Through Spiritual Practice
- Community Engagement
  - Introduced the concept of Langar (community kitchen)
  - Established Sangat (collective worship) as a cornerstone of spiritual practice
  - Created Pangat (eating together) to break social barriers
- Economic Justice
  - Advocated for "Kirat Karni" (honest labor)
  - Introduced "Vand Chakna" (sharing with others)
  - Established Dasvandh (voluntary tithing) for community development

#### **Spiritual Practice**

- Emphasized **"Naam Japna"** (meditation on divine truth)
- Rejected empty ritualism
- Integrated spirituality with daily life

### **1.8 ARCHEAOLOGICAL DISCOVERY**

#### News: 6,000-year-old stones discovered in Vembakkottai excavation

- PLACE : Sathur,
- During the ongoing Phase 3 excavation near Vembakkottai, stones called jasper and chert, which were used to make ornaments 6,000 years ago, were discovered on Friday.
- The Phase 3 excavation work has been ongoing since June 18.
- In this Phase 3 excavation, more than 2,800 archaeological artifacts have been discovered so far, including:

- Gold coin
- Copper coins
- Broken terracotta figurine
- Chess pieces
- Glass beads
- Circular discs

The archaeologists continue to uncover evidence of ancient civilization and craftsmanship at this important historical site.

### **1.9 SASTRI'S TAKE ON DRAVIDIAN-ARYAN DIVIDE**

#### Sastri's take on Dravidian-Aryan divide

- According to historian K.A. Nilakanta Sastri, both Dravidians and Aryans came to India in multiple waves over time, not in a single migration.
- Oxford Professor J. Burrow suggested that Vedic speech was influenced by "proto-Dravidian" language that existed before both Dravidian languages and Aryan arrival in India - though this was disputed by some scholars like Fürer-Haimendor
- Sastri emphasized that using "Aryan" and "Dravidian" as racial terms is scientifically

incorrect, citing Max Müller who strongly discouraged inferring race from language.

- He challenged the oversimplified notion that North India is purely Aryan/Brahmin/ Sanskrit while South India is purely Dravidian/ non-Brahmin/Tamil.
- Sastri **rejected** claims about **Tamil land being the origin of civilization** and the Indus Valley Civilization being created by Tamils, noting these weren't supported by scientific scholarship.

### **1.10 APPOINTMENTS**

#### Government appoints two Additional Advocate Generals

 Senior advocates K.Chandramohan and M. Sureshkumar have been appointed as Additional Advocate Generals of the Madras High Court.

#### Appointments - Who is who?

 President Droupadi Murmu has appointed K.Sanjay Murthy as the new Comptroller and Auditor General (CAG) of India. Murthy, an IAS officer from the 1989 batch, is currently the Secretary of the Department of Higher Education. He belongs to the Andhra Pradesh cadre.

- K Sanjay Murthy will assume the role of CAG from the date he takes office.
- He replaces Girish Chandra Murmu, who has served since August 8, 2020. Before this, Murthy was the first Lieutenant Governor of Jammu and Kashmir.

#### **Comptroller and Auditor General**

• K.Sanjay Murthy, former Secretary of the Central Higher Education Department, took charge as the country's new **Comptroller and Auditor General (CAG).** 

- Girish Chandra Murmu, who was serving as the Comptroller and Auditor General, retired last Wednesday.
- A **1989 batch** IAS officer from Himachal Pradesh cadre, he has extensive experience in public administration.

#### Hemant Soren as appointed as Chief Minister of Jharkhand

 Hemant Soren began his fourth term as Chief Minister of Jharkhand, sworn in by Governor Santosh Kumar Gangwar in Ranchi.

## The LAC agreement, the détentes and the questions

### **2.3 PUBLIC OPINION**

#### **Misuse of Copyright**

- Misuse of Copyright: The dispute highlights how copyright can be misused to suppress speech and silence opponents.
- South Indian actor filed a copyright infringement suit against other actress for using clips from their film without permission.
- Copyright law treats a film as an amalgamation of various components, each potentially having different copyright owners.
- The concept of 'fair dealing' under Section 52(1)(a) of the Copyright Act 1957 allows certain uses of copyrighted work without constituting infringement.

### 2.4 PROBLEMS IN CONDUCT OF PUBLIC ELECTIONS

## At 65%, Maharashtra clocks better turnout than in 2019

- Maharashtra recorded a voter turnout of 65.11% in the single-phase Assembly election, higher than the 61.6% turnout in 2019.
- Urban centers like Mumbai and Thane registered low turnouts, with Mumbai City at 52.07% and Mumbai Suburban at 55.77%.
- Naxalism-affected Gadchiroli district saw a high turnout of 73.68%, while Kolhapur recorded 76.25% and Bhandara 69.42%.
- Minor skirmishes were reported in Beed district, including vandalism of a polling booth and an assault on a local leader.

 Chief Electoral Officer S. Chockalingam noted that the voter experience in Mumbai was significantly better than during the Lok Sabha election earlier this year, with no complaints of long queues or inadequate facilities.

# Factors collectively contributed to the higher voter turnout compared to the previous election in 2019.

- **Improved Voter Outreach**: Extensive efforts by the Election Commission to reach out to voters and encourage participation.
- Ease-of-Voting Measures: Implementation of measures to make voting more accessible and convenient for the electorate.

- Better Arrangements: Enhanced arrangements at polling stations, including the deputation of municipal commissioners as election officers, 
   leading to a smoother voting experience.
- Increased Awareness: Greater awareness and education about the importance of voting and the electoral process.
- **High-Profile Participation**: The involvement of prominent figures, such as cricket legend Sachin Tendulkar, which can inspire and motivate people to vote.
  - **Peaceful Polling**: Despite minor incidents, the overall peaceful conduct of the elections likely encouraged more people to participate.

### 2.5 POLITICAL PARTIES AND POLITICAL SYSTEM IN INDIA

## The perfect cocktail of layered discrimination

- Delimitation involves recalibrating Lok Sabha seats per state based on population, currently frozen since 1971 census but may change by 2026.
- Non-Hindi states (Kerala, Tamil Nadu, West Bengal) have lower fertility rates (1.6-1.8) compared to Hindi heartland states (Bihar, UP, MP) with rates around 3.5.
- Post-delimitation, southern states' parliamentary representation would drop from 25% to 17%, while Hindi heartland states would increase from 40% to 60%.
- Developed states already receive only 30% of their tax contributions, while states like Bihar receive 250-350% of their contribution.
- Hindi-speaking population has grown from 36% to 43%, while other linguistic groups have decreased, threatening India's federal structure.
- Possible solutions include extending the freeze or permanent freezing of delimitation, creating new federal structure, or preserving

current seat proportions while **increasing total seats.** 

#### Total Fertility Rate (TFR)

 TFR is "a demographic indicator that estimates the average number of children a woman gives birth to during her reproductive years." The replacement level TFR is 2.1.

#### Context

- The delimitation of Lok Sabha seats in India is primarily addressed under Article 81 of the Indian Constitution.
- Article 82 complements this by stating that the Parliament must enact a Delimitation Act after each Census to readjust the number of seats in the Lok Sabha and their respective constituencies
- This process (delimitation) was suspended under Indira Gandhi's government until 2001
- Further suspended for 25 years by A.B.Vajpayee's government until 2026
- The freezing was done to avoid disincentivizing states that effectively controlled their population

### 2.6 PUBLIC AWARENESS & GENERAL ADMINISTRATION

#### Sanjiv Khanna Takes Charge as 51st Chief Justice of Supreme Court

- President Droupadi Murmu administered the oath of office. Sanjiv Khanna took charge today after D.Y. Chandrachud's retirement.
- Sanjiv Khanna will serve as Chief Justice of Supreme Court for 6 months. He will remain in office until May 13 next year
- Sanjiv Khanna began his career as a lawyer in 1983. He served as a lawyer for about 23 years. He was appointed as Delhi High Court Judge in 2016 and Supreme Court Judge in 2019.

#### **Important Judgments**

- He was part of the **5-judge constitutional bench** that delivered historic verdicts including cancellation of electoral bonds scheme for political party donations and confirmation of the abrogation of **Article 370** that granted special status to **Jammu-Kashmir**.
- A bench headed by him delivered a judgment on April 26 affirming the reliability and security of Electronic Voting Machines, refusing to ban their use in elections.
- He also ordered interim bail for Aam Aadmi Party's National Coordinator and then Delhi Chief Minister Arvind Kejriwal, who was arrested in the Delhi excise policy case, to campaign in the Lok Sabha elections.
- 5,000 additional Central Armed Police Forces (CAPF) personnel are being deployed in Manipur.
- Reason : There has been a surge in violence, resulting in at least 22 deaths.
- Confrontation between a special commando team and protesters in Jiribam district.
- Suspected activities of **Kuki militants**, were found in the Barak river in Assam

- The curfew in **Imphal East, Imphal West, and Bishnupur** districts was extended.
- Internet and mobile data ban extended in seven districts.
- Home Minister **Amit Shah** reviewed the security situation and deployment of security forces.
- Three cases of violent crimes against women and children have been handed over to the National Investigation Agency (NIA).
- Chief Minister **N.Biren Singh** chaired a meeting with **NDA legislators** to review the law-and-order situation.

#### **The Central Armed Police Forces**

- The Central Armed Police Forces (CAPF) is a collective term for the central police organizations in India, operating under the Ministry of Home Affairs.
- These forces were previously known as the "Central Para-Military Forces (CPMF)" but since 2011, India adopted the term "Central Armed Police Forces" to eliminate the word "paramilitary."
- CAPF is tasked with ensuring **internal security and guarding the borders**. There are seven security forces under this designation, all overseen by the **Ministry of Home Affairs**.

#### These seven security forces are

- Assam Rifles (AR)
- Border Security Force (BSF)
- Central Industrial Security Force (CISF)
- Central Reserve Police Force (CRPF)
- Indo Tibetan Border Police (ITBP)
- National Security Guard (NSG)
- Sashastra Seema Bal (SSB)

### 2.7 GOVT – WELFARE ORIENTED GOVT SCHEMES, THEIR UTILITY

- Government health spending in low and lower-middle income countries shows a concerning downward trend after an initial pandemic-related spike, threatening progress toward SDG health targets.
- Growth in health spending per capita from 2019-2023 has been minimal (0.4% in LICs (low income countries), 0.9% in LMICs (lower middle class income countries) compared to pre-pandemic growth (4.2% in LICs, 2.4% in LMICs), indicating a significant slowdown.
- The share of health in government budgets is declining as overall government spending grows faster than health expenditure, reversing pre-pandemic trends where health was gaining priority.
- 35 nations, including India, face particular risks with declining per capita health spending and reduced budget share for health. India's health spending dropped below 2% of the budget post-pandemic.
- Future outlook is concerning as 23 countries are projected to face government budget contractions from 2023-2029, which may force difficult trade-offs in maintaining health spending levels.
- The TeacherApp was launched by Union Minister for Education Dharmendra Pradhan.
- Developed by Bharti Airtel Foundation.
- Provides over 260 hours of resources, including courses, videos, and interactive sessions.

#### NEP 2020:

- The app aligns with the National Education Policy 2020.
- Emphasizes continuous teacher development to enhance student engagement and learning outcomes.

#### **One Nation - One Subscription**

- The Cabinet has approved several schemes including 'One Nation One Subscription', National Natural Farming Mission, two hydroelectric projects in Arunachal Pradesh, and the extension of the Atal Innovation Mission.
- The One Nation One Subscription scheme has been launched to support initiatives of Anusandhan National Research Foundation, which was established to enhance research in universities, colleges, and laboratories as per the New Education Policy recommendations to achieve the goal of Developed India.
- The scheme ensures quality higher education for youth.

#### **Rs 6,000 Crore Allocation**

- Under this scheme, Rs 6,000 crore has been allocated to implement a uniform subscription model across the country for accessing
   research papers and journals.
  - The scheme will be implemented for three years 2025, 2026, and 2027.
- It will be implemented in all higher education institutions nationwide, including central and state governments, and autonomous colleges under the University Grants Commission (UGC).
- Higher education institutions can access research papers and journals through the "One Nation One Subscription" portal developed by the Ministry of Higher Education.

#### **Natural Farming Mission**

- The National Natural Farming Mission will be launched to promote natural farming across () Scheme Overview 7.5 lakh hectares, benefiting 1 crore farmers. Rs 2. The "Bima Sakhi Yojana" focuses on women's 2,481 crore has been allocated for this project.
- The government plans to select interested panchayats to develop 15,000 agricultural groups and establish 10,000 natural input resource centers as needed.
- These centers will distribute natural resources and provide capital assistance up to Rs 1 lakh.

### 2.8 CENTER AND STATE RELATION

#### **Net Borrowing Ceiling (NBC) Caps** Kerala's Borrowing at 3% of GSDP

- In 2023, the central government set a 3% Net Borrowing Ceiling (NBC) of GSDP on Kerala, covering all borrowing methods, restricting development and welfare funding.
- Kerala has petitioned the Supreme Court to challenge the NBC under Article 293 of the Constitution, arguing it limits the state's constitutionally guaranteed fiscal autonomy.
- The Fiscal Responsibility and Budget Management (FRBM) Act enforces fiscal discipline with deficit targets, aiming to reduce the fiscal deficit to below 4.5% of GDP by 2025-26; states argue this curtails their financial autonomy.
- Proposals suggest strengthening Article 293 by creating a commission akin to the Finance Commission, setting clear guidelines for

the Center's control over state borrowing, ensuring transparency, consultation, and fairness to uphold cooperative federalism

#### **Role of Voluntary Organizations**

- Women gig workers in India held a first digital strike on Deepavali, organized by the Gig and Platform Services Workers Union (GIPSWU), protesting against exploitative labour practices by platform companies.
- Discounts offered by platform companies come at the expense of gig workers' wages, who face exploitative conditions.
- The narrative often highlights start-up job creation without examining the labour exploitation underlying rapid growth.
- The absence of strong labour and data privacy laws enables unchecked exploitation, with a call for grassroots organizing and policy reform.



**3. GEOGRAPHY** 

### **3.1 POLICY ON ENVIRONMENT AND ECOLOGY**

#### **First Global Tree Assessment**

- First Global Tree Assessment was published as part of an update to the IUCN Red List of Threatened Species, with its findings announced at the Convention on Biological Diversity (CBD COP16) in Cali, Colombia.
- The 2024 UN Biodiversity Conference of the Parties (COP) to the UN Convention on Biological Diversity (CBD) was held recently in Cali, Colombia with an objective to assess how countries are advancing towards the 2022 Montreal commitment to protect 30% of the planet's land and marine areas by 2030.
- The South Western Ghats of Kerala host Buchanania barberi, a small tree classified as Critically Endangered on the IUCN Red List since 2018.

#### Asia–Pacific (APAC) Climate Report 2024 🕕

- The Asian Development Bank (ADB) released its Asia-Pacific (APAC) Climate Report 2024, highlighting alarming economic impacts of climate change on the Asia-Pacific region.
- High-end greenhouse gas emissions, the APAC region could see a 17% reduction in Gross Domestic Product (GDP) by 2070.
- By 2100, this figure may surge to 41% under Collaborative high GHG emissions. communities,
- India may experience a **24.7% GDP** decline by

2070. Bangladesh faces a potential 30.5% loss, while Vietnam could see a 30.2% reduction, and Indonesia a 26.8% decline.

NEWS: The tiger population in western Assam's Manas National Park, a major wildlife preserve stretching into Bhutan, tripled from 2011 to 2019.

#### Location

- Manas National Park is in western Assam
- It's a cross-border preserve extending into Bhutan
- It's a UNESCO World Heritage Site
- One of Assam's two tiger reserves (the other being Kaziranga)
- Context:
  - Park previously suffered from prolonged armed conflict

#### **Current challenges include**

- Study suggests potential doubling of tiger numbers by 2023 (conditional on effective conservation measures).
- India's developing carbon credit mechanism, with focus on COP-29 Baku, Azerbaijan).
- India updated its Nationally Determined
   Contributions in 2023
- Established the Energy Conservation Amendment Act in 2022 for Carbon Credit Trading Scheme (CCTS).

#### It emphasizes two key lessons:

- Maintaining carbon credit integrity and aligning with global standards, particularly Article 6 of the Paris Agreement.
- The framework faces challenges like greenwashing in the voluntary carbon market (VCM) and issues with the Green Credit Programme (GCP).
- The Bureau of Energy Efficiency (BEE) plays a crucial oversight role, and the Voluntary Carbon Markets Integrity Initiative (VCMI) introduces a tiered system for credit claim assessment.
- It stresses the importance of transparency, third-party verification, and robust protocols to prevent double-counting while aligning with international standards.
- Green washing? Greenwashing is when a company makes misleading claims or false advertisements to suggest that they are more environmentally friendly than they actually are.
- VCM The voluntary carbon market (VCM) is a decentralised market where private actors

voluntarily buy and sell carbon credits that represent removals or reductions of **Green House Gases (GHGs)** in the atmosphere.

• The Bureau of Energy Efficiency (BEE) : To improve Energy Intensity of Indian Economy thereby contributing towards sustainable development of country.

#### COP29

- huge costs" were being levied upon India for the voluntary "climate action" it was undertaking.
- Countries are expected to update next year their voluntary commitments to curb emissions from the use of fossil fuel, known as Nationally Determined Contributions (NDC), the upper limit of carbon emissions that the atmosphere can support, to have a shot at preventing temperatures from going past the 1.5 degrees Celsius mark, it was likely to breached by the end of the decade, India noted.

#### **New frog species**

- Scientists from SACON have identified a new frog species in Meghalaya, named 'Raorchestes asakgrensis'. This discovery took place over two years, from October 2020 to January 2022.
- The research team surveyed various locations in the Garo and Khasi Hills, which were

published in the journal Herpetozoa on It is the first-ever effort by the Indian November 18.

#### **Discovery Process**

- They captured and photographed the frogs for further analysis.
- The team documented their observations meticulously to describe the new species accurately.

#### **Naming the Species**

- The new species is named after the Eman Asakgre Community Reserve, which honours the local community that supported the researchers during their study.
- It reflects a commitment to recognising Indigenous contributions to scientific research.

### Air pollution in India has escalated beyond an environmental concern to a severe health and economic crisis.

#### **Health Impact**

- Air pollution is the leading environmental risk to health and the cause of premature deaths, with nearly 2 million deaths in India in 2021.
- Vulnerable groups like pregnant women, children, the elderly, and those with existing health conditions face higher risks.

#### National Clean Air Programme (NCAP)

- The National Clean Air Programme (NCAP) was launched by the Ministry of Environment, Forest and Climate Change (MoEFCC) at the start of 2019.
- To improve the air quality of 131 cities across 24 states/UTs in India.

- government to provide a national-level framework with time-bound reduction.
- India is the third most polluted country in the world.
- Out of the 50 most polluted cities, 42 were in India according to the IQAir report 2023.
- With the right to a healthy environment as part of Article 21, the programme seeks to reduce the concentration of atmospheric Particulate Matter (PM) by 20-30% by 2024.
- This was later revised to 40% and to be achieved by the year 2025-26.

#### **Eco-sensitive Zones (ESZs)**

- Areas around national parks and wildlife sanctuaries, serving as "shock absorbers" for protected areas.
- Usually extend within 10 km of these boundaries, but can vary.
- Function as transition zones from higher protection to lesser protection areas.
- Not intended to disrupt local daily activities but to safeguard and enhance the environment.

#### **Policy Frameworks**

#### Two significant reports

- Gadgil report: Advocated strong environmental regulations and extensive ESZs.
- Kasturirangan Recommended report: a balance, reducing ESZ areas for developmental needs.

#### **Recent Developments in Kerala**

 2013, Kerala proposed 9,993.7 sq km as ESZs, But in 2019, Proposal reduced to 8,656 sq km.

 In May 2024 ,Kerala included 12 villages from Wayanad district as ESZs.

#### India's largest saline wetland

- Sambhar Lake is India's largest inland saltwater lake at 230 sq km, spread mostly across Jaipur and Nagaur districts and also a part of Ajmer.
- It has a catchment area of **5,700 square km**, with the water depth fluctuating between 60

cm in the dry season to about 3 metres at the end of the monsoon.

• When the monsoon arrives in July, the lake erupts with delight, accompanied by the chirping of avian species such as **coots**, **blackwinged stilts**, **sandpipers**, **and redshanks**.

Sambhar Lake has also been classified as a Ramsar Site.

### **3.2 MISCELLANEOUS**

#### **First Green Hydrogen Fuelling Station**

- Iindia has recently inaugurated its first green hydrogen fuelling station in Leh, Ladakh, which is milestone in the green mobility sector.
- The project was completed by Amara Raja Infra for NTPC Ltd, which aims to promote emission-free transport in the region.

#### **Project Overview**

 The green hydrogen fuelling station is part of a broader green mobility initiative, which enables the operation of hydrogen fuel cell buses in Leh.

#### **Station Specifications**

- The fuelling station can produce 80 kg of green hydrogen daily.
- It was constructed at an altitude of 3,400 meters.

#### **Operational Details**

- 2 NTPC will operate five hydrogen fuel cell buses in the region.
  - The project includes three years of operation and maintenance for all systems. This ensures the fuelling station runs efficiently



4. ECONOMICS

### 4.1 CURRENT SOCIO-ECONOMIC PROBLEMS

## India's urban infrastructure financing, needs and reality

#### **Urban Population and Financing Needs**

- India's urban population is expected to double from 400 million to 800 million over the next three decades.
- India needs approximately Rs.70 lakh crore by 2036 to meet urban infrastructure needs.
- Current annual investment in urban infrastructure is around Rs. 1.3 lakh crore, only a quarter of the required Rs.4.6 lakh crore.

#### **Municipal Finances and Challenges**

- Municipal finances have remained stagnant at 1% of GDP since 2002.
- Municipal bodies contribute 45% of urban investments; the rest is managed by parastatal agencies.

• Municipalities' own revenue sources declined from 51% to 43%.

#### **Public-Private Partnerships and Future Steps**

- PPP investments in urban infrastructure have dropped significantly over the past decade.
- Strengthening State finance commissions and empowering municipal governments is crucial.
- Developing a pipeline of 600-800 projects to meet investment needs.

#### **Collaboration and Sustainable Development**

- Addressing financial and structural challenges requires collaboration across government levels and private sector participation.
- Emphasizing innovation and efficient governance to meet the demands of growing cities.

### 4.2 NEW ECONOMIC POLICY & GOVT. SECTOR

- India's GDP growth for July-September 2024 is expected to decrease to 6.5%, the slowest in one and a half years, due to elevated food prices reducing household spending.
- The Reserve Bank of India (RBI) forecasts a rebound to 7.6% growth in the current quarter, driven by festival-related consumption.
- Sustained economic growth above 8% is needed to generate sufficient employment for India's growing youth population; current slowdown raises concerns about meeting

employment demand.

- Challenges: High food inflation, reduced consumer spending, and weakened industrial activity are key challenges affecting GDP growth.
- Slow pace of capital expenditure by both states and the central government is a major concern, but rural demand and agricultural growth are expected to support future growth.
- The Ministry of Statistics and Programme Implementation came into existence as an

Independent Ministry on 15th Oct 1999, after the merger of the Department of Statistics and the Department of Programme Implementation.

- The Statistics Wing called the National Statistical Office (NSO) consists of the Central Statistical Office (CSO), the Computer centre and the National Sample Survey Office (NSSO).
- The Programme Implementation Wing has three Divisions, namely,
  - Twenty Point Programme

- Infrastructure Monitoring and Project Monitoring
- Member of Parliament Local Area Development Scheme.
- Besides these two wings, there is National Statistical Commission created through a Resolution of Government of India (MOSPI) and one autonomous Institute, viz., Indian
- Statistical Institute declared as an institute of National importance by an Act of Parliament.

### **4.3 CURRENT TRENDS IN INDIAN ECONOMY**

#### **10-year Sovereign Green Bonds**

 The Reserve Bank of India (RBI) has expanded the list of Government securities available for non-resident investment under the Fully Accessible Route (FAR) by designating 10-year Sovereign Green Bonds (SGrBs) as 'specified securities.' These bonds will be issued by the government in the second half of the fiscal year 2024-25, aligning with the increasing global inclusion of Indian Government Securities (G-Secs) in international bond indices, such as JPMorgan Chase's GBI-EM GD index, Bloomberg EM Local Currency Government indices, and FTSE Russell's EMGBI.

#### **10-Year Sovereign Green Bonds in FAR**

 The RBI's move to include 10-year Sovereign Green Bonds under FAR comes as the government plans to issue these bonds as part of its borrowing program in FY2024-25.

#### India should join RCEP and CPTPP

• BVR Subrahmanyam, CEO of NITI Aayog, suggests India should join RCEP and CPTPP.

#### **Background:**

- RCEP (Regional Comprehensive Economic Partnership): A 15-country FTA (Free Trade Agreement), including ASEAN (Association of Southeast Asian Nationsnations) and China. India was part of initial negotiations but left just before finalization.
- CPTPP (Comprehensive and Progressive Agreement for Trans-Pacific Partnership): An 11-country FTA, including Canada, Japan, and Australia, evolved from the Trans-Pacific Partnership.

#### **Provisions Beyond India's Practice:**

• RCEP and CPTPP include (MFN and FET) principles, missing in India's current treaties.

#### MFN (Most Favored Nation)?

• It is a principle in international trade that

ensures equal treatment among countries. When one country grants MFN status to another, it agrees to extend the same trade advantages, such as low tariffs or high import quotas, that it provides to its most favored trading partners. This principle is a cornerstone of the World Trade Organization (WTO) agreements, aimed at promoting nondiscriminatory trade practices among member nation

#### FET (Fair and Equitable Treatment) ?

 It is a fundamental principle in international investment law, primarily found in Bilateral Investment Treaties (BITs) and other international investment agreements (IIAs). This standard aims to protect foreign investors by ensuring that they receive just and unbiased treatment from host states.

India would need to deviate from its 2015 Model BIT (Bilateral Investment Treaty) for RCEP and CPTPP.

#### (Bilateral Investment Treaty)?

An agreement establishing the terms and conditions for private investment by nationals and companies of one state in another state. These treaties aim to promote and protect foreign investments through various protections like fair and equitable treatment, and dispute resolution mechanisms.

### **4.4 REPORTS AND INDICES**

#### **Henley Passport Index**

- The Henley Passport Index revealed that Singapore holds the title of the world's most 201 powerful passport.
- Singaporean citizens can travel to 195 countries without needing a visa.

#### **Henley Passport Index Overview**

 The Henley Passport Index ranks passports based on the number of destinations their holders can access without a visa.

 The index is a useful tool for understanding global mobility and the strength of a country's passport.

#### **Top Rankings**

- Singapore: 1st place, 195 countries.
- France, Germany, Italy, Japan, Spain: 2nd place, 192 countries.
- United States: 8th place, 186 countries.
- India: 83rd place, 58 countries. These rankings reflect the ease of travel for citizens of these countrie



# **5. SCIENCE**

# 5.1 LATEST INVENTIONS ON SCIENCE AND TECHNOLOGY

## GM crops can help fight hunger depending on farming method

- **Population Growth and Food Demand:** The world's growing population necessitates more food production without indiscriminately expanding agricultural land or using excessive pesticides.
- Genetically Modified (GM) Crops: GM crops, like Bt cotton and Bt brinjal, have been developed to resist insects by incorporating genes from Bacillus thuringiensis, reducing the need for insecticides.
- Herbicide-Tolerant (HT) Crops: HT GM crops are resistant to specific herbicides, allowing farmers to target weeds without harming the crops, which helps reduce tilling and carbon emissions.
- Health and Environmental Impact: While consuming GM crops shows negligible adverse health effects, the broader farming methods have complex impacts on human health and the environment.
- **Resistance Development:** Pests can develop resistance to GM traits over time, necessitating diversified GM crop planting and the inclusion of multiple resistance genes to maintain efficacy.
- Regulation Costs and Accessibility: The high cost of regulating GM crops limits their development to a few major companies, making it challenging for government institutions and smaller companies.

• Sustainable Pest Management: Integrated pest management and crop rotation are recommended to reduce reliance on agrochemicals and prevent resistance, balancing between the extremes of no pesticide use and current intensive practices.

#### BOMB CYCLONE

- Definition: A bomb cyclone is a powerful winter storm characterized by a rapid drop in atmospheric pressure, at least 24 millibars in 24 hours.
- Approaching Storm: An upcoming bomb cyclone is set to impact the US West Coast, predicted to drop nearly 70 millibars in one day, potentially reaching 942 millibars, similar to a Category 4 hurricane.
- Formation: Bomb cyclones form when warm, moist air collides with cold Arctic air, creating a rapidly intensifying storm. The term was coined in the 1980s, likening the storm's intensification to an explosion.
  - **Atmospheric River**: The storm will merge with an atmospheric river, a narrow band of concentrated moisture, leading to substantial rainfall and snowfall across several states.
  - **Rainfall Predictions:** California is expected to receive approximately 8 trillion gallons of water, Oregon and Washington 5 trillion and 3 trillion gallons, respectively, and Idaho around 2.5 trillion gallons, totaling nearly 20 trillion gallons across the western US.

- Potential Effects: Coastal regions may face erosion and flooding, inland areas are at risk of flash floods and mudslides, and mountainous regions could experience record snowfall.
- Precautionary Measures: Residents are advised to stay updated on weather changes and follow evacuation orders from local authorities
- A year-long study by (Sálim Ali Centre for Ornithology and Natural History) SACON, Coimbatore, indicates an exponential rise in the peafowl population in Tamil Nadu.
- The study estimated a mean population size of about 61 lakh peafowl and a minimum of about 38 lakh.
- A total of 1,025 peafowl were sighted in 32 of the 38 districts, but data revealed their presence in all 38 districts.
- The study addressed crop damage caused by peafowl, with 78.70% of farmers reporting damage and 82.88% saying it was a daily occurrence.
- From 2011 to 2023, 1,345 peafowl deaths were reported due to pesticide poisoning, electrocution, and vehicular accidents, with the highest mortality in March.
- The disappearance of mesocarnivores like jackals and foxes from Tamil Nadu's plains is linked to the rise in peafowl population.
- The increasing peafowl population poses a significant concern for farmers, damaging crops like maize, tomato, chilli, millets, and paddy. Farmers use plastic tape and dogs to keep peafowl away due to the ineffectiveness of fencing.
- Indian peafowl : scientifically known as Pavo cristatus, is currently classified as a species of Least Concern by the International Union for Conservation of Nature (IUCN), indicating that its population is stable. This species is primarily found across the Indian subcontinent, including India and Sri Lanka,

and has been introduced to various other regions worldwide

#### ) Aphantasia

- A study by Roberto S. Luciani and colleagues at the University of Glasgow examines the relationship between auditory and visual senses in people with aphantasia.
- Individuals without aphantasia show strong neural activity in the visual cortex in response to auditory stimuli, while those with aphantasia show significantly weaker neural activity.
- The study supports the idea that mental visualization exists on a spectrum, with aphantasia at one end.
- The research highlights unique variations in human cognitive processes, challenging previous assumptions about uniform brain functions.
- The study underscores the interconnectedness of different brain regions, even in individuals with limited visual imagination.
- Aphantasia is a condition where individuals
   cannot create mental images, first observed by Francis Galton in the 1880s and named by Adam Zeman in 2015.
- Aphantasia is relatively rare, affecting about 2% of the population.
- People with aphantasia may not create mental images from sounds or dreams but can be creative in other ways like writing or problemsolving.
- Aphantasia occurs due to differences in the brain's ability to imagine.
- Aphantasia is not considered a problem; people with the condition can live normal, happy lives and may not realize they have it until asked to imagine something

## Recent research in Harvard Medical School

- Cellular Learning: Recent research suggests human cells can exhibit a form of learning known as habituation.
- **Definition of Habituation**: Habituation is the process where an organism stops responding to repeated stimuli over time.
- **Research Details**: The study was conducted by researchers from **Harvard Medical School** and the **Centre for Genomic Regulation**, published in Current Biology.
- **Findings**: Four molecular networks within cells exhibit habituation, functioning similarly to animal brains. Two types of cellular memory were identified, with one fading quickly.
- **Implications**: The research raises questions about cellular capabilities, potentially explaining chemotherapy resistance in cancer cells and antibiotic resistance in bacteria.
- Further Research: More studies are needed to validate these findings and gather real-world biological data.
- Centre for Genomic Regulation: This Spainbased center focuses on understanding gene functions and their implications in health and disease.
- Current Biology: A scientific journal that publishes research on various biological topics, including cellular processes and evolution.
- **Ciliate**: Single-celled organisms with hairlike structures that exhibit primitive learning abilities similar to animals.

### Moiré Materials- superconductivity What is super conductors ?

- **Definition**: Superconductors are materials that can conduct electricity with zero resistance below a certain temperature.
- Critical Temperature (Tc): The specific temperature at which a superconductor's

resistance drops to zero.

• **Zero Resistance**: Below the critical temperature, superconductors conduct electricity without any resistance.



- Low Energy State: Most materials must be in an incredibly low energy state (very cold) to become superconductive.
- **Cooling Process:** Currently, a significant amount of energy is required to cool materials to achieve superconductivity, making it uneconomical and inefficient.
- **Research and Development:** Studies are ongoing to design compounds that can become superconductive at higher temperatures, aiming to make superconductors more practical and cost-effective.
- Moiré Materials: Created by stacking two layers of the same material (e.g., graphene) and twisting one layer slightly, resulting in a unique moiré pattern.
- **Superconductivity:** Moiré materials made from semiconductors, like tungsten diselenide (tWSe), not just graphene ,This can also exhibit superconductivity .
- Flat Bands: The twist in moiré materials leads to the formation of flat energy bands, causing electrons to move slowly and interact strongly.

- **Cooper Pairs:** Strong electron-electron interactions in flat bands lead to the formation of Cooper pairs, essential for superconductivity and zero resistance.
- **Recent Study**: tWSe2 with a twist angle of 3.65° showed superconductivity at a transition temperature of around–272.93° C when electronic states were half-filled.
- Stability: tWSe2's superconducting state is robust and more stable than graphene-based moiré materials, driven by electron-electron interactions and half-band filling.
- **Insulating State**: The moiré material can transition to an insulating state by altering its electronic properties.

#### **Palpares contrarius**

 Researchers identified Palpares contrarius on the Madras Christian College (MCC) campus, a new species of antlion in Tamil Nadu, which marks addition to the region's biodiversity.

#### **Identification Features**

- Palpares contrarius resembles a dragonfly, which has distinct antennae and a unique fluttering flight.
  - Antennal structure helps differentiate it from similar insects. Adults are elusive and primarily nocturnal.

#### Habitat and Distribution

- Antlions are prevalent in several countries.
- They are found in Africa, Myanmar, Thailand, and Sri Lanka. In India, they inhabit states like Odisha, Maharashtra, Karnataka, Mizoram, Uttarakhand, and Madhya Pradesh.
- The discovery of this species in **Tamil Nadu** is unprecedented.

#### **Research and Publication**

- Anita Pearline Esther, an entomologist at MCC, documented this finding.
- The research was published in the Journal of Threatened Taxa.
- The specimen has been preserved at the Zoological Survey of India in Chennai.

### 5.2 SPACE

#### Rocket, Satellite Research Center: IIT Chennai - ISRO Agreement

IIT Chennai has signed a Memorandum
 of Understanding with ISRO regarding
 the establishment of a satellite and rocket
 temperature research center.

#### Press release from IIT Chennai regarding

- A special Fluid and Thermal Research Center will be established at IIT Chennai with ISRO's support. A Memorandum of Understanding for this was signed at IIT
- ISRO is providing financial assistance of Rs.
   1 crore and 84 lakhs for establishing this research center.

- Temperature management research related to rockets and satellites will be conducted here. IIT professors will provide technical assistance for temperature-related issues that arise during the testing of rocket and satellite design and various components.
- It has been stated that this will greatly encourage collaborative efforts between ISRO scientists and IIT professors engaged in new discoveries in fluid and thermal sciences

#### SpaceX's Falcon-9 deploys Indian Satellite into Orbit

 India's GSAT-N2 (GSAT-20) communication satellite was successfully launched by SpaceX's Falcon-9 rocket

- At Cape Canaveral Space Force Station in Florida, Falcon-9 put the GSAT-N2 into a geosynchronous transfer orbit.
- GSAT-N2 is a Ka-band high throughput communication satellite of NewSpace India Limited.
- Ka-band refers to a segment of the microwave part of the electromagnetic spectrum, specifically encompassing frequencies from 27 GHz to 40 GHz.
- This frequency range **provide high data transfer rates and wide bandwidth.**
- The satellite is set to enhance broadband services and in-flight connectivity across the Indian region.
- This satellite, featuring multiple spot beams and wideband Ka x Ka transponders.
- Aims to support a large subscriber base with small user terminals, significantly boosting system throughput through its multi-beam architecture which allows frequency reuse
- The **GSAT-N2** satellite, with a lift-off mass of **4,700 kg**, **has a mission life of 14 years**.
- This is India's first collaboration with Elon Musk's SpaceX.

#### World's First Twin Satellite Launch Project designed for solar research

- The European Space Agency's twin satellites, designed for solar research, will be launched by ISRO using a PSLV rocket on December 4.
- The European Space Agency has developed twin satellites to study the Sun's corona. This project has been named Proba-3.

 The two satellites are equipped with laser zone and reflector instruments to conduct research while flying in tandem.

#### "PSLV C-59 Set to Launch European Satellite on December 4"

- The PSLV C-59 rocket is scheduled to launch on December 4th carrying the European Space Agency's 'PROBA-3' satellites, designed to study the Sun's outer atmosphere.
- New Space India Limited, operating under the Indian Space Research Organisation (ISRO), has been conducting commercial operations to launch foreign satellites.
- The ESA's PROBA-3 satellites will be positioned in an orbit 60,500 kilometers from Earth by the PSLV C-59 rocket, where they will study the Sun's outer radiation.

## "India's First Al Laboratory to Launch in Space Soon"

- Hyderabad-based Tech Me 2 Space, an innovative company, is set to establish an artificial intelligence (AI) laboratory in space.
- The Mission Orbital Infrastructure -Technology Demonstrator (MOI-TD), an AI laboratory designed to facilitate costeffective space research, will be India's first AI laboratory in space.
  - The MOI-TD is scheduled to be launched into space this December via ISRO's PSLV-60 rocket. This laboratory is being established to provide users with direct access to space data, reducing data transfer costs and delays.

#### **5.3 LATEST DISCOVERIES IN HEALTH SCIENCE**

#### Global Tuberculosis Report – 2024

- TB has likely returned to being the world's leading infectious disease killer in 2023
- Five countries account for 56% of global TB cases: India (26%), Indonesia (10%), China (6.8%), Philippines (6.8%), Pakistan (6.3%)
  - India accounts for 26% of global TB cases
  - Highest TB burden globally
  - Making significant progress in TB notification and treatment
- **Risk factors**: Key risk factors include undernutrition, alcohol use disorders, smoking, and diabetes.
  - Social determinants like poverty, income inequality, and poor living conditions significantly impact TB spread

### Telcos cast satellite Internet as a threat to terrestrial networks

- CRUX : The conflict between telecom operators (like Reliance Jio) and satellite internet providers (like SpaceX's Starlink) regarding
- Whether satellite internet services should <sup>201</sup>. The require spectrum auctions in India
- Spectrum Auction: A process where government sells rights to transmit signals over over specific bands of the electromagnetic spectrum)
- Purpose: Allocate scarce radio frequencies to telecommunication companies
- Concerns over satellite capacity and coverage, with specific numbers being debated:
  - Starlink's projected 35,000 satellites globally
  - Potential 500-600 satellites over India
  - India representing 0.6% of world's surface area

 Wayforward: This shows a significant policy debate in India's telecommunications sector regarding the regulation and implementation of satellite internet services.

#### Scientists have discovered that mpox (formerly known as monkeypox) clade la has evolved to achieve sustained human-to-human transmission.

- TB Adding to growing concerns about the virus's evolution. This is particularly significant because previously, clade Ia only caused ers, sporadic infections from animals to humans since its discovery in 1970.
  - There are four known variants of mpox: Ia, Ib, IIa, and IIb
    - Clade IIb was responsible for the 2022 outbreak
    - Clade Ib is currently causing infections in central Africa
    - WHO has declared mpox a public health emergency twice in two year

The evidence for human-to-human transmission comes from studying mutations in the virus's DNA.

- Researchers found that 63% of mutations in clade Ia infections were consistent with changes introduced by APOBEC (a human immune system protein family).
- This protein introduces random changes in foreign DNA as a defense mechanism.

#### Food prices spur inflation to 6.2%

- Overall Inflation Rate: India's retail inflation jumped to 6.2% from 5.5%, hitting a 14-month high and breaching RBI's upper tolerance limit.
- Food Inflation Driver: The main cause was a 10.9% surge in food prices, with urban areas

seeing food inflation cross **11.1% and rural** areas at 10.7%.

- Vegetable Price Spike: Vegetable prices saw a dramatic 42.2% increase - the highest in 57 months (nearly 5 years), up from 36% in September.
- Edible Oil Crisis: Edible oil prices increased by 9.5%, the highest in nearly two years, driven by a 27% rise in global prices due to Southeast Asian supply disruptions.
- **Regional Impact:** Rural India faced sharper inflation at 6.7% compared to urban areas at 5.6%.
- **RBI Implications:** This spike makes interest rate cuts unlikely in RBI's December review, challenging their Q3 (QUARTER ) projection of **4.8% average inflation.**
- Reason : disruption in South East Asia

#### 210 Million People Affected in India: Lancet Study Reveals

- A long-term 32-year study was conducted on diabetes across 4 major population groups.
- The study covered a total population of 212 million people, including:
  - India: 146 million people
  - China: 36 million people
  - USA: 27 million people
- Various factors were examined including age differences, lifestyle changes, and dietary habits.
- This study helped understand the spread of diabetes and its impacts.
- It is considered a crucial study that will help develop new methods to control and prevent diabetes.

## Turritopsis dohrnii (The Immortal Jellyfish)

- Nicknamed **"immortal jellyfish**" due to unique regeneration abilities
- Can reverse its aging process when stressed or damaged
- Transforms adult cells back to polyp stage through transdifferentiation
- First scientific description in 1883
- Natural habitat includes Mediterranean Sea and Worldwide Oceans
- Only known animal capable of reverting to earlier life cycle stage

#### State of the Climate 2024 Report (WMO) Key Findings:

- 2024 projected to be warmest year on record
- January-September temperature 1.54°C above pre-industrial levels
- Global sea level rise rate: 4.77mm/ year (2014-2023)
- Rate doubled compared to 1993-2002 period
- India faced extreme weather on 93% of days in first 9 months

• The centenary celebrations of the iconic "Bose-Einstein" Statistics were inaugurated by Union Minister Dr. Jitendra Singh at the S.N. Bose National Centre for Basic Sciences in Kolkata.

- The event honored the contributions of Indian
   physicist Satyendra Nath Bose and highlighted
   India's strides in quantum research.
- The celebrations included international conferences and outreach programs, focusing on Bose Statistics in Condensed Matter Physics, Quantum Information, and Quantum Science.
- The Minister also emphasized the recently launched National Quantum Mission (NQM), which aims to position India at the forefront of quantum technology

#### IISc, published - Biophysical Journal

- Cancer Cell Study Recent research from IISc, published in the Biophysical Journal, investigates how the microenvironment influences the movement of cancer cells, focusing on metastasis.
- The study examines two ovarian cancer cell lines, OVCAR-3 (rounded shape) and SK-OV-3 (elongated shape), both capable of invading surrounding tissues.
- Researchers used soft surfaces to simulate healthy tissue and stiff surfaces to mimic

scarred tissue around tumors, observing cell movement under these conditions.

- On soft surfaces, both cell types exhibited slow and random movement. On stiff surfaces, OVCAR-3 cells moved more than SK-OV-3 cells and displayed a unique "slipping" movement pattern.
- The research team plans to explore the mechanisms driving these movements in more intricate 3D environments to better understand ovarian cancer's rapid spread and treatment challenges.

#### M-Pox a Public Health Emergency of International Concern

- The World Health Organization (WHO) has declared M-Pox a Public Health Emergency of International Concern (PHEIC), which follows a rise in cases worldwide.
- The WHO Emergency Committee met recently to assess the situation.
- Concerns focus on a new variant known as clade Ib, which originated in the Democratic Republic of Congo.
- Cases of M-Pox are increasing, which has spread to various countries, including the UK, Germany, Sweden and India. The outbreak is now classified as global.

### 5.4 MASS MEDIA & COMMUNICATION

#### India's 6Ghz spectrum dilemma is affecting PS5 Pro console launch in India

- Traditionally, WiFi has used 2.4GHz and 5GHz bands.
- In 2021, several countries began de-licensing the 6GHz spectrum for WiFi, but India and China have not yet allowed its use.

• PS5 Pro Console Launch: Released in key markets globally, but not in India due to the unavailability of the 6GHz wireless band for WiFi 7.

#### WiFi Bands and Technology

• 4GHz covers larger areas with limited bandwidth; 5GHz is faster but covers shorter distances.

 WiFi 6 uses 2.4GHz and 5GHz with greater efficiency. WiFi 6E introduced 6GHz spectrum for higher speeds (up to 9.6Gbps).

#### **6GHz Spectrum in India**

- The 6GHz band in India is currently allocated to ISRO for satellite use.
- Telecom operators and tech companies are *Future Prospects* WiFi use.

#### **Regulatory and Industry Response**

• The International Telecommunications Union. • WiFi 7 doesn't require 6GHz to function and aims for uniform wireless frequencies, but many countries haven't agreed on 6GHz usage.

- Telecom operators want 6GHz for telecom, while tech companies advocate for its allocation to WiFi.
- The Indian government might follow a balanced approach like Australia, de-licensing part of the spectrum.

- pushing for 6GHz allocation for 5G, 6G, and Other devices (Apple, Samsung) can avoid connecting to 6GHz spectrum in India; Sony could adopt similar measures for PS5.
  - can work with existing bands for improved efficiency and speed.

### 5.5 NEW SCIENTIFIC LABORATORIES/ **OBSERVATORIES/ CENTRES**

#### Alarming rate of decrease in African **Elephant count**

- African elephants, Earth's largest land mammals, face severe population decline across the continent, as revealed in a comprehensive study spanning 1964-2016.
- The research covered 475 sites across 37 African countries, examining both savannah and forest elephant species.

#### **Population statistics show:**

- Savannah elephants: 70% decline
- Forest elephants: 90% decline
- Overall average decline: 77%
- Primary threats identified: Poaching, Habitat loss.

- Regional variations:
  - Northern/Eastern Africa: Severe losses, especially in Mali, Chad, and Nigeria
  - Southern Africa: Population growth in 42% of surveyed sites
  - Improved areas : Botswana, Zimbabwe, and Namibia
- Forest elephants are particularly vulnerable, with population numbers approximately onethird of savannah elephants.
- As of 2016, the combined population estimate for both species was between 415,000 and 540,000 elephants.

#### **Proba-3 Spacecraft**

- ISRO will launch the European Union's Proba-3 spacecraft next month from Sriharikota using the PSLV-XL rocket.
- It will help study the corona, the bright halo region of the Sun.
- This will be the world's first mission to precisely study the Sun.
- India plans to establish a space station by 2035 and land the first Indian astronaut on the Moon by 2040.

#### Shilp Samagam Mela 2024

- The Union Ministry of Social Justice and Empowerment launched the 'Shilp Samagam Mela 2024' at Dilli Haat, New Delhi.
- This event aims to showcase and promote traditional handicrafts from various states in India.
- It is organized by three key corporations under the Ministry: NSFDC, NBCDFC and NSKFDC.

#### The TULIP Initiative

 During the event, Dr.Kumar launched the 'TULIP' programme. This stands for Traditional Artisans' Upliftment Livelihood Programme. TULIP aims to empower marginalised artisans. It provides them with an online platform for global exposure and sales of their products. The initiative primarily targets artisans from Scheduled Castes (SC), Other Backward Classes (OBC), sanitation workers, and persons with disabilities.

#### Easy Educational Loans for Higher Education Students

 The Union Cabinet has approved the Prime Minister's 'Vidya Lakshmi Scheme' to facilitate easy educational loans for students gaining admission to the country's top government and private higher education institutions.

### According to NIRF's recent rankings, the scheme will be launched in:

- Government and private higher education institutions ranked in the top 100 overall and in other categories
- State government higher education institutions ranked between 101-200

#### The central government will provide:

- 75% guarantee for loans up to Rs. 7.5 lakhs
- 3% interest subsidy on educational loans up to Rs. 10 lakhs for students from families with annual income up to Rs. 8 lakhs and who are not benefiting from any other scholarship or interest subsidy schemes

This interest subsidy will be provided to one lakh students per year.

### First All-Women CISF Battalion: Central Government Approval

 The central government has approved the formation of the country's first all-women battalion in the Central Industrial Security Force (CISF) with over thousand personnel.

#### CISF Establishment: June 15, 1983

- The CISF, which has about 180,000 personnel, (1)• In conjunction with the Mandala Puja is responsible for protecting VIPs, Parliament, Delhi Metro stations, 68 airports nationwide, and important historical monuments.
- The Home Ministry has issued a notification approving the creation of the country's first all-women battalion comprising 1,025 female personnel under a senior commander.

#### Debating the healthy longevity initiative

- World Bank's 2024 report projects global deaths to increase from 61 million (2023) to 92 million (2050), with (Non Communicable Disease) NCDs being the leading cause, especially in Low-and Middle-Income Countries (LMICs).
- India has the world's second-largest elderly population (140 million aged 60 vs China's 250 million), with growth rate 3 times higher than overall population growth.
- NCDs in India are projected to account for 75% of all deaths by 2030, with cardiovascular diseases, cancer, respiratory illness, and diabetes causing 50% of current deaths.
- Key risk factors: tobacco use, alcohol abuse, obesity, sedentary lifestyle, and diets high in simple carbohydrates and saturated fats.
- Ayushman Bharat Scheme aims to provide health insurance to bottom 40% households but faces challenges like inadequate funding, strict eligibility criteria, and corruption (revealed in CAG 2023 report).
- Supreme Court directed central government to regulate hospital procedure rates due to inflated private healthcare costs.

#### "Swami AI Chatbot" App to Help Sabarimala Devotees

pilgrimage, an Artificial Intelligence (AI)powered conversational chatbot called Swami AI Chatbot is set to be introduced to assist



devotees visiting Sabarimala. The logo of this application was released by Kerala Chief Minister Pinarayi Vijayan.

- To prevent overcrowding, the Kerala government has decided to allow only 80,000 devotees who register online daily and 10,000 walk-in devotees this year.
- The chatbot will provide detailed information about puja timings, railway and airport facilities in Malayalam, Tamil, English, Hindi, Telugu, and Kannada languages.
- During this year's holy pilgrimage season, the chatbot will ensure a more convenient, accurate, and safe pilgrimage experience for Ayyappa devotees.

#### **Constitutional Museum in Haryana**

 Lok Sabha Speaker Om Birla is set to inaugurate India's first Constitutional Museum, which has been magnificently established at Jindal Global University in Haryana.

- An advanced guide robot, developed by a uteration team of IIT Chennai students to assist visitors to this museum, was introduced in Chennai.
- The university has set up the Constitutional Museum spanning 10,000 square feet to create public awareness about the Indian Constitution.

#### **Special Features:**

- The museum features statues and paintings of over 300 people including Ambedkar, Rajendra Prasad, K.M. Munshi, who were instrumental in creating the Indian Constitution. It also houses the original copy of the Indian Constitution, descriptive sculptures, exhibitions, paintings, and commemorative postage stamps.
- The museum will be inaugurated by Lok Sabha Speaker Om Birla on November 26th, the day when the Indian Constitution came into effect.
- AI Technology... IIT Chennai has developed an advanced guide robot to assist visitors to this museum. The robot has been designed with Artificial Intelligence technology.
- It will explain the special features of the museum to visitors in Hindi and English languages and will also answer visitors' questions.

#### Odisha: 24 Villages Receive 'Tsunami Ready' Recognition

24 coastal villages in Odisha state
 received UNESCO's Intergovernmental
 Oceanographic Commission's Tsunami
 Ready recognition. This recognition was
 initiated to train people to face tsunami
 impacts and improve preparedness.

- The 2nd Global Tsunami Conference was held in Indonesia, where various measures were undertaken including preparing tsunami management plans, community awareness programs, conducting mock drills, and identifying evacuation routes for these 24 tsunami-vulnerable villages.
  - The **State Disaster Management Authority** has identified 381 tsunami-prone villages in the state. Officials stated that work is ongoing to improve tsunami preparedness in all these vulnerable villages.

#### Prime Minister Narendra Modi Receives High Honors from Guyana and Dominica

- These awards were presented in recognition of his contributions during the COVID-19 pandemic period and outstanding service to humanity. With this, the number of foreign high honors awarded to Prime Minister Modi has increased to 18.
- During his Nigeria visit, the Prime Minister was honored with that country's highest award, the Grand Commander of the Order of the Niger.
- He engaged in bilateral talks with leaders of various countries including the United States, Britain, France, Italy, Brazil, and South Africa.

#### ISRO Signs MoU with Australian Space Agency for Gaganyaan Mission Implementation

 ISRO has signed a Memorandum of Understanding with the Australian Space Agency regarding the implementation of India's human spaceflight Gaganyaan mission.
 ISRO, which has designed the Gaganyaan mission to send humans to space, is entering into agreements with various countries' space agencies for implementing this project. • The plan is to send 3 astronauts to low Earth orbit and bring them back to Earth after 3 days. The agreement has been made to track the Gaganyaan spacecraft while it orbits in space and exchange information during emergencies.

#### Army Chief General Upendra Dwivedi Receives Honorary General of Nepal Army Title

- During his four-day visit to Nepal, Army Chief General Upendra Dwivedi was honored with the title of Honorary General of the Nepal Army by Nepal's President Ram Chandra Paudel.
- The exchange of visits between army chiefs of Nepal and India and conferring honorary general titles to both army chiefs has been a tradition since 1950.
- Nepal shares a 1,850 km border with five Indian states: Sikkim, West Bengal, Bihar, Uttar Pradesh, and Uttarakhand.

#### India's Renewable Energy Generation Capacity Increase

- India's renewable energy generation capacity increased by 24.2 gigawatts in October.
- The country's renewable energy generation capacity, which was 178.98 gigawatts in October 2023, has increased by 24.2 gigawatts (13.5 percent) to 203.18 gigawatts in the same month this year.
- In October alone, an additional 1.72 gigawatts of renewable energy generation capacity was installed.
- As of October, large hydroelectric power stations contributed 46.93 gigawatts to the country's renewable energy generation capacity. Nuclear power stations' contribution was 8.18 gigawatts, according to the report.

#### **Climate Change Performance Index**

- India has ranked 10th among more than 60 countries evaluated for their efforts to combat climate change.
- The Climate Change Performance Index (CCPI-2024) rankings were released at the annual UN Climate Conference being held in Baku, Azerbaijan.
- The rankings were released by think tanks 'Germanwatch, New Climate Institute, and Climate Action Network International'
- According to the rankings, the first three places remain empty as no country performed adequately in all index measurements.
- Following that, Denmark (4th), Netherlands, and Britain are in subsequent positions as countries with high performance and low emissions.

#### India in 10th Place:

• India ranks 10th among countries with high performance in climate change actions.

#### **Below Global Average**

- Although India is the world's most populous country, its per capita emissions and energy use are comparatively low.
- India's per capita CO2 emissions are 2.9 tonnes, which is significantly lower than the global average of 6.6 tonnes.
- As the world's third-largest greenhouse gas emitting country and a rapidly growing major economy, India has committed to achieving net-zero emissions by 2070.
- India also aims to achieve 500 gigawatts of renewable energy capacity by 2030.
- China and the United States, the world's largest emitters, rank very low in performance at 55th and 57th places respectively.

 Russia (64th), United Arab Emirates (65th), Saudi Arabia (66th) and Iran (67th) are at the bottom of the rankings.

#### **Bhu-Neer portal**

- The Bhu-Neer portal was launched on September 19, 2024, and aims to enhance groundwater management in India.
- It was introduced during the India Water Week 2024 closing event and Union Jal Shakti Minister C.R. Paatil inaugurated the platform.

#### **Purpose of Bhu-Neer**

- Bhu-Neer is designed to improve the management of groundwater use, which makes the process of obtaining withdrawal permits more transparent.
- It promotes efficiency and sustainability in groundwater usage.

#### **Development and Features**

- The Central Ground Water Authority (CGWA) developed the portal. The National Informatics Centre (NIC) assisted in its creation.
- Bhu-Neer replaces the older NOCAP system.
- It features a single ID system linked to the user's PAN. This simplifies the application process for permits.

### First Artificial Intelligence (AI) data bank

- India revealed its first Artificial Intelligence.
   (AI) data bank, which aims to encourage innovation and enhance national security, by the Ministry of Science and Technology.
- The data bank will serve researchers, startups, and developers by providing essential datasets for AI solutions.
- The AI data bank was launched at the 7th ASSOCHAM AI Leadership Meet 2024

#### The Ustad Bismillah Khan Yuva Puraskar

 The Ustad Bismillah Khan Yuva Puraskar will be awarded to young artists, and take place on November 22, 2024, which will be held at Dr
 Ambedkar International Centre in New Delhi.

#### **Award Details**

- The Ustad Bismillah Khan Yuva Puraskar was established in 2006. It honours the legendary Ustad Bismillah Khan.
- The award is given annually to artists under 40 years old. Eligible fields include music, dance, drama, folk and tribal arts, and puppetry.
- Each awardee receives a cash prize of Rs.25,000.
   They also receive a plaque and an angavastram

#### Khelo India Youth Games

- Bihar will host the Khelo India Youth Games in April 2025, which marks the state's first time as a host for this prestigious event.
- The Khelo India Para Games will follow shortly after, with a gap of 10 to 15 days, and this is the first time the Para Games will be held in Bihar.

- The Prime Minister made this announcement during his "Mann Ki Baat" radio program.
- The 162nd birth anniversary of Swami Vivekananda will be celebrated on January 12 next year.
- This initiative is called the Young Leaders Conference for Developed India.
- National Cadet Corps (NCC) Day was observed on Sunday (November 24).

#### **Central Government Issues Guidelines for Differently-Abled Persons Reservation**

- The Central Government has issued guidelines for forming committees to properly implement 40% reservation for differently-abled persons and identify government jobs for them.
- The guidelines specify that reservation should be followed in jobs identified for differentlyabled persons.
- Under the Rights of Persons with Disabilities Act 2016, the guidelines state that it is necessary to identify government jobs to properly implement 40% reservation for persons with disabilities.
- These identified positions should be reviewed once every three years.
- 4% reservation in direct recruitment and promotions must be mandatorily followed for categories including visually impaired, hearing impaired, and intellectually disabled persons.
- It was also announced that notifications issued in 2021 and 2022 regarding this would be exempted.

#### **The Prime Minister Internship Scheme** (PMIS)

- will launch on December 2, 2024, and aims to enhance job opportunities and skills for India's vouth.
- The pilot phase began on October 3, 2024, and Selected candidates will receive joining orders on the launch day.

#### Putin signs new Russian nuclear doctrine

- President Vladimir Putin on Tuesday signed a revised nuclear doctrine declaring that a conventional attack on Russia by any nation that is supported by a nuclear power will be considered a joint attack on his country.
- Mr. Putin's endorsement of the new nuclear deterrent policy comes on the 1,000th day after he sent troops into Ukraine, on February 24, 2022.

- It follows the U.S. President Joe Biden's decision to let Ukraine strike targets inside Russia with U.S.-supplied longer-range missiles.
- The IAEA collaborates with developing  $\supseteq$  The signing of the doctrine, which says that any massive aerial attack on Russia could trigger a nuclear response, demonstrates Mr. Putin's readiness to tap the country's nuclear arsenal to force the West to back down as Moscow presses a slow-moving offensive in Ukraine.

#### MORE ABOUT CARICOM

- The Caribbean Community (CARICOM) is a grouping of twenty-one countries: fifteen Member States and six Associate Members.
- It is home to approximately sixteen million citizens, 60% of whom are under the age of 30, and from the main ethnic groups of Indigenous Indians, Peoples, Africans, Europeans, Chinese, Portuguese and Javanese.
- Stretching from The Bahamas in the north to Suriname and Guyana in South America, CARICOM comprises states that are considered developing countries, and except for Belize, in Central America and Guyana and Suriname in South America, all Members and Associate Members are island states.
- Prime Minister Narendra Modi proposed seven key pillars to strengthen ties between India and CARICOM during the second India-CARICOM Summit in Guyana.
  - The summit focused on areas such as trade, technology, tourism, economic cooperation, agriculture and food security, health and pharmaceuticals, and science and innovations.
  - Modi highlighted the importance of the SME sector and mentioned a grant of one million dollars for SME sectors announced during the previous India-CARICOM meeting.

### PM Vidyalaxmi differ from other Schemes

- The Union Cabinet approved PM Vidyalaxmi, a new Central Sector Scheme to provide financial support to meritorious students for higher education.
- Students can get collateral-free, guarantor-free loans for tuition fees and other course-related expenses.
- The scheme covers students admitted to 860 higher education institutions defined by the National Institutional Ranking Framework (NIRF) and potentially benefits 22 lakh students.
- For students with an annual family income of up to Rs.8 lakh, a 3% interest subvention for loans up to Rs.10 lakh is provided during the moratorium period, covering one lakh students each year.
- The scheme has an outlay of Rs.3,600 crore from
   2024-25 to 2030-31, aiming to benefit seven
   lakh fresh students with interest subvention.
- Unlike previous schemes, Vidyalaxmi covers middle-income families and simplifies loan applications through the Vidyalaxmi portal, linking to major public and private banks.
- Eligibility under Vidyalaxmi is based on NIRF rankings rather than NAAC and NBA accreditations, limiting it to top 100 ranked institutions in various categories.

 The reduced number of eligible institutions increases the competition for high ranks, affecting students' ability to avail loans based on academic performance.

#### ICC issues arrest warrants against Netanyahu, Gallant, Hamas leaders

The International Criminal Court (ICC) issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu, former Defence Minister Yoav Gallant, and Hamas officials, accusing them of war crimes and crimes against humanity.

#### International Criminal Court (ICC)

- The International Criminal Court (ICC) is a permanent international tribunal located in The Hague, Netherlands, established to prosecute individuals for serious crimes such as genocide, war crimes, and crimes against humanity
- Its foundation is rooted in the Rome Statute, adopted in 1998 and effective from July 1, 2002. Currently, 124 countries are parties to the Rome Statute, although notable absences include the United States, China, and India

#### Armenia has become full member of the International Solar Alliance (ISA)

• Armenia has become the 104th full member of the International Solar Alliance (ISA).

#### **Membership Details**

- Armenia's membership commenced on November 15, 2024.
- This followed the signing of the ISA agreement on November 16, 2023, in Yerevan, which was ratified by Armenia's President.
- The ISA was established by India and France to combat **climate change**.

• The organization promotes solar energy as a sustainable solution.

#### **Member Nations:**

- A total of 106 countries have signed the ISA Framework Agreement.
- Out of 106 nations, 86 have signed and ratified the ISA Framework Agreement.
- All member states of the United Nations are eligible to join the ISA.
- The Headquarters is in India with its Interim Secretariat being set up in Gurugram.
- The ISA was conceived as a joint effort by India and France to mobilize efforts against climate change through deployment of solar energy solutions.

#### **Benefits of Membership**

- The membership supports Armenia's commitment to renewable energy

#### Climate talks at Baku run into overtime

- Climate talks in **Baku**, **Azerbaijan**, extended due to disagreements over the draft agreement.
- Developed countries proposed \$250
   billion by 2035 for climate finance, despite acknowledging a need for at least \$700 billion
   by 2030 for developing countries.
- There was no commitment to disburse funds to developing countries on affordable terms, leading to criticism from several countries and civil society groups.

  - According to the report "Road map for India's citysystems reforms" by Janaagraha, a not-forprofit organisation, 17 States have legislated for 50% women's quota, over the constitutional minimum of 33%.

#### The Green Energy Corridor-II (GEC-II)

- The Green Energy Corridor-II (GEC-II)
   Scheme is a project for Tamil Nadu, which aims to enhance the state's renewable energy transmission capacity.
- The initiative is part of a larger national effort to integrate renewable energy sources into the grid. The Central Electricity Authority (CEA) has outlined this plan in its recent report.

#### **Project Overview**

- The project is valued at Rs.719.76 crore and focuses on integrating 19 gigawatts (GW) of renewable energy. Tamil Nadu will contribute 4,000 megawatts (MW) of this total.
- The infrastructure will include 624 **circuit kilometers (ckm)** of transmission lines and 2,200 substations.

#### **Financial Aspects**

- The total cost of the project is Rs.12,031.33 crore. The **Central Financial Assistance (CFA)** stands at Rs.3,970.34 crore, which is 33% of the overall cost.
- Funding will also come from loans via institutions like KfW, REC, and PFC. The CFA is subject to approval by the Cabinet Committee on Economic Affairs.

### Stalin flags T.N.'s 3 major challenges with XVI Finance Commission

- Tamil Nadu faces three primary challenges: natural disasters, an increasing elderly population, and rapid urbanization.
- Severe impact from cyclones, torrential rains, and flooding has affected lives, property, livelihoods, and infrastructure.
- The average age in Tamil Nadu is currently 36.4, expected to rise to 38.5 by the end of the 16th Finance Commission's tenure, making it the state with the highest elderly population.
- Rapid urbanization requires significant funds for urban infrastructure, especially in cities like Chennai.
- The State needs financial support for relief and restoration measures, social welfare for the elderly, and urban infrastructure development.
- The Goods and Services Tax regime has created obstacles in generating revenue for the State.
- Chief Minister emphasized the importance of the Finance Commission's role in ensuring the overall development of the country through the development of States.

#### The 16th Finance Commission

• The 16th Finance Commission of India,

established **under Article 280 of the Indian Constitution,** is primarily focusing on the devolution of the consolidated fund.

- The Commission aims to support local bodies such as panchayats and municipalities, as mandated by the 73rd and 74th constitutional amendments.
- The agenda includes addressing the fiscal health of municipalities, enhancing property tax collection, improving maintenance of accounts, and allocating resources for pollution mitigation.
- The Commission also recognizes the significant role of cities in India's economic growth and
   the need for increased financial devolution to urban local bodies

 So far, 188 Tamil scholars' books have been nationalized by the Tamil Development OPrecision Technology Center Department. Notably, 140 scholars' books were nationalized during former Chief Minister Karunanidhi's administration.

#### Next World Tamil Economic Conference in **New York**

 V.R.S.Sampath, the founding president, announced that the 12th World Tamil Economic Conference will be held in Washington D.C., USA, as decided in the previous conference in Malaysia.

#### **Cooperative Department's Transformation of Small Savings**

- The Cooperative Department's chain network is fundamental to the success of Tamil Nadu government's welfare schemes. During COVID-19 lockdown, cyclones, rains, and floods, the department delivered essential goods and financial assistance to people.
- Minister launched three special schemes "Siragugal including the Scheme" for transgender persons and small multi-purpose stores in Chennai.

#### "Tamil Magal Scheme"

- 1.16 crore women receive Rs. 1,000 monthly Of these, 8.29 lakh women receive the amount through cooperative banks. Women are earning interest by keeping their rights amount as deposits instead of withdrawing it. Through this "Tamil Magal" scheme, the Cooperative Department has transformed small savings into a movement.
- The first cooperative society was established in Triplicane in 1904.

• The Honorable Minister for Cooperation is Mr.K.R. Periyakaruppan.

- Chief Minister Stalin inaugurated the Precision **Engineering Technology Center.**
- The government announced that a Mega Cluster scheme worth Rs. 100 crores will be implemented in 5 locations across Tamil Nadu to enhance the production capabilities and encourage innovations of micro, small and medium enterprises, and to help them enter emerging industrial sectors.
- According this Precision to plan, а Manufacturing Cluster was planned to be established in Thirumudivakkam Industrial Estate in Kanchipuram district of Chennai region, in collaboration with entrepreneurs' association. This center is considered a hub for creating precision engineering parts used in autonomous vehicles, machinery, and electrical and electronic equipment.

For the first time in South India, a Precision Engineering and Technology Center has been established at the Thirumudivakkam SIDCO Industrial Estate.

#### Tamil Nadu tops the table in growth of SGST collections

Growth in SGST Collections: Tamil Nadu saw a 20.12% growth in State Goods and Services Tax (SGST) collections in the first half of 2024-25, reaching Rs.35,414.05 crore from Rs.29,481.97 crore in the previous year.

Top Performer: This growth rate is the highest among key comparable states, with Gujarat and Uttar Pradesh recording over 14% growth, Maharashtra 13.46%, and Karnataka over 10%.

- SGST Contribution: SGST accounts for roughly half of the States' own tax revenue (SOTR).
- Key Growth States: Tamil Nadu, Assam, Maharashtra, Uttar Pradesh, and Karnataka showed significant year-on-year growth (13.3%-50.8%).

#### State Goods and Services Tax (SGST)

- SGST is a tax applied within the GST framework on transactions within a state.
- It is imposed by the state government where the goods or services are consumed, making it an intrastate tax.
- SGST is regulated by the state's SGST Act of 2017 and is subject to periodic revisions.
- The introduction of SGST consolidated various state-level taxes, simplifying the taxation structure.
- SGST is imposed by state or Union Territory governments, governed by a uniform tax rate based on the type of goods or services

#### Muttamizh Peravai Golden Jubilee Year

- The 50th year golden jubilee celebration of Muttamizh Peravai, which was inaugurated by the late former Chief Minister Karunanidhi, was held at Raja Annamalai Puram in Chennai with a music festival and awards ceremony.
- Actor Sathyaraj received the "Kalaignar Award", D.K.S. Meenakshi Sundaram of Tiruppamuram received the "Rajaratna Award", poet Andal Priyadarshini received the "Iyal Selvam Award", Dr. Gayatri Girish received the "Isai Selvam Award", D.S.Umasankar of Thirukadaiyur received the "Nadaswara Selvam Award", Swami Malai

C. Gurunathan received the "Thavil Selvam Award", Dr. T.Somasundaram received the "Gramiya Kalai Selvam Award", and Parvathi Ravi Kandasala received the "Nattiya Selvam Award".

 The Chief Minister released the golden jubilee year souvenir book titled "Life History of ThiruvavatuthuraiT.N.Rajarathinam" written by author Thumilan.

#### "Vizhuthugal - One Stop Centre"

- Chief Minister M.K. Stalin inaugurated the "Vizhuthugal - One Stop Centre"
- The centre aims to provide health-related rehabilitation services to persons with disabilities.
- He also opened a renovated building at Chennai Middle School, Sholinganallur, under the "Namakku Naame" initiative.
- The Vizhuthugal Centre is part of a World Bank-assisted Rights Project, with 273 centres planned.
- They are integrated into the Chief Minister's Comprehensive Health Insurance Scheme.
- The centres comply with the Union government's 2021 Harmonized Guidelines for building design.

#### PRASAD Scheme

- The Ministry of Tourism has announced plans to develop 29 locations in Tamil Nadu, including 8 Navagraha temples.
- Through PRASAD (Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive),
  29 new locations including eight Navagraha temples in Tamil Nadu have been identified for development.

• The Ministry of Tourism has taken steps to promote spiritual tourism destinations, including those in Tamil Nadu, through 1 various events, websites, and social media platforms.

#### **Chief Minister's Proficiency Test for** Students

- has announced that government school 10th standard students can apply from November 30 for the Tamil Nadu Chief Minister's Proficiency Test, which provides monthly educational assistance of Rs.1000.
- Students studying 10th standard in government schools under Tamil Nadu State curriculum in the current academic year can apply for this test.
- A total of 1,000 people (500 boys and 500 girls) will be selected based on current reservation policies.
- They will receive Rs.1,000 per month, totaling Rs.10,000 per academic year as educational assistance.
- The test will include multiple-choice questions from 9th and 10th standard Mathematics, Science, and Social Science subjects.

#### Not to implement the PM Vishwakarma

- Chief Minister informed the Centre that Tamil Nadu will not implement the PM Vishwakarma scheme in its current form.
- The Centre did not consider Tamil Nadu's concerns about caste-based discrimination within the scheme.
- The government examination department Tamil Nadu plans to develop a more inclusive and comprehensive scheme.
  - The Prime Minister's attention has been drawn to these issues.

#### PM Vishwakarma Scheme

- Launched on 17th September, 2023 by the Prime Minister.
- **Beneficiaries**: Supports Target artisans and craftspeople engaged in 18 trades (e.g., carpenters, blacksmiths, potters, cobblers, etc.).

#### Benefits to Artisans and Craftspeople

- Certificate and ID card for artisans and craftspeople.
- Basic Training (5-7 days) and Advanced Training (15 days or more) with a stipend of Rs. 500 per day.
- Credit Support: Collateral-free loans of up to Rs. 3 lakh.
